E. Consider and take possible action to approve Senate Bill 1494 which provides an option to change our May uniform election date to the November uniform election date and if the option is approved to change to the November uniform election date an Ordinance must be passed on or before December 31, 2026.

No action was taken.

F. Consider and take possible action to approve declaring the City of Bayou Vista's used golf-cart and the 2019 Chevy Tahoe – Police Package as surplus property.

A motion was made by Mayor Pro-Tem McCloskey to declare the Bayou Vista golf card and 2019 Police Chevy Tahoe as surplus property.
