There being a quorum, Supervisor Kozara called the meeting to order at 6:00 p.m.

**Acceptance of Agenda:**

Oatten requested that item #10 under New Business be put on the April 9 agenda. It was board consensus to accept the agenda as amended.

**Public Comments:**

Alex Krzyaniak, District Liaison for State Senator Roger Kahn, introduced himself to the board and provided his contact information if any questions arose in the future.

Raymond Jones, 3675 Jackson, asked what the pink ribbons on several trees in the township were for. Oatten responded that it was not for a township related project and he was not sure who had put the ribbons on the trees.

Julie Barrett, 4666 Sherman, spoke on behalf of Elaine Carey, 1424 Sally Lane. Ms. Carey had been shut-off for non-payment of a utility bill. Ms. Carey had sent the payment to the township office with no address by mistake. Ms. Barrett requested a refund of the \$40.00 turn off/on fee because Ms. Carey was elderly and had never been late making a payment for the past two years. Discussion followed. It was board consensus that, while unfortunate, a refund would not be granted as it would be violating the township ordinance.

**Approval of Minutes:**

It was moved by Fritz and supported by Riley to approve the February 26, 2007 regular meeting minutes with correction: Page 2, paragraph 6, line 5, change \$9,500.00 to \$11,500.00. There being all ayes, the motion carried.

It was moved by Riley and supported by Dalton to approve minutes for: March 12, 2007 - departmental meeting, March 20, 2007 Public Hearing for 2007 Tax Levies and March 20, 2007 - Public Hearing for Township Budgets as presented. There being all ayes, the motion carried.

**Correspondence:**

It was moved by Fritz and supported by Dalton to receive and file the correspondence as listed for March 2007. There being all ayes, the motion carried.

**Accounts Payable:**

It was moved by Dalton and supported by Fritz to approve the March Accounts Payable for the amount of \$138,583.21. There being all ayes, the motion carried.

**Committee/Commission/Board Reports:**

It was moved by Riley and supported by Fritz to allow Oatten to purchase seven Gator Hawk Lite Level 3A body armor vests at \$625.00 each. There being all ayes, the motion carried.

It was moved by Dalton and supported by Riley to allow Oatten to purchase a 2007 Chevrolet Impala and equipment for an amount up to \$25,000.00 from Shaheen Chevrolet. There being all ayes the motion carried.

**Pending Business:**

It was moved by Dalton and supported by Riley to increase the hourly wage for cleaning personnel G. Timm to \$11.00. There being all ayes, the motion carried.

**New Business:**

It was board consensus to authorize Oatten to sign the brining estimates from Saginaw County Road Commission.

Discussion was held on a proposal for a lease of township property for a cell tower site. It was board consensus to have Oatten negotiate and bring further information to the board.

It was moved by Fritz and supported by Riley to approve the quote from Hamilton Electric for repairs to the Carrollton Rd. pump station for \$9500.00. There being all ayes, the motion carried.

It was moved by Dalton and supported Fritz to approve the quote from Bandit Reconditioning to recondition the brush chipper for \$1,216.45. There being all ayes, the motion carried.

**Board/Director Comments:**

Riley thanked King and Oatten for their hard work on the fiscal year budgets.
