There being a full board, Supervisor Kozara called the meeting to order at 6:07 p.m.

**Acceptance of Agenda:**

It was board consensus to accept the agenda as presented.

**New Business:**

It was moved by Kozara and supported by Dalton to receive and file the salary determination for elected officials submitted by the Compensation Commission on February 11, 2009. The Commission kept the elected officials' salaries the same for the next two years.

Kozara noted for the record that the entire township board agreed it was the best choice to keep their salaries the same due to the current economic conditions.

It was moved by Dudek and supported by Riley to award Garber Chevrolet in Midland the bid for two (2) Chevrolet Silverado extended cab, 4-wheel drive pickup trucks in the amount of \$56,850.00 (\$28,425 each) for the Department of Public Works and Fire Department (copy of bid attached). There being all ayes, the motion carried.

Kozara called for a recess at 6:42 p.m. The meeting reconvened at 6:51 p.m.

It was moved by Fritz and supported by Riley to award the bid (copy attached) for audit services to Yeo & Yeo, P.C., CPA for the following amounts:

The term may be extended with Yeo & Yeo for an additional two years (if the board agrees) with the following amounts:

March 31, 2012	\$8,750
March 31, 2013	\$9,000

It was moved by Dalton and supported by Riley to set a special meeting to discuss the proposed Fiscal Year 2009-2010 budgets on Monday, March 16, 2009 at 6:00 p.m. There being all ayes, the motion carried.
