Alderman Welch made a motion to approve the request. Alderman Griffin seconded the motion. Request passed with a 3 to 0 vote.

Request Approval of the Street Department collecting bulk collection only on Mondays each week. The Council approved this request. Alderman Welch made the motion with Alderman Cloer supporting the motion with a second. The vote was 3 to 0 in support of this request.

A request for a street closure on November 25, 2023, closing Second Avenue for "Whoville" in the City Park scheduled to begin at 10:00 a.m. scheduled to end at 6:00 p.m. Chief Etheridge requested the time be amended for the closing of Second Avenue to 8:00 a.m. to 8:00 p.m. Alderman Welch made a motion to amend the time with Alderman Cloer seconding the amended time. The request for the street closure was passed with a unanimous vote of 3 to 0.

A request for a street closure on October 31, 2023, closing Peachtree "Street for Spring Creek Inflatables Halloween Extravaganza" in the City Park scheduled to begin at 5:00 p.m. scheduled to end at 8:00 p.m. Per The City of Chatsworth's insurance, Spring Creek Inflatables will have, as part of the reservation by a commercial entity, a certificate of insurance provided with a General Liability minimum of \$1M per occurrence and \$2M Aggregate. The policy will also add the City of Chatsworth to be named as an additional insured. This coverage document will be brought to City Hall by closing time 5:00 p.m. on October 31, 2023. After discussion, it was decided that Second Avenue and Peachtree Street both would be closed for safety reasons. Alderman Griffin made the motion with Alderman Welch seconding the motion. The Council approved the request with a 3 to 0 vote.

Holly Meyers has requested to address the Mayor and the City Council to DDA matters relating to budget planning. Celeste Bargeron spoke on behalf of the DDA during the Council Meeting. Celeste Bargeron addressed the Council on behalf of the DDA. She spoke of the Façade Grant communicating that three of those grants have been requested. Ms. Bargeron spoke of the purchase of a new building. She voiced her concerns about the DDA not receiving any additional funds. Ms. Bargeron requested funding from the City of Chatsworth. She spoke of many thoughts the DDA has for the City of Chatsworth. Alderman Welch

commented the City would look at the finances and see what the City could offer. Ms. Meyers interjected the DDA Members pay out of pocket for training for new Board Members. Alderman Welch stated that the City would review to see what the City could offer.
