**CITY OF CHATSWORTH
COUNCIL MEETING
JUNE 1, 2020**

The Chatsworth City Council met in regular session on Monday, June 1, 2020 at 6:00 p.m. in the Council Chambers of City Hall with Mayor K. W. Gong presiding.

PRESENT: Mayor K. W. Gong, Aldermen: Rhett Griffin, Teryr Crump, Jeff Cloer and Fred Welch. City Attorney Steve Williams and City Clerk Wilma Nolan.

MINUTES:**AGENDA:**

Mayor Gong presented the minutes of the prior meeting and the agenda for the current meeting for review.

Fred, "I am going to make a motion on the minutes that we approve those and I will make a recommendation that we table the second request by the Housing Authority for their board until we have this checked out."

Jeff seconded and the motion passed by a vote of 4 to 0.

OLD BUSINESS

Presentation of the recommendation of the Chief of Police regarding improved signage in the area of South Fourth and Fifth Avenues.

Mayor Gong called for Chief Etheridge's review of the signage request. The Chief was in agreement with the recommendation for Lakeshore Drive and South Fifth Avenue. (Remove the stop sign on Lakeshore Drive and leave the Stop sign on South Fifth Avenue.) Meir Street at South Fifth Avenue (Chief Etheridge was in agreement to remove the stop sign for northbound traffic on South Fifth Avenue and place a stop sign at west Meir Street and the intersection with South Fifth Avenue.) South Fourth Avenue and Meir Street (Chief Etheridge was not in agreement to remove the stop signs at this intersection due to speed and the number of accidents at this location.)

Fred, "I make a recommendation we go with Josh's recommendations." Terry, "I second." The motion passed by a vote of 4 to 0. (The change will be advertised in the local newspaper to make the public aware of the upcoming change.)

NEW BUSINESS

Recognition of the Chatsworth Police Department as a result of the City of Chatsworth being listed as the ninth safest city in Georgia. Mayor Gong commended the Chief on the good management of the Police Department.

PRESENTATION OF A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE THE LEASE AGREEMENT WITH GMA FOR THE PURCHASE OF A F150 FOR THE STREET DEPARTMENT.

Fred, "I make a motion we adopt the resolution." Rhett seconded and the motion passed by a vote of 4 to 0.

REQUEST BY THE CHATSWORTH HOUSING AUTHORITY TO APPOINT MITCHELL SMITH CHAIRMAN OF THE HOUSING AUTHORITY BOARD.

Terry, "I make a motion we appoint Mitchell Smith chairman." Fred seconded and the motion passed by a vote of 4 to 0.

REQUEST THE AUTHORIZATION OF THE MAYOR TO EXECUTE THE LEASE AGREEMENT WITH GMA FOR THE PURCHASE OF THREE POLICE VEHICLES (2 -Durangos and 1-F150).

Fred, "I so move." Terry seconded and the motion passed by a vote of 4 to 0.

PRESENTATION OF THE FOUR DAY WORK WEEK FOR REVIEW FOLLOWING THE 90 DAY TRIAL PERIOD.

Fred, "I make a motion we make the change." Jeff seconded and the motion passed by a vote of 4 to 0.

SCHEDULE THE JULY COUNCIL MEETING. Mayor Gong stated he did not plan to have a July meeting unless we had to have a called meeting. He asked if anyone had a problem with this matter.

Fred, "I make a motion we skip the July meeting unless there is pertinent business that needs to be addressed." Rhett seconded and the motion passed by a vote of 4 to 0.

Terry, "I make a motion we adjourn." Rhett seconded and the motion passed by a vote of 4 to 0.

The meeting adjourned at 6:20 p.m.
