

**CITY OF CHATSWORTH
COUNCIL MEETING
April 3, 2023**

The Chatsworth City Council met in regular session on Monday, February 6, 2023, at 6:00 P.M. in the Council Chambers of City Hall with Mayor K.W. Gong presiding.

PRESENT: Mayor K.W. Gong Aldermen: Fred Welch, Jeff Cloer, Terry Crump and Rhett Griffin and City Clerk, Linda Penland was in attendance. Attorney Steve Williams was not present.

Mayor Gong called the meeting to order and presented the minutes of the last meeting and the agenda of the current meeting for review.

Alderman Fred Welch "I make a motion we accept the minutes and the agenda." Rhett Griffin seconded the motion to accept the minutes and agenda from the last meeting. The motion passed unanimously.

Request the approval to close Cherokee Street for the 1st Methodist church event to be held on Saturday, April 8th from 11am-1:30pm. Alderman Terry Crump makes a motion to approve the closure. Alderman Jeff Cloer seconds the motion. Request passed unanimously.

Mayor Gong, "I want to make sure everyone is informed, Judge Wilson has been on the staff for eighteen (18) years. His last day is May 24th, 2023." There will be a reception around 11:00 A.M or 11:30 A.M after court. This reception is open to the public. Mayor Gong, "The Council is in the process of reviewing attorneys to be appointed as the new Municipal Court Judge. It will probably be done the next council meeting." Mayor Gong asked if there were any questions on the retirement of Judge Wilson. No one had any questions.

Mayor Gong commented in the past Murray Arts Council has been able to get grants to have "Concerts in the Park." He continued to explain that this year they are having trouble getting money. They have requested that the City allot them \$5,000.00 to help with "Concerts in the Park." The Concerts will be the second Saturday in the Months of June, July, August and September. In the past Lori has been able to get donations but is struggling this year with gathering donations. Mayor Gong asks for a motion to approve the donation. Alderman Fred Welch makes a motion to approve the donation. Rhett Griffin seconded the motion. The request passed unanimously by the City Council.


