Authorized under MCL 446.201, et seq.

As required by State statute (MCL 446.202(4)), a bond in the sum of **\$6,000.00** shall be given to the City of Flat Rock, with at least two sureties and conditioned for the faithful performance of the duties and obligations pertaining to the conduct of the business and for the payment of all costs and damages incurred by any violation of 1917 PA 273, as amended by 2002 PA 469. This bond shall be given to the City before a Pawnbroker's License may be issued.

- The applicant shall permit inspection of the licensed premises, activity, and the record of transactions required by section 5 of the Pawnbrokers Act at reasonable times by any authorized representative of the City of Flat Rock. The city may charge an hourly fee for the inspection of the licensed premises and record of transactions.
- The applicant shall not engage in the business of a pawnbroker at any time after the license has expired, without having been reissued, or at any time when the license is suspended or revoked
- No license shall be issued or renewed unless and until the applicant and any and all employees, officers, partners or agents of applicant shall, if deemed necessary by the chief or police (or designee), submit to being fingerprinted and photographed as part of the background investigation
- Upon application for a Pawnbroker's License and payment of the required license fee (\$250.00 current annual fee as of April 2014) and bond in the penal sum of Six Thousand Dollars (\$6,000.00).
- A copy of the application shall be forwarded to the Flat Rock Police Department for review and approval.
- After zoning and police approval, this completed application shall be forwarded to the Mayor for authorization of a Pawnbroker's License for the specific location listed above.
- The approved license shall be mailed to the applicant, with copies retained by the Zoning and Police Departments.
- An approved Pawnbroker's License is valid for a period of one year from the date of issuance, unless revoked, and is not transferable. Annual renewal of the license shall require re-application using this form. A new license fee is required, although a new bond is not needed unless requested by the City Treasurer.

I hereby certify that I understand the application provided is true and accurate and that, if a license is granted, the applicant will abide by all applicable ordinances and statutes. I further certify that I have not been convicted of a violation of the Pawnbrokers Act (1917 PA 273; MCL 446.201, et seq.) within the past twelve months. By signing this application I hereby authorize the city clerk and/or chief of police (or designee) to carry out a background investigation on the applicant and all employees, officers, partners or agents of the applicant
