MAY 31, 2022
OFFICIAL PROCEEDINGS

Regular session of the May meetings of the Cloud County Board of Commissioners was called to order at 9:00 a.m. on May 31, 2022 in the Commissioners' room at 811 Washington, Concordia, Kansas with Chairman Ron Copple, Members Bill Czapanskiy and Gary Caspers, and County Clerk Shella Thoman present.

County staff attending was: Andy Asch, Highway Administrator; Tonya Sulanka, Interim Health Department Administrator; Barry Porter, Appraiser; Mike Hake, Solid Waste Director;

Andy Asch, Highway Administrator discussed an Agreement for Engineering Services between Cloud County and Kirkham Michael & Associates to assist with the Plum Nellie Wind Farm project. Expenses related to the agreement would be paid for by Plum Nellie. Discussed sign installation and purchasing a grader.

Tonya Sulanka, Interim Health Department Administrator reported that \$119,600 has been received for COVID testing.

Kirby Fox, LockIT Technologies discussed County email and Courthouse WIFI upgrades. LockIT will move forward with both upgrades.
