

COMMISSIONERS' PROCEEDINGS
CLOUD COUNTY, KANSAS
JULY 5, 2022
OFFICIAL PROCEEDINGS

Regular session of the July meetings of the Cloud County Board of Commissioners was called to order at 9:00 a.m. on July 5, 2022 in the Commissioners' room at 811 Washington, Concordia, Kansas with Chairman Ron Copple, Members Bill Czapanskiy and Gary Caspers, and County Clerk Shella Thoman present.

County staff attending was: Andy Asch, Highway Administrator; Tonya Sulanka, Interim Health Department Administrator; Mike Hake, Solid Waste Director.

Others attending: Toby Nosker, KNCK; Nicki Reed, Cloud Corp Director; Dr. Douglas & Brenda Berndt; Republic County Commissioners: Doug Garman and Melvin Jeardoe; Kathleen Marsicek, Republic County Clerk (by conference call).

Andy Asch, Highway Administrator reported that 20th Road between Oat & Plum is closed, the 1 lane bridge at Glasco is also closed. Discussed looking at a 2012 120 M-Cat grader this week. Spraying for Johnson grass.

Nicki Reed, Cloud Corp Director presented the July Slate Selection. The Grant Committee reviewed applications and according to the guidelines recommends awarding the following projects: JKCC Print & Design, \$50,000. JKCC Print & Design is located in Glasco and applied for the grant to remodel the warehouse building. Rock Island RV Park, \$50,000. The Park will be located in Clyde and will be a 10-15 spot RV Park / Tourist Camp. The grant will be used to equip all spaces with electrical, water, sewer and Wi-Fi hook ups. The rock/asphalt lined road will lead to the 15' pad of rocks for camper parking. Einstein Sewing Workshop with Cynthia Monier, \$25,000. The Workshop will be located in Miltonvale and the grant funds will be used for building improvements. Concordia Collision repair, \$25,000. The shop is located in Concordia and grant funds will be used for a concrete floor that would expand the floor space.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved distributing \$70,000 of Wind Farm funds to the Get in the Cloud Small Business Grants.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved the July Slate Selection for the Get in the Cloud Small Business Grants for JKCC Print & Design for \$50,000, Rock Island RV Park for \$50,000, Einstein Sewing Workshop with Cynthia Monier for \$25,000 and Concordia Collision Repair for \$25,000.

Tonya Sulanka, Interim Health Department Administrator reported that COVID numbers are increasing following the Memorial Day holiday and expect more after the 4th of July holiday. The parapet is almost complete and discussed the wind break. Jennifer Gieresh is working on her Masters and helping update all the policy and procedures at the Health Department. Preparing for an immunization, COVID & regular audit.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved Kyah Summers as a fulltime CNA/HHA at an introductory hourly rate of \$12.52 effective June 20, 2022.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved hiring Megan Marvin as the LPN COVID / Float Nurse at an introductory hourly rate of \$19.40 effective July 5, 2022.

Mike Hake, Solid Waste Director reported the door at the Transfer Station was fixed, looking into replacements for a broken window and fixing the leaking roof. Recycling Center sold 32,492 lbs. of cardboard at \$155 a ton. Skid Steer needs repairs and discussed getting a time clock at the Recycling Center & Transfer Station.

Dr. Douglas & Brenda Berndt discussed a complaint in regards to a case involving their daughter.
