

COMMISSIONERS' PROCEEDINGS
CLOUD COUNTY, KANSAS
JULY 18, 2022
OFFICIAL PROCEEDINGS

Regular session of the July meetings of the Cloud County Board of Commissioners was called to order at 9:00 a.m. on July 18, 2021 in the Commissioners' room at 811 Washington, Concordia, Kansas with Chairman Ron Copple, Members Bill Czapanskiy and Gary Caspers, and County Clerk Shella Thoman present.

County staff attending was: Andy Asch, Highway Administrator; Tonya Sulanka, Interim Health Department Administrator; and Toby Marco, County Appraiser.

Others attending: Toby Nosker, KNCK.

Andy Asch, Highway Administrator presented a draft Road Use and Maintenance Agreement for Plum Nellie Wind Farm prepared by Kirkham Michael. Discussed the purchase of a 2012 grader; an additional rim will be purchased and tires will be swapped with the grader we have; with a trade difference totaling \$114,427. Done sealing Union Road east and working on Rock from Concordia City limits to Hwy 9. Spraying Johnson grass.

Tonya Sulanka, Interim Health Department Administrator reported they were working on getting the needed reports from the Nightengale program, Bike rodeo will be Saturday August 20th in Glasco, and audits were this week. Working on scheduling the yearly advisory meeting that has not been held for several years and background checks for compliance. Received an MCH grant extension. Presented classification changes for Katie Kearn and Chelsey Simon.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved the classification change for Katie Kearn from CNA to Receptionist at an hour rate of \$14.42 effective July 17th.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved the classification and wage change for Chelsey Simon from Receptionist at \$14.30 to Office / WIC Clerk at \$15.88 hourly effective July 17th.

On a motion by Commissioner Copple, second by Commissioner Czapanskiy, unanimous vote the Board approved a 10-minute executive session for personnel exception to discuss non-elected personnel resuming open session at 10:14 a.m. including Tonya Sulanka and Shella Thoman.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved the appointment of Tonya Sulanka as County Health Department Administrator at a yearly salary of \$55,000 effective July 17, 2022

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved the Interlocal agreement and contract for County Appraiser with Toby Marco effective July 18, 2022.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved the Real Property Relief Application for the 2022 tax years for Paul D. Grobler for 717 Olive Street, Concordia due to a fire.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved the increase for mileage reimbursement rate to 58.5 cents a mile effective July 1, 2022.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved publishing the 2023 budget with an estimated mill levy of 63.899 and setting the Revenue Neutral Rate (RNR) and budget hearing for September 12th at 9:00 a.m.

The Board reviewed the Budget Status report and Fund Status Report as of June 30, 2022 with an ending cash balance of \$14,488,146.25.
