SEPTEMBER 19, 2022  
OFFICIAL PROCEEDINGS

Regular session of the September meetings of the Cloud County Board of Commissioners was called to order at 9:00 a.m. on September 19, 2022 in the Commissioners' room at 811 Washington, Concordia, Kansas with Chairman Ron Copple, Members Bill Czapanskiy and Gary Caspers, and County Clerk Shella Thoman present.

County staff attending was: Andy Asch, Highway Administrator; and Tonya Sulanka, Health Department Administrator.

Others attending: Toby Nosker, KNCK; Charles Johnson, Public Building Commission; Wyatt Hoch, Foulston Siefken; Kirby Fox, LockIT; and Sheryl Budke, NexTech (by conference call).

Andy Asch, Highway Administrator reported they were behind with mowing due to repairs, continuing ditch and dirt work and finished up striping. Mediation on the Ames/Miltonvale road is postponed.

Tonya Sulanka, Health Department Administrator reported that staff will be attending the Home Health Care / Hospice conference, the Safe Sex is Sexy outreach program at the College, and the Safe Sleep Certification course in Wichita, presented Flu Clinic dates, attending the NCK Public Health Initiative meeting, received \$4,200 in COVID testing and the new COVID booster is available for Walk-ins on Wednesday. The Pharmacy quarterly review went well. The Law Enforcement Center has not put together a contract with the Health Department for services. On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved a 15-minute executive session for attorney-client privilege to discuss the Law Enforcement Center including Wyatt Hoch, Foulston Siefken and Charles Johnson, Public Building Commission resuming at 9:47 a.m.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved allowing Wyatt Hoch, Foulston Siefken to begin the groundwork in evaluating a possible law suit.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved hiring Noah J. Thoman as part-time Recycling Sorter at an hourly rate of \$13.00 effective September 15, 2022.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved hiring Megan Affolter as Immunization Director at an introductory wage of \$28.00 effective October 3, 2022.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved moving IT services from NexTech to LockIt.
