CITY COUNCIL SPECIAL MEETING MINUTES

JUNE 23RD, 2022

Members of the City Council of the City of Crawford, Nebraska, met in special session in the Crawford City Hall Council Chambers, 135 Elm Street, Crawford, Nebraska on the 23rd day of June, 2022, at 5:45 o'clock p.m. The following individuals were present: Mayor Connie Shell, Council Member Ed Kuhnel, Council Member Ronnie Thompson, Council Member Susan Leeling and Council Member Zac Riggs. Absent: Attorney Adam Edmund.

Notice of the meeting was given in advance thereof by posting in three public places as shown by the Certificate of Posting available at the City Clerk's office at City Hall. Availability of the agenda was communicated in the advance notice and in the notice of the Mayor and City Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.


