CITY COUNCIL SPECIAL MEETING MINUTES

JULY 8TH, 2022

Members of the City Council of the City of Crawford, Nebraska, met in special session in the Crawford City Hall Council Chambers, 135 Elm Street, Crawford, Nebraska on the 8th day of July, 2022, at 12:00 o'clock p.m. The following individuals were present: Mayor Connie Shell, Council Member Ed Kuhnel, Council Member Ronnie Thompson and Council Member Zac Riggs. Absent: Attorney Adam Edmund and Council Member Susan Leeling.

Notice of the meeting was given in advance thereof by posting in three public places as shown by the Certificate of Posting available at the City Clerk's office at City Hall. Availability of the agenda was communicated in the advance notice and in the notice of the Mayor and City Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Mayor Shell called the meeting to order and declared a quorum present at 12:08 p.m. and announced to the public that a copy of the Open Meetings Act is posted on the wall in the Council Chambers. It is also available in pamphlet form.


