ORDINANCE NO. 04-2022

AN ORDINANCE AMENDING THE CROSBYTON CODE OF ORDINANCES CHAPTER 6, ARTICLE 6.02; PROPERTY MAINTENANCE; AMENDING SECTION 6.02.065 TO ADD DETAILS REGARDING THE FEES AND EXPENSES FOR CUTTING TALL WEEDS AND GRASS; PROVIDING A SAVINGS CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City Council of the City of Crosbyton, Texas has previously passed an Ordinance regulating property maintenance, specifically tall weeds and grass, as detailed in Chapter 6, Article 6.02 of the Crosbyton Code of Ordinances; and

WHEREAS, it is necessary to amend certain provisions of Chapter 6, Art. 6.02, Section 6.02.065 of the Crosbyton Code of Ordinances related to the fees and expenses for cutting tall weeds and grass on private premises; and

WHEREAS, the City Council believes it is in the best interest of the citizens of Crosbyton to continue to regulate nuisances on private premises, including weeds and other unsanitary matter;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CROSBYTON, TEXAS:

SECTION I

- A. Section 6.02.065 shall be deleted and amended to read as follows:
- (a) If the owner or his agent of any lot or premises to whom notice has been given in accordance with the provisions of this division fails to comply with the notice within ten days after notice is given, the city may do such work or make such improvements as are necessary to correct, remedy or remove the condition which is the subject of the notice, or cause the work to be done, and pay for the work and charge the fees and expenses incurred

to the owner of such lot. Such fees and expenses shall be assessed against the lot or real estate upon which the work was done, or the improvements made. The fees and expenses for cutting shall be billed to the owner of the premises at a rate determined by the Public Works Director but in no event less than one-hundred dollars (\$100.00) for a cutting. The doing of such work by the city shall not relieve such person from prosecution for failure to comply with such notice in violation of section 6.02.064.

SECTION II

<u>Repealer</u>. All ordinances, or parts thereof, that are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters regulated herein.

SECTION III

Severability. The provisions of this ordinance are declared to be severable. If any section, sentence, clause or phrase of the ordinance shall for any reason be held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the remaining sections, sentences, clauses, and phrases of this ordinance, but they shall remain in full force and effect; it being the legislative intent that this ordinance shall remain in effect notwithstanding the validity of any part.

SECTION IV

<u>Effective Date</u>. This Ordinance shall take effect immediately upon its adoption by the City Council and publication as may be required by governing law.

SECTION V

<u>Open Meetings</u>. It is hereby officially found and determined that the meeting at which this Ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the *Open Meetings Act, Chapter 551, Gov't. Code*.

The City of Crosbyton, Texas

Whereas, the City of Crosbyton, Texas, (hereinafter referred to as "City of Crosbyton") has been awarded TxCDBG funding through a TxCDBG grant from the Texas Department of Agriculture (hereinafter referred to as "TDA");

Whereas, the City of Crosbyton, in accordance with Section 109 of the Title I of the Housing and Community Development Act. (24 CFR 6); the Age Discrimination Act of 1975 (42 U.S.C. 6101-6107); and Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. 794) and for construction contracts greater than \$10,000, must take actions to ensure that no person or group is denied benefits such as employment, training, housing, and contracts generated by the CDBG activity, on the basis of race, color, religion, sex, national origin, age, or disability;

Whereas, the City of Crosbyton, in consideration for the receipt and acceptance of federal funding, agrees to comply with all federal rules and regulations including those rules and regulations governing citizen participation and civil rights protections;

Whereas, the City of Crosbyton, in accordance with Section 3 of the Housing and Urban Development Act of 1968, as amended, and 24 CFR Part 75, is required, to the greatest extent feasible, to provide training and employment opportunities to lower income residents and contract opportunities to businesses in the Section 3 Service Area;

Whereas, the City of Crosbyton, in accordance with Section 104(1) of the Housing and Community Development Act, as amended, and State's certification requirements at 24 CFR 91.325(b)(6), must adopt an excessive force policy that prohibits the use of excessive force against non-violent civil rights demonstrations;

Whereas, the City of Crosbyton, in accordance with Executive Order 13166, must take reasonable steps to ensure meaningful access to services in federally assisted programs and activities by persons with limited English proficiency (LEP) and must have an LEP plan in place specific to the locality and beneficiaries for each TxCDBG project;

Whereas, the City of Crosbyton, in accordance with Section 504 of the Rehabilitation Act of 1973, does not discriminate on the basis of disability and agrees to ensure that qualified individuals with disabilities have access to programs and activities that receive federal funds; and

Whereas, the City of Crosbyton, in accordance with Section 808(e)(5) of the Fair Housing Act (42 USC 3608(e)(5)) that requires HUD programs and activities be administered in a manner affirmatively to further the policies of the Fair Housing Act, agrees to conduct at least one activity during the contract period of the TxCDBG contract, to affirmatively further fair housing;

Whereas, the City of Crosbyton, agrees to maintain written standards of conduct covering conflicts of interest and governing the actions of its employees engaged in the selection, award and administration of contracts.
