CRA APPLICATION FOR AN EXEMPTION FROM REAL PROPERTY TAXATION RESIDENTIAL DWELLING

Information and Instructions

Properties within the City of East Cleveland's Community Reinvestment Area (CRA) are eligible for real property tax exemption when new construction of residential, for-sale, single family homes occurs, as follows:

• If making improvements to an existing residential structure that is 1 or 2 units and the cost of remodeling each residential unit is at least \$2,500.00.

- OR -

• If making improvements to an existing residential structure that is 3 units and the cost of remodeling each residential unit is at least 5,000.00.

- OR -

• If building a new residential unit.

The City offers real property tax exemption of 100% of the increase in the assessed valuation of the property.

If the improvements are made to 1-2 unit existing structures, the property owner receives 10 years of exemptions.

If the improvements are made to 3-unit existing structures, the property owner receives 12 years of exemptions.

And if constructing a new residential structure, the property owner receives 15 years of exemptions.

To receive these exemptions, the property owner must apply to the City's Housing Officer, who then certifies the improvements or construction was completed.

Submit applications with the Housing Officer no later than six months after completion of the building improvements or new construction. The Housing Officer reviews the application to confirm it meets the requirements of state law and the City's rules and regulations for implementation.

This program is authorized by East Cleveland Ordinance 91-02 (passed June 18, 2002).
