1. **Call to order/Pledge of Allegiance**: Called to order @ 6:00 p.m. by Supervisor Larry Grimsby followed by Pledge of Allegiance to the flag.

- c. **Historical Society**: Jim and Larry met with Pelassaros. Motion by Grimsby to consider selling just short of 6 acres. From parking lot of transfer station to the curve of 'old pavement' of property to Historical Society. Conversation with Dean=ok to sell surplus property at true value (currently between \$800-1000/acre). Motion to be willing to sell an approximately 5.87 acre parcel (as described above) for approximately \$5000, to the Historical Society by Hellen, supported by Perkis. Nuce-yes, Anderson-yes, Hellen-yes, Perkis-yes, Grimsby-yes. Motion carried.
- d. **Deer Crossing Signs**-Request for that 'deer crossing' signs replace the 'slow children signs' on VanBuskirk near deer yards. Cost is approximately \$80 for 2 signs. Motion to provide 2 'deer crossing' signs to replace the 'slow children' signs by Perkis, supported by Hellen. Motion carried.
