6.1 Lot Reconfiguration Request 3580 Boyne City Road, Case #PC2023-06

He stated that it just came to the applicants attention that he would like to make additional changes to the submitted sketch, so he will resubmit at a later date. 7.1 Lot Reconfiguration Request 728 N. Addis Road, Case #PC2023-05

Chair Cortright recognized that David Beek and JP Gerster are here tonight representing this request. He noted this topic was tabled at the previous meeting because of irregularities and past splits. Chair Cortright demonstrated the historical splits as researched by the planning commission and township attorney noting misinterpretations of the ordinance by applicants and staff resulted in 8 (eight) splits over time. He stated there should have been a maximum of 4 (four) splits with one remaining large parcel. Chair Cortright stated that Township Attorney, Bryan Graham confirmed there are no additional splits available.

Discussion took place with David Beek and JP Gerster as to the intent of the impending sale.

Motion by R. Swiss to approve bringing Parcel C back into conformance with the Township Ordinance by reconfiguring the lot to a 3.015 acre rectangle with an easement as identified in legal description and sketch dated July 12, 2001, seconded by S. Smith: vote all ayes, motion carried.

David Beek and JP Gerster exited the meeting.
