CITY OF FARMERSVILLE ORDINANCE # 2012-0515-001

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FARMERSVILLE, TEXAS CANVASSING RETURNS AND DECLARING THE RESULTS OF A GENERAL ELECTION HELD MAY 12, 2012 FOR THE PURPOSE OF ELECTING MAYOR, AND TWO COUNCILMEMBERS, PLACES 2 AND 4, OF THE CITY OF FARMERSVILLE, TEXAS; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

- WHEREAS, the City Council of the City of Farmersville, Texas, ("City Council"), issued an order on February 14, 2012, directing that a general municipal election be held on May 12, 2012, for the purpose of electing three officials of the City to serve as the Mayor, and Place 2 and Place 4 City Council Members; and
- WHEREAS, notice of election was properly given by the City as required by law; and
- WHEREAS, the City Council has considered the returns of said election held May 14, 2012; and
- WHEREAS, said election was duly and legally held on May 12, 2012 in the City and in conformity with the election laws of the State of Texas, and the results of said election have been certified and returned by the proper judge and clerks thereof; and
- WHEREAS, the election returns, duly and legally made, showed that there were cast at said election a total of ____ valid and legal votes, of which ____ votes were cast early and ____ votes were cast on election day, and that each of the candidates in said election received the following votes:

WHEREAS, section 67.003 of the Texas Election Code, as amended, generally provides that each local canvassing authority shall convene not later than the eleventh (11th) day after the election date for the purpose of canvassing the election results; and

WHEREAS, section 67.004(a) of the Texas Election Code, as amended, establishes the quorum level required to canvass election results; **NOW**, **THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FARMERSVILLE, TEXAS, THAT:

Section 1: FINDINGS INCORPORATED

The findings set forth above are found to be true and correct and are hereby incorporated into the body of this Ordinance for all purposes as if fully set forth herein.

Section 2: EXPRESSION OF ELECTORS

It is further found and determined that the results of the election as canvassed and tabulated in the preamble reflect the expressed desires of the resident qualified electors of the City.

Section 3: ELECTED MAYOR AND COUNCILMEMBER PLACES 2 AND 4

Pursuant to the applicable provisions of the Texas Local Government Code and the Texas Election Code, the City Council officially finds and determines and declares the results of said election to be that the duly elected Mayor and Councilmembers of the City Council of the City of Farmersville, Texas, elected May 12, 2012, for Mayor and Councilmember Places 2 and 4, subject to the taking of the oaths of office as provided by the laws of the State of Texas are as follows:

Section 4: EXECUTION AND DELIVERY OF ORDINANCE

The Mayor is hereby authorized and directed to execute and deliver this Ordinance canvassing the General Election in accordance with the Texas Election Code and all other necessary action in connection therewith.

Section 5: SEVERABILITY CLAUSE

It is hereby declared to be the intention of the City Council that the words, phrases, clauses, sentences, paragraphs and sections of this Ordinance are severable, and if any word, phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the City Council without the incorporation of this Ordinance of any such unconstitutional word, phrase, clause, sentence, paragraph or section.

Section 6: REPEALER CLAUSE

Any provision of any prior ordinance of the City, whether codified or uncodified, which is in conflict with any provision of this Ordinance, is hereby repealed to the extent of the conflict, but all other provisions of the ordinances of the City, whether codified or uncodified, which are not in conflict with the provisions of this Ordinance shall remain in full force and effect.

Section 7: EFFECTIVE DATE

This Ordinance shall take effect immediately from and after its passage.

<u>SECTION 1:</u> All of the recitals contained in the preamble of this resolution are found to be true and adopted as findings of fact by this governing body and as part of its judgment.

<u>SECTION 2:</u> It is further found and determined that the results of the election are as canvassed and tabulated in the preamble hereof and in Exhibit A attached hereto, and, a majority of the resident qualified electors voting at said election having voted in favor of the propositions numbered 1 and 2, the City Council is hereby declared to be authorized and empowered to issued the bonds on behalf of the City in the amount and for the purposes stated in said propositions numbered 1 and 2; all as more fully set forth and identified above and in the proceedings calling said bond election.

<u>SECTION 3:</u> The City Secretary is hereby authorized and directed to make the appropriate entries of information appearing in the tabulation of precinct results shown in Exhibit A attached hereto in the election register maintained by the City in accordance with provisions of Section 67.006 of the Election Code.
