This Old Tree – To Keep or Not to Keep

Your dedicated reporter assumed when leaving the house on a cold, icy evening to attend the Town Council meeting that the inclement weather meant he would probably be the only citizen in the audience. The steps from his house and the front walkway were dangerously slippery. So imagine how shocked he was upon arriving at the Town Hall that an unusually large audience of 17 people was present. Most of them, it turned out, were present for the same issue: probable removal of a single tree.

As readers may know, the long-planned sidewalk project is on the verge of starting. The Town has the so-called 100-percent design from the engineers and is ready to submit it to the Maryland State

government, with work likely to begin in a couple months. One part of this major project is replacement of the elderly, decrepit asphalt sidewalk along Clermont Avenue with a new ADA (Americans with Disabilities Act)-compliant concrete sidewalk. This will be wider than the existing sidewalk. All well and good, right? Ah! It turns out that in order to build this sidewalk, the engineers (both the original engineering firm picked by the State, and the replacement firm picked by the Town), several arborists (including the Town’s Phil Normandy), and the Arboretum Committee decided that a particularly large tulip poplar would need to be removed.

This tree stands on Town property between 10914 and 10916 Clermont Avenue. The decision to remove the tree had been incorporated into the so-called 30 percent engineering plan of a couple years ago, so this decision was not new news. However, a group of residents living close to the tree came to the Town Council meeting to argue, some of them passionately, for keeping the tree by rerouting and modifying the planned sidewalk. Their presentations (mostly by Clermont Avenue residents John Tschirky, Jill Stevens, Suzi Gifford, and Terrance Sauvein) and the ensuing discussion with the Town Council and other residents in the audience went on for 90 minutes.

Your reporter took copious notes, but in retrospect, the many varied details would take far too much space in the Bugle. So here are just a couple of the highlights. The tree may be nearing the end of its natural life (although this is not certain) and building the new sidewalk will increase the stress on the tree which might shorten its remaining life. Should the tree be kept contrary to the advice of the arborists, the Town might become liable if the tree were to fall and cause damage not covered in its insurance policy (not to mention the possibility of bodily harm or death). In addition, the engineers do not think alternative designs for the sidewalk are feasible—the presence of roots would require moving and raising the sidewalk which would also create design problems for the driveways involved. On the other hand, the tree is much loved by the residents—large, shapely, etc—and is a fitting part of Garrett Park as an arboretum.

Neither the arborists’ conclusions about the tree’s current and future health, nor the opinions of the current engineers have been made in writing. Those in the audience strongly in favor of keeping the tree were unwilling to accept the description of these conclusions related by members of the Town Council. At several points, passions were running so high that implicit (or not so implicit) accusations of disbelief or lack of trust were made by some in attendance. So how did all this tension get resolved?

The Mayor and Council agreed that they would request written memos from both the engineers (on the engineering problems involved in trying to work around the tree) and the arborists (on the health issues of the tree) prior to sending in the 100-percent engineering plan to the State government; and to share these memos with the Claremont residents. The Council will then need to hold an off-cycle Council meeting to consider these written opinions. All of this is intended to happen within the next several weeks.

Whew. But wait! Right after this discussion was finished, word came in of a water main break on

Kenilworth, a couple houses past the Town Hall. This had the effect of accelerating discussion of the remaining items on the agenda. A variance request from the Kellers concerning a proposed deck was approved unanimously on the grounds that the curvature of Cambria Avenue creates unusual or exceptional characteristics for the property, in the language of the variance ordinance. Next, Karen Thiel was unanimously approved for membership on the Archives Committee. And, finally, the mid-year budget adjustment, which had been introduced and discussed at the previous Council meeting, was unanimously approved.

The Town Manager’s monthly report was presented in his absence, and contained no surprises, but did make special mention of the hard work of Butch and Frank to ensure during the two-week spell of very cold weather and some snow that streets were passable and the sidewalks around Penn Place were clear. Thank you Butch and Frank!

Finally, the meeting was adjourned close to 10 p.m. and the Mayor and others went out to check on the water main break. Your reporter gingerly headed down the icy sidewalk for a much delayed dinner at home.

Still have a Christmas Tree? Remove the branches and use them as winter mulch over bulbs and perennials. Layer the boughs over the plants and soil to keep soil temps consistent and reduce the risk of early sprouting and winter damage that can occur during winter thaws.

Obituary

Marvin H. Trattner (1928-2017)

Marvin H. Trattner, of [11118 Kenilworth Avenue](#), died on November 11th. He was 89 years old. He had suffered from myositis, a rare and debilitating disease.

Marvin is survived by his wife of 42 years, Ruth Patt Newman Trattner; and his stepchildren, Lyn Newman Silverman of Pittsburgh and George H. Newman of Philadelphia.

Marvin received a Master's degree from Fordham University and his Doctorate in Psychology from Catholic University. He formulated tests and did research at the U.S Office of Personnel Management.

Originally born in the Bronx, a borough of New York City, Marvin spent his last 26 years here in Garrett Park, in the same home that he and Ruth custom built in 1991. Some of his favorite pastimes included bridge and bicycling. He and Ruth also loved to travel and took many trips together, both stateside and abroad.

His neighbors remember him as very helpful, giving rides to those going to exercise classes and to doctors' appointments. He is very much missed.

A memorial service is planned for April 27. Further details will be posted in the Post Office, later in April.

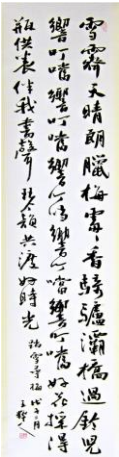

Mark your calendars! Here is the list of movies that will be shown in 2018 by the Garrett Park Film Society. The movies are shown in the Town Hall. You can subscribe to a membership, or just attend individual showings, as you like.

January 19: Cleo from 5 to 7 (1962; France; PG-13) Drama: New Wave director Agnes Varda tells a story of a self-obsessed, young pop singer wandering across Paris while awaiting the results of a medical test that may show she has cancer.

February 16: I Know Where I'm Going (1945; UK; G) Romance: Joan Webster (Wendy Hiller), a headstrong and ambitious young woman travels to Scottish Hebrides to marry a rich industrialist who lives on the Isle of Kiloran (fictitious). Stranded by stormy weather on the Isle of Mull, Joan meets a handsome and penniless naval officer (Roger Livesey) who threatens her carefully laid plans.

March 16: Denial (2016; UK/USA; PG-13) Drama: Based on an actual case, acclaimed writer and historian Deborah E. Lipstadt must battle for historical truth to prove the Holocaust actually occurred when David Irving, a renowned denier, sues her for libel. Stars Rachel Weisz, Timothy Spall and Tom Wilkinson.

April 13: Jodorosky's Dune (2013; USA/France; PG-13) Documentary: An exploration of cult film director Alejandro Jodorowsky's ambitious but ultimately doomed adaptation of Frank Herbert's seminal science fiction novel, *Dune*. Undertaken in the mid-1970s, the proposed cast included Orson Welles, Mick Jagger, David Carradine and Salvador Dali, featuring music by Pink Floyd and set design by some of the most provocative talents of the era, HR Giger and Jean 'Moebius' Giraud.

June 15: The Tale of Princess Kaguya (2013; Japan; PG) Anime. A bittersweet Japanese fairy tale of love, loss and mortality.

September 21: King of the Hill (1993; USA; PG-13) Drama: In his first Hollywood studio film, writer/director Steven Soderbergh crafted a "small jewel of a growing-up story" based on a memoir by A.E. Hotchner. The film recounts the "struggles of a resourceful and imaginative adolescent," forced to survive on his own during the Depression.

October 19: No (2013; Chile: R) Drama: The story of how an ad campaign took down dictator, Augusto Pinochet. Under international pressure, in 1988, Pinochet called a plebiscite on his presidency—a YES or NO to another eight years of his rule. Gael

This Old House

If the 1891 Queen Anne house with the three-story shingled tower at 11210 Kenilworth Avenue is on your walk, you might want to give a thought to Lucia and Herman Hollerith. In 1896 after renting the home of General Abbott at 4716 Waverly Avenue, they bought this house. Herman Hollerith developed a system of the punch, card reader and sorter inspired by his observations of conductors on trains. He noted conductors would hand-punch details around the edge of the ticket to identify the ticket holder.

Hollerith's electric tabulating system became IBM.

The house is designated as a Montgomery County landmark.

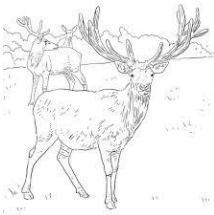

What We’re Cooking...

In honor of her, my husband's family put together a family cookbook with all of their favorite family recipes. Shuggie's Stew is one of our favorite recipes from this book. This hearty soup is perfect for the icy weather we are having. It is also super-easy and makes a lot.”]

Shuggie's Stew

Ingredients & Materials

- 2-3 lbs ground chuck - lightly browned and drained
- 4 cans diced tomatoes
- 2 potatoes (diced)
- 3 onions (diced)
- 3 carrots (diced)
- 1 package frozen corn kernels (16 oz)
- 1 package frozen black-eyed peas (16 oz)
- 1 package frozen green peas (16 oz)
- 1 package frozen edamame (16 pz)
- 1 T salt
- 1 T black pepper
- Tobasco/Worcestershire sauce
- 1 box chicken broth (4 cups)

Directions

Bring just short of boiling. Simmer until done-approximately 5 hours.

Letter from the Mayor

Gene and I are struggling as we try to put together a proposed FY 2019 Town budget to present to the Town Council and our citizens. We had thought that it would be pretty simple – more of the same – until the new tax act was passed by Congress and signed by the President. Our FY 2019 budget goes into effect in July of this year, and continues until June, 2019. The revenues we receive reflect the payments that Town residents make to the state and county governments during that period, all of which are governed by the changes reflected in that legislation. How do we predict the Town's income during that period when we have no idea how that act, and coming changes in state taxation, will affect our residents?

One factor is the federal state and local tax deduction that will now be capped. Many of our residents will no longer be able to take full advantage of that deduction. Since the Garrett Park property tax is one contributor to that total, should we consider a reduction in our Town property tax rate? If so, will we receive enough revenues from other sources to continue to provide the services we have become accustomed to if we reduce that source?

Since the state bases its income tax collections on the federal tax forms, if the federal tax receipts go down, as is projected, will the state increase its tax rate to maintain its income? If not, another source of revenue for the Town will decrease. If, on the other hand, many of us will experience an increase in federal taxes, as I suspect may be the case, a state tax rate increase would make the situation even worse for all of us, and perhaps the Town should look for an even larger decrease in other revenues to help out residents, since we cannot change our share of state income taxes.

Much of the annual change in Town revenues is affected by capital gains tax returns. When Town residents are selling assets, particularly stocks and mutual funds, the Town receives more money from the state income tax. In the past we have become reasonably adept at predicting how that might affect Town revenues by looking at the broad economy and stock market trends. That won't work at least for a couple of years. When people adjust their investments, as may occur right now and in the coming months as the elements of the tax act become more clear, that could affect Town revenues. Those actions are totally unpredictable at this time.

Since we are required by our Charter to propose a balanced budget, our expenditures budget must reflect our expected revenues, and therefore we are in a conundrum in determining how to proceed. I

should point out that we have sufficient reserves and flexibility so that we can survive a year or two if we guess wrong, but we would then have to build up those reserves, which affects our expenditures in future years.

If any of you have some insights that may help us in our discussions, please share them with us. One of the best ways of doing that is on the Town Forum, which is contained within the Residents Portal of the Town website, <http://www.garrettparkmd.gov/residents-portal/town-forum>, to which access is limited to Garrett Park residents only. If you are not currently registered to access the residents only portion of the site, you can register by clicking the drop down on the top right of the home page.
