Moved by Commissioner Reinhardt and seconded by Commissioner Stoller to approve agenda. All present voting aye; motion carried.

Moved by Stoller and seconded by Reinhardt to approve minutes. All present voting aye; motion carried.

New business:

Jackie Steinmetz, Director of Tax Equalization, met with the Board to present a contract for reassessment with Vanguard Appraisal Services. She will send a letter of intent to all taxing jurisdictions.

Patrick Diehl, Disaster Emergency Manager, presented Fire Emergency and Burn Ban for reinstatement for the year beginning April 15, 2020. The declaration effectively bans the starting of fires when the ND rangeland Fire Danger rating is High, Very High, or Extreme category.

Stoller moved to accept the resolution to close polling location in Grant County for the June 9, 2020 primary. Seconded by Reinhardt. Roll call vote – Stoller- aye, Reinhardt – aye, Zenker – aye. Motion carried.

Sheriff Foss updated the Board gave police report and an increase in patrol in rural areas.

John Sauber, Sauber Engineering joined the meeting via phone. The gravel project north of Carson has a time extension until April 18th to complete the relaying of the top layer.
