Motion made by Hochhalter to approve 10 year contract with Otis Elevator Company for elevator maintenance. Roll call vote-Reinhardt – aye, Hochhalter– aye, Zenker – aye. Motion carried.

Motion made by Hochhalter to approve contract with North Dakota Supreme Court to provide clerk services. Roll call vote- Hochhalter – aye, Reinhardt– aye, Zenker – aye. Motion carried.

Motion made by Hochhalter to approve for Rural Fire Departments as part of the ARPA to pay for expenses inquired from March 3 to December 31, 2021. Maximum amount of awards were prorated among districts by service area and expenses reported on applications received on or before April 1, 2022. Motion seconded by Reinhardt. Roll call vote – Hochhalter – aye, Reinhardt – aye, Zenker – aye.

Being no further business, Zenker adjourned meeting at 12:50 p.m.
