The citations go to the State. Auditor Meier said the overtime is reimbursed by the state, but the income tax, mileage and vehicle use is the counties expense. Sheriff Harding stated they can apply for \$600.00 to cover mileage. An adjustment to the hours will be made to account for the income tax. The contracts for the campaigns must be approved by the Board of Commissioners prior to being submitted in the future.
