Commissioner Zenker called the June 16, 2021 meeting of the Grant County Commissioners to order 9:01 a.m. Present were Commissioner Reinhardt, Commissioner Hochhalter, Sara Meier, Auditor, and Grant Walker, County States Attorney. Public present was Gregory Bruce.

Moved by Commissioner Reinhardt and seconded by Commissioner Hochhalter to approve agenda. All present voting aye; agenda approved.

Old business: Jackie Steinmetz, Secretary of the County Zoning Board presented a letter that will be sent to the property owners of Red Rock Resort to inform them of a public hearing to be held on the issue of year-round residency for the subdivision property. Bill Schneider requested that the Red Rock Subdivision be allowed to have year-round residents. It is currently restricted to summer access only. The request is in response to the possible access of Southwest Water Authority pipeline. Public hearing will be held July 7 at 10:00 a.m.

Jon Alt, County Road Superintendent met with the Board to discuss road conditions specific to the storm damage to occur in the Shields area. He and other road crew members are assessing damages, and making repairs to improve traffic flow as soon as possible.

John Sauber and Edmund Baffoe-Twum of Sauber Engineering met with the Board. Sauber Engineering has been completing cost estimates for the repairs in the Shields area. Chairman Zenker requested quotes from Weisz & Sons and Miller Construction for some of the large projects. An Archeological Site Study must be completed for barrow dirt, rip rap and retrieved materials for the projects to meet standards for possible FEMA funding and DOT inspection. A motion to have Sauber contact a firm to complete the studies was made by Reinhardt, and seconded by Hochhalter. Roll call vote- Hochhalter– aye, Reinhardt – aye, Zenker – aye. Motion carried.

Patrick Diehl, Emergency Services presented an amended Fire Emergency and Burn Ban for Grant County. The amendment “The burning of garbage pits and large controlled burns will not be allowed regardless of the North Dakota Rangeland Fire Index Rating Map. The ignition of fireworks will not be allowed regardless of the North Dakota Rangeland Fire Index Rating Map.” Reinhardt moved to approve the amended Fire Emergency and Burn Ban for Grant County, seconded by Hochhalter. Roll call vote- Hochhalter– aye, Reinhardt – aye, Zenker – aye. Motion carried.

Patrick Diehl, Emergency Services presented the Flood Emergency Declaration Grant County, North Dakota. Reinhardt moved to approve declaration and Hochhalter seconded. Roll call vote- Hochhalter– aye, Reinhardt – aye, Zenker – aye.

Being no further business, Zenker adjourned meeting at 12:24 p.m.
