

# GRANT TOWNSHIP – HILLSIDE CEMETERY

*NO GRADING, LEVELING OR EXCAVATING UPON A BURIAL SPACE EXCEPT BY EMPLOYEES.*

*LIVE FLOWERS AND PLANTS MAY BE PLANTED IN URNS ONLY. URNS MAY BE FILLED WITH SOIL ONLY. NO OTHER MATERIALS.*

*NO TREES OR SHRUBS SHALL BE PLANTED ON PLOTS*

*THE SEXTON /GROUNDSKEEPER HAS THE RIGHT TO REMOVE OR TRIM ANY TREE, PLANT OR SHRUB AS NEEDED.*

*THE SEXTON HAS THE RIGHT TO REMOVE AND DISPOSE OF ANY GROWTH, EMBLEMS, DISPLAYS, OR CONTAINERS THAT BECOME DETERIORATED OR UNSIGHTLY.*

*FUNERAL FLOWERS SHALL BE REMOVED WHEN THEY BECOME UNSIGHTLY*

*NO SIGNS OR PERSONAL MEMENTOS SHALL BE PLACED ALONG ANY GRAVE SITE OR STONE. NO SOLAR LIGHTS OR MISCELLANEOUS ITEMS ARE TO BE PLACED OUTSIDE OF FOUNDATION*

*NO WHITE STONE, WOODCHIPS, GRAVEL OR OTHER ITEMS SHALL BE PLACED OVER OR AROUND GRAVE SITES.*

*SILK FLOWERS MUST BE PLACED IN AN URN OR PLANTER WHICH CAN BE MOVED. NO SILK FLOWERS OR DISPLAYS ON WIRES MAY BE PUSHED INTO THE GROUND.*

*ALL LITER, DEBRIS, URN MATERIAL OR GARBAGE SHALL BE DISPOSED OF IN LITTER BARRELS.*

*ALL ARTIFICIAL FLOWERS AND DECORATIONS THAT ONE WISHES TO KEEP, MUST BE REMOVED BY OCT 15 OF EACH FALL SEASON. DECORATIONS MAY NOT BE RETURNED TO THE GRAVE SITE UNTIL AFTER MAY 15 OF EACH SPRING SEASON.*

*CHRISTMAS / WINTER DECORATIONS ARE LIMITED TO WREATHS OR ARTIFICIAL FLOWERS. NO DECORATED TREES. THESE ITEMS ARE TO BE REMOVED BEFORE SPRING CLEAN UP WHICH BEGINS APRIL 1<sup>15TH</sup> OF EACH YEAR.*

*ALL WREATHS MUST BE PLACED BETWEEN HEADSTONES*

*THE TOWNSHIP IS NOT RESPONSIBLE FOR LOST, STOLEN OR DESTROYED ITEMS LEFT ON GRAVESITES*
