#### OUTSTANDING CONSERVATIONIST Kandiyohi SWCD 2022 Outstanding Conservationists Church Lake Farms

Conservation practices are increasing across Minnesota to protect the land and waters, and those leading the efforts on their land were recently recognized at the state level. Church Lake Farm of Pennock was honored as outstanding conservationists at the annual meeting of the Minnesota Association of Soil and Water Conservation Districts (MASWCD). They were selected by the Kandiyohi Soil and Water Conservation District (SWCD) for the award. Each year, the state's SWCDs recognize individuals and organizations for outstanding accomplishments in implementing conservation practices and improving Minnesota's natural resources. The award program is done with support from *The Farmer* magazine.

Church Lake Farm was recognized for using a wide variety of conservation practices on their farm, said SWCD District Technical Coordinator, Ryan Peterson. Church Lake Farm has constructed water and sediment control basins to help manage water runoff and control erosion on their land. They primarily grow alfalfa and are use cover crops along with conservation plantings to help protect their soils from eroding year-round. A variety of wildlife and pollinators also benefit from the native buffers installed to help filter and keep water clean. Solar panels, Irrigation water management, wetland restorations, and nutrient and pest management plans are some additional examples of Church Lake Farm conservation efforts.

"We're really proud of Church Lake Farm and what they have done for conservation in Kandiyohi County," said Peterson. "Church Lake Farm provides a wonderful example of how conservation can be successfully implemented using modern technology and farming practices. They are excellent stewards of the land and great models for future conservationists."
