*Charges may be dismissed if the defendant remedies this defect and shows proof to the court by the court date, a compliance fee of \$20.00 will be charged

**Charges will be dismissed upon presentation of evidence of valid driver's license or that insurance was in effect on the vehicle driven on the date the citation was issued.

Code of Criminal Procedure Art. 45.0511(g). RIGHT TO A DRIVERS SAFETY OR MOTORCYCLE OPERATORS COURSE.

You may be able to require that this charge be dismissed by successfully completing a driving safety course or a motorcycle operator training course. You will lose that right if, on or before your appearance date, you do not provide the court with notice of your request to take the course.

PLEASE HAVE PARENT OR GUARDIAN CONTACT COURT FOR HEARING DATE

Art. 45.057(h)(i) CCP

A child and parent required to appear before the court have an obligation to provide the court in writing with the current address or residence of the child. The obligation does not end when the child reaches 17. On or before the seventh day after the date the child or parent changes residence, the child or parent shall notify the court of the current address in the manner directed by the court. A violation of this subsection may result in arrest and is a Class C misdemeanor. The obligation to provide notice terminates on discharge and satisfaction of the judgment to final disposition not requiring a finding of guilt.

If you wish to plead not guilty and set a trial date or if you wish to pay by mail please enter a plea as indicated at the bottom of this page and return it to the court on or before your appearance date. Refer to Fine Schedule for fine amount. Make payment by money order, payable to the City of Kemp.

If you wish to enter a motion for a time payment plan, deferred disposition, or a driving safety, you must appear in court at 10:00 a.m. on the appearance date which is noted on the bottom right-hand corner of your citation, or complete the plea form below and mail it in no later than your appearance date.

* I have enclosed \$ 144.00, proof of insurance, and a copy of my driver's license; and request a driving safety course (Additional \$25.00 if violation in active school zone)

* I have enclosed \$134.00 and request deferred disposition, the remaining balance of the fine will be due at the end of probation. (Additional \$25.00 if violation in active school zone)

To be eligible for the driving safety course, you must meet these requirements:

1. Must make request in writing via certified mail or in person.
2. Must not have had course in past 12 months.
3. Must have valid Texas driver's license or permit or proof of active duty military.
4. Must not have or held a commercial Driver's License.
5. Must not have been exceeding speed limit 25 m.p.h. or more.
6. Must not have been in a work zone with workers present.
