ORDINANCE NO. 24-01

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KEMP, TEXAS, ORDERING A GENERAL ELECTION TO BE HELD ON THE 4TH DAY OF MAY 2024, FOR THE PURPOSE OF ELECTING THREE (3) COUNCILMEMBERS, PLACES 1, 3 & 5 FOR TWO (2) YEAR TERMS EACH; PROVIDING FOR ELECTION OFFICERS; DESIGNATING THE PLACES AND MANNER OF HOLDING SAID ELECTION; PROVIDING FOR THE POSTING AND PUBLICATION NOTICE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the regular General Election for the City of Kemp, as set forth by the Texas Election Code, is required to be held on Saturday, May 4, 2024, at which time the voters will elect persons to the position of three (3) council members, Places 1, 3 and 5; and

WHEREAS, in accordance with Section 271.002 of the Texas Election Code, the City General Election will be conducted jointly with other political subdivisions of Kaufman County, Texas.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KEMP, TEXAS, THAT:

SECTION 1

The facts and recitations contained in the above preamble of this Ordinance are hereby incorporated herein for all purposes.

SECTION 2

The regular general municipal election of the City of Kemp, Texas, shall be held between the hours of seven o'clock a.m. (7:00 a.m.) and seven o'clock p.m. (7:00 p.m.) on Saturday, May 4, 2024, in the City for the purpose of electing three (3) council members, Places 1, 3 and 5, for two-year terms each.

SECTION 3

The election will be conducted jointly with other political subdivisions in Kaufman County on May 4, 2024, pursuant to Chapters 31 and 271, Texas Election Code.

SECTION 4

The election precincts and voting places of said election shall be determined by Kaufman County, Texas.

SECTION 5

All election officials, including the Early Voting Clerk, shall be the officials appointed to such positions by Kaufman County and to the extent required by law, are hereby so appointed.

SECTION 6

Early voting by personal appearance will be held jointly with other Kaufman County public entities at those locations identified in Exhibit A, attached hereto and incorporated by reference, beginning on April 22, 2024, and continuing through April 30, 2024, at the times and locations as referenced therein.

SECTION 7

The Kaufman County Election Administrator is hereby appointed to serve as the Early Voting Clerk, and the Elections Administrator's permanent county employees are appointed as deputy early voting clerks.

Applications for ballots by mail must be received no later than the close of business on April 23, 2024.

SECTION 8

Election Day voting by qualified voters shall occur on Saturday, May 4, 2024, from 7:00 a.m. until 7:00 p.m.

SECTION 9

The City Secretary is hereby authorized and directed to file, publish and/or post, in the time and manner prescribed by law, all notices required to be so filed, published and/or posted in connection with the conduct of this election.

SECTION 10

The election shall be conducted pursuant to the election laws of the State of Texas.

SECTION 11


This Ordinance shall be construed with any action of the Kaufman County Commissioners Court providing for the conduct of a joint election with other public entities as herein contemplated.
