Introductions were given: Tag Wybrow- Spillman & Perry Koger - Spillman

There was a demonstration on Spillman System software products, which took most of the meeting.

After the demonstration of the Spillman System there were several issues that were brought up.

- > Friendship reception is very poor. Tom said that the bottom line is that the new system have the new tower installed on Benner Hill before the new system can be turned on. Tim Polky thought that it would be better to keep the system as is and wait until the new system up and running.
- ➤ Having some problems with the minitor 5's going off in the middle of the night. There is a fix for that (software) which is available on line.
- > Can we be provided a timeline on progress?
  - Nothing has been done on Coggins, just got the construction permit, the town permit will be in hand tomorrow (March 21, 2013). Work should start on April 1, 2013. A temporary trailer will be placed on Vinalhaven at the new tower as we need to keep the old tower site working until we can move it. The building will move later when the mud dries up enough to get the building foundation poured. The trailer will be used until that happens.
  - Benner Hill is depending on the new tower for the microwave.
  - The land owner has an issue with the right away and some other things and family is involved. The county is working through attorneys to straighten out the issues which involve damage to the road due to mud.
  - Tenants Harbor's new equipment is hung on the tower, needs to get a shack and the new equipment in there and that would be ready to fire up when the rest of it is.

- ➤ By-laws need to get the by-laws going in the right direction. The Executive Board needs to meet with the County Administrator and Lawyer to see what the holdup is. The Executive Board must get back with this committee on the status of the by-laws within 30 days.
- > Need to know what the uniform way of following up on complaints would be.
- Formal written complaint process needs to be outlined in the by-laws.

- > Tom Johnston reported on the following:
  - Vinalhaven's trailer is out there set and ready. They will be setting phones for the pads for the building. SPA should be out there next week to inspect the microwaves and do some aliment. Most equipment on Ragged is set up. Coggins Hill has the building and generator set on it ready for Active to go and put their equipment in. Tenants Harbor building should go in sometime next week with power hook up and ready to go. Figuring on power backup either backup battery or generator. Benner Hill reached an agreement with surrounding landowners, road owners on Monday. Hopefully have the paper work in hand on 4/26/2013 where we can get SPA started on the site next week. Once we get on that site we can move ahead. Tom said that they are looking at testing out the system by June 1, 2013 and in operation on the 15<sup>th</sup>. There was discussion on what Tom reported. It was asked about if the system will work as well as before the system was for the HAM Radio side. Tom said that he didn't know of any changes that would affect but he will check on it.
- ➤ Linwood discussed outages. One outage was due to the link between Ragged and Lenfest Tower, which has been the caused by the last 2 outages. Nobody really knows what the cause was. Once the new system comes on all that will be obsolete. One outage was caused by a tech doing repair work. An operator error occurred using the City Watch program to make this notification, the initial outage info was only sent to personnel having cell text/email addresses.
- ➤ Chief Grinnell had a problem about being dispatched to the wrong locations. Discussed 1- EMS call Dispatch problem (120 Beechwood St) and 2- call (fire) was dispatched to wrong location.
- > Tom Johnston had a question about the procedure on a grass fire. At what point does Dispatch contact forestry? Director Lothrop said that notification is made upon agency request-not automatically.
- ➤ By-Laws update- Report

After Chris Farley gave a short report from the Executive Board meetings of March 9<sup>th</sup> and 18<sup>th</sup> there was discussion and suggestions about the by-laws. After the Executive Board review what the County Attorney reported it was decided to rewrite the by-laws. There were several suggestions on how and what should be included in the by-laws such the original by-laws were written prior to the County going to a Charter government.

### **Follow-up Actions**

1. Review calls with dispatchers – make sure proper listening techniques are being used. Stress need for accuracy. Provide additional training where applicable.

2. Periodic review of known flagged records for accuracy by both the responsible agency and dispatch.

Review policy on response to schools by EMS for Fire incidents.

3. EMS Staging – discuss with Advisory Board for one policy

Caller Instructions – SOG updated to guard against sending a caller into a dangerous environment to gain added information

Dispatch Announcements – Canned message for Fire and EMS announcements to better gain uniformity Examples attached.

#### Rockland EMS:

- A- ambulance to respond non-emergency may or may not have ALS on board depending on staffing
- B- ambulance to respond emergency (confirm with duty officer that ALS is available or needs to be requested if called for)
- C- ambulance to respond at the ALS level emergency (if ALS is not immediately available start the closest ALS)
- D- ambulance and extra crew (ambulance or squad) emergency (if ALS is not immediately available the closest ALS will be started)

Anytown Volunteer EMS (for A+B level calls tone, wait 3 min. if no licensed personnel re-tone, wait 3 more minutes, then start M/A, For C+D calls start M/A 3 min after first tone, then re-tone)

- A- ambulance to respond non-emergency (after 3 min. if no response tone again, after another 3 min start M/A)
- B- ambulance to respond emergency (dispatch to secure where ALS will come from if needed: call Anytown Medics first, if unavailable secure closest M/A ALS)
- C- ambulance to respond emergency (if no ALS signs on within 3 min start closest M/A ALS)
- D- ambulance to respond emergency (if no ALS signs on within 3 min start closest M/A ALS)


