- Section 3.06.003(a)(1) – General standards for fences states: “Except as otherwise stated herein, fences may be constructed of wrought iron, vinyl, stone, masonry, brick, welded wire within wooden or metal framing, with wooden or metal posts, wood or other materials of like kind...”

Section 3.06.003(a)(6) – “Galvanized sheet metal, corrugated metal, or corrugated fiberglass fences shall not be permitted in any zoning district.”

The resident has built a 6 ft metal fence in the back yard.
