

SECTION 5.0
MISCELLANEOUS:

SECTION 5.1
TRAFFIC SIGNS:

Orders and directions of the Police Department as to traffic by mechanical device, shall be indicated as follows: On display of the "STOP" Sign, all vehicles must stop back of the stop sign on arrival at street intersections.

SECTION 5.2
PRIVATE SIGNS PROHIBITED:

Private signs regulating traffic prohibited. Except as provided in the ordinance, no person other than those authorized in this ordinance, shall exhibit a sign or standard of any type upon any street or in any public place in any attempt to regulate traffic or the parking of vehicles.

SECTION 5.3
THE USE OF ANY STREETS FOR DISPLAY PURPOSES PROHIBITED:

It is unlawful to use any of the streets within the town for display purposes, or commercial selling.

SECTION 5.4
DUMPING OF SNOW IN THE STREETS AND PUBLIC WAYS PROHIBITED:

In an effort to assist Madawaska residents with winter snow removal; but to also ensure the safety of the traveling public; the Board of Selectpeople acting within 30A M.R.S.A. §3009 establishes the following Municipal Public Ordinance, Section 5.4. This ordinance will replace the version adopted on December 1, 1983.

It shall be unlawful for any person to push or unload snow on the sidewalks, or in the breakdown lane or right-of-way of any street or public way; either by the use of a motor driven vehicle or snow blowing equipment; after the Madawaska Public Works Department has completed the clean-up and removal of snow banks; resulting from the towns plowing activities; from the said sidewalks, streets, and/or public ways.

It shall be the responsibility of individuals to check with the Madawaska Public Works Department regarding the snow cleanup status for their sidewalk, street, or public way prior to placing snow in the town's right-of-way. The Madawaska Public Works Department shall make the determination as to when the snow cleanup operations are complete.

In no event shall any person push or unload snow into the traveled portion of any street, avenue, or public way.

Any person found guilty of violating this ordinance will receive one written warning. The second time an individual violates this ordinance, the penalty shall be \$190.00.

This ordinance is not intended to effect prosecutions made pursuant to the **State of Maine Laws: M.R.S.A., Title 29, and Section 2396, Subsection 4 which states:** A person may not place and allow to remain on a public way snow or slush that has not accumulated there naturally. Penalty: Section 2396, Subsection 4: \$190.00.

SECTION 5.5

SLIDING PROHIBITED:

It is unlawful for any person to slide, ski, or skate or slide on cardboard on any sidewalk or streets within the town limits.

SECTION 5.6

FOUR-WAY STOP ON FRENCH AND 11TH AVENUE:

There shall be established on the corner of French Street and 11th Avenue a four-way stop.

PENALTY: The penalty for violation of the above ordinance shall be in accordance with State of Maine Statutes.

SECTION 5.7

FOUR-WAY STOP ON FOX STREET AND 19TH AVENUE:

The Board of Selectpeople acting within 30 M.R.S.A. §2151 (3) proposes to establish a four-way stop at the intersection of Fox Street and 19th Avenue.

SECTION 5.8

**FOUR-WAY STOP ON FRENCH STREET AND PLEASANT STREET
FOUR-WAY STOP ON FRENCH STREET AND 12TH AVENUE**

1. The Board of Selectpeople pursuant to 30 M.R.S.A. §2151 proposes to establish a four-way stop at the intersection of French Street and Pleasant Street.
2. The Board of Selectpeople pursuant to 30 M.R.S.A. §2151 proposes to establish a four-way stop at the intersection of French Street and 12th Avenue.

SECTION 5.9

FOUR-WAY STOP ON FRENCH STREET AND 13TH AVENUE:

The Board of Selectpeople pursuant to 30 M.R.S.A. §2151 proposes to establish a four-way stop at the intersection of French Street and 13th Avenue.

SECTION 5.10

**FOUR-WAY STOP ON FOX STREET AND 22ND AVENUE
STOP SIGN AT THE CORNER OF ST. THOMAS STREET AND
5TH AVENUE**

1. The Board of Selectpeople pursuant to 30 M.R.S.A. §2151 proposes to establish a four-way stop at the intersection of Fox Street and 22nd Avenue.
2. The Board of Selectpeople pursuant to 30 M.R.S.A. §2151 proposes to the replacement of a yield sign to a stop sign at the corner of St. Thomas Street and 5th Avenue.
