

Oliver County LEPC/MHMP Meeting

Minutes for April 27th, 2022

Oliver County Courthouse, Center, ND

***Meeting called to Order:** The meeting was called to order by Carmen Reed at 7:00 pm. There were 12 members present.

***A Motion to Approve the Minutes from last LEPC meeting which was held on 05/13/21:** Barb Fleming made a motion to approve the minutes as presented from the last meeting, which was held on September 16th, 2021. Mickie McNulty-Eide seconded this motion. All members were in favor. Motion passed.

***Review of Center Power Outage during the April 24th Storm:** City of Center experienced a power outage during the April 24th Storm. Committee members discussed different sheltering options available to the City residents during different types of severe weather. It was agreed that for winter weather the Civic Center would be the main shelter. The St Paul's Lutheran Church is used for Summer Severe weather. Amber Vogle %Coal Country Health Clinic states if the Clinic could get a generator, they have a huge empty basement that could be used for a shelter. Items that will be checked on include:

1. Partnering with Red Cross on Supplies & information on our shelters.
2. Gather the application requirements for obtaining a generator for the clinic.
3. See if the School would shelter people if needed in a cold weather incident.

*** 2022 Exercise Update:** Troy Karlberg %Minnkota Power discussed the upcoming tabletop exercise that is scheduled for June 9th, starting at 5 pm with a tour of the Nelson Lake Dam, then 6pm a catered dinner and at 6:30pm the tabletop exercise. Also discussed the invite list of entities.

***SIRN Radio & NG911 Projects Update:** NG911 update was completed November 17th. The SIRN Radio upgrade will be complete by May 11th. Training will be done May 3rd & 4th. Entities are ordering radios as they can afford them and the orders have a 6-8 month delivery schedule.

***TEP – Training & Exercise Plan, is now the Integrated Preparedness Plan (IPP):** This new plan is basically the same, we need to review and discuss the types of exercises Oliver County needs to do to keep responders prepared to respond to. Carmen will review information that she received from State and bring back topic at next meeting. It has been decided to do the 3 exercises a year (Tabletop, Function & Full Scale exercises) within a 6-8 week timeframe and include both Counties. Looking at doing this as early as fall of 2022.


***Other Items/Discussion:**

- ✱ Hannover Tower & School Bus Radio Status Report: School Bus Radios are working. A new antenna has been put on a State Radio Tower. No bills have been received yet.

- ✱ Skywarns class for Oliver County will be done June 1st at 6pm at the Oliver Ambulance. A supper will be provided to get more people at this meeting.
- ✱ At the next LEPC meeting we will need to review all Tier II reports, along with fees collected for Oliver County.
