a. Administrator:

- i. Clinic None
- ii. Fire Department/EMS
 - EMS air ambulance regulations EMS Chief Erin Cooper attended a meeting with the State Medical Services Board working group. She reports the working group is taking action to address our concerns. The proposed regulations will need to be reissued, but Chief Cooper is hopeful they will allow Penobscot Island Air to continue fly emergency medical patients off the island.

 - Y-Knot Boatyard has disconnected the ramp and floats at Pulpit Harbor
- iv. Legal George and Martha Neale have offered to donate shore land on Fresh Pond to the Town. Tammy Brown continues to work with the Town's attorney to determine the best way to proceed.

 - New Smith Street parking area is nearly done; awaiting permission to construct 5 new diagonal parking spaces above Calderwood Hall on Fred Emrich's property

- viii. Town Properties Colin Bergeron, a tree surgeon, will prepare an estimate to assist the town in trimming back tree limbs and removing diseased or dead trees that impact the Town's roads and properties.
- ix. Transfer Station Lattimer and Transfer Station Manager, Peter Cooper, are working on a plan to address hazardous waste disposal and to obtain more containers
- x. Water Department We received one estimate from Phoenix Tech out of Akron, Ohio: \$120,000 for the interior, another \$56,000 if we wanted the exterior painted as well. Water Department Supervisor Glen Marquis had identified other possible vendors; we are awaiting their estimates. The Town water tank was installed in 1994.

7. Old Business:

a. Community Building Lights — Achorn Electric submitted the lowest priced bid to replace the sodium lights and the fluorescent lights inside the building and to install an exterior light shining on the basketball court that would be activated by a timer: \$5,796.

b. *Public Safety Building* — Lattimer noted that he is continuing to draft a request for proposals and will share the draft with the Fire Chief, EMS Chief, and Road Commissioner to obtain their feedback and comments.

8. New Business:

- a. Burnt Island Float J.O. Brown's notified the Town that the current float at Burnt Island will not survive another season; Brown's recommends replacement with a new float. The Board directed Lattimer to talk with both Brown's and Thayer's Y-Not Boatyard to see if both are interested. If so, Lattimer is to compete the work.
- b. *Executive Session* The Board held an executive session under Maine Revised Statutes, Title 1, Chapter 13, subchapter 1, section 405.6.C. The purpose of the executive session was to discuss the possible acquisition of real property by the town.

- Curtis noted there is a company in Maine that recycles fiberglass boats; perhaps that company could take care of the three boats at the Transfer Station
