DEDICATION NORTH HAVEN ANNUAL REPORT – 2021





Dear Friends.

On the heels of 2020's challenges, 2021 brought us both amazing progress and frustrating setbacks. The incredible rollout of several effective, FDA approved COVID-19 vaccines helped reduce the risks of this deadly pandemic – but vaccine hesitancy, combined with the dangers of new variants, have prolonged this crisis and created new risks for Maine people. The challenges raised tension levels to boiling points during the fallout of the 2020 presidential election and the January 6th Capitol attack. But despite that, Congress was able to deliver for a nation gripped by an unprecedented pandemic. As we reflect back on the year, we see the important action that will make a difference for Maine people – as well as work still unfinished.

As COVID-19 continued to impact communities across our state and the country, Congress's first priority this year was to confront the pandemic's health threats and economic toll. We immediately got to work on the *American Rescue Plan*, crafting an emergency bill to meet the moment and get our nation back on stable footing. The legislation delivered essential support to businesses facing crises, households in need, and the medical professionals on the front lines of this fight. The funds helped get vaccine shots in arms, while also confronting the damage done to our economy. All told, the *American Rescue Plan* is bringing billions of dollars to Maine, helping the state continue to push through this crisis and bounce back stronger than ever.

After passing the *American Rescue Plan*, Congress turned its attention to a longstanding but unfulfilled priority: infrastructure. Through hard work and compromise, both parties came together to pass a bipartisan bill that finally addresses key infrastructure needs. For Maine people, the bill means an estimated \$1.5 billion to repair crumbling roads and out-of-date bridges, \$390 million to improve access to clean drinking water, and more. I am most excited about the significant funding for broadband – because, as we have seen during the pandemic, broadband is a necessity to succeed in the 21st century economy. The historic investments in the bipartisan infrastructure bill, combined with additional funding I pushed for in *the American Rescue Plan*, will bring an estimated \$400 million for broadband home to Maine. These funds will be nothing short of transformational, creating new opportunities across our state.

These two bills have made and will continue to make a real difference for Maine people, helping to both address the challenges of COVID-19 and lay a foundation for long-term success. I am proud of what we've accomplished this year – but I know there is still a lot of work to do and that the road ahead is challenging. Even still, I am filled with optimism because I know the true nature of our citizens, though challenged, has not changed. Despite every hardship, people in towns and communities have stepped up with strong local leadership, a willingness to help, and a Maine 'neighborhood' spirit. It is why I truly believe we can and will get through anything together. Mary and I wish you a happy, healthy, and safe 2022.

Dear Friends,

I hope this letter finds you well. It is an honor to represent you and your family during these challenging times, and I am thankful for the opportunity to update you on my work in Washington and Maine.

The COVID-19 pandemic continues to cause challenges for people in Maine and across the country. Please know that the health and safety of you and your loved ones, as well as the economic recovery of our communities, remains the driving force behind legislation I have pushed for in Congress.

In early 2021, Congress passed the American Rescue Plan, historic legislation that makes investments to crush the virus, create millions of jobs, provide direct relief to working families, and help schools remain safely open. Not only did this legislation give 90 percent of American households a stimulus check, but it also helped local and state governments better respond to the pandemic, put food on families' tables, got more vaccine shots into arms, cut child poverty in half through the expanded Child Tax Credit, and so much more. The American Rescue Plan is one of the most important pieces of legislation Congress will ever pass, and I'm so proud to have supported it from the beginning. Our economic recovery from the pandemic will be accelerated even more thanks to the bipartisan Infrastructure Investment and Jobs Act, which Congress passed in November. This legislation marks the most expansive infrastructure investment since the construction of the interstate highway system. From funding to repair our aging roads, bridges, and ports to high-speed broadband expansion and legacy pollution clean-up, this law is a once-in-a-generation investment in our future.

In addition to working on COVID-19 relief legislation, my Congressional colleagues and I are also collaborating on legislation that addresses the climate crisis, supports voting rights, and—through my role on the House Appropriations Committee—supports programs important to Maine.

After seven years on the House Appropriations Committee, I took the gavel and lead the subcommittee that oversees discretionary spending for the Department of the Interior, the

Environmental Protection Agency, US Forest Service, and several agencies related to the arts and humanities. In my new role as Chair, I have fought to secure significant funding for Maine's tribes, environmental preservation programs, our cultural economy, and our forests.

I will keep pushing legislation to support America's long-term care needs, lower prescription drug costs, expand Medicare benefits, cut taxes for working people, make our workforce competitive with the world, and fight climate change.

So, as we reflect on 2021, let us welcome 2022 with a renewed sense of optimism. There is a lot to fight for, and I assure you I will continue to fight for Maine in Congress. I want you to know that my staff and I are doing all we can to support Mainers through this public health crisis and all the challenges that come with it. If you are unsure of the resources available to you, are having difficulty accessing resources, or if you'd just like to share a thought or opinion, please do not hesitate to reach out.

NORTH HAVEN PLANNING BOARD - 2021 REPORT

It has been another busy year for the Planning Board, especially around ongoing work on a final land use ordinance document. Workshops, discussions with the Select Board, and check-ins surrounding possible legal issues have brought the board to a Final Draft of an updated North Haven Land Use Ordinance. We are looking forward to setting a date for a Public Hearing on the Draft. This hearing will allow the public an opportunity to examine the document as well as to provide a forum for observations, comments, and questions directed to the Planning Board.

Also on the agenda is a NH Shoreland Zoning Ordinance. We plan to use the State of Maine's model SZO as our guide. Shoreland Zoning involves many state-mandated rules and regulations, therefore we will model our Shoreland Zoning on Maine SZO guidance. Our final SZO will eventually be presented at a Public Hearing.

As a reminder: Public Hearings on local ordinances are followed by Town Meetings at which voters may elect to adopt them.

Working closely with Faye Grant and Tammy Brown, the Town's Code Enforcement and Associate Code Enforcement Officers, respectively, the Planning Board uses and interprets local ordinances regularly to answer questions, provide guidance, and process Land Use Permits. We encourage property owners and their agents to inquire of Code Enforcement whether a Land Use Permit is required before commencing any project related to land use

FERRY SERVICE ADVISORY BOARD - 2021 REPORT

By many measures, the Maine State Ferry Service (MSFS) has rebounded from the ridership lows of 2020. There are, however, still lingering Covid-19 effects, some of which may in the end turn out to be beneficial.

We all remember March of 2020 when the North Haven schedule was reduced to two trips per day, which made sense as most people on the island weren't anxious to travel even as far as Rockland. And at the same time, it made sense to limit the number of people traveling to North Haven to protect our community. Gradually, people adapted to limited mainland travel, often in their vehicles rather than sitting in the cabin. The crew, which was good about wearing masks, spent many hours cleaning and disinfecting common surfaces.

By summer of 2020 we were back at our full schedule of three trips per day, although the boat was not often fully loaded. From then on, travel gradually ramped up so that line-up numbers and reservations were again hard to come by, and necessary, to assure travel on a desired boat. Even when the new seasonal tickets became more expensive in the spring, summer, and fall of 2021, travel on the ferry continued to increase right through the year.

We were fortunate that the MSFS was proactive in securing \$2M from the Federal Relief Funds, which coupled with rebounding traffic on the boat and the higher seasonal ticket prices has helped to keep the service running without further price increases.

Rockland Terminal Manager Mark Higgins has assured the Advisory Board that there are no rate increases being considered until at least the fall of 2023.

In other good news, Higgins has stated that there are no immediate plans to change the parking/line up procedure in Rockland. Something to keep an eye on just the same.

Just keeping the boats running during the pandemic has required a lot of work behind the scenes on the part of the people responsible for scheduling crews, particularly in the Rockland Office. Covid has resulted in many complications for keeping crew numbers up, even still today. On January 21st, the MSFS posted the following from Rockland Manager Mark Higgins:

"...The MSFS continues to operate and prioritize the health and safety of our customers, employees, and communities. While no schedule reductions or cancellations are planned at this time, we are experiencing staffing shortages due to COVID-19. These staffing shortages could lead to temporary interruptions of service on short notice. Any such changes will be communicated on the message boards at the MSFS terminals and sent through the 511 notification system. We strongly encourage all riders to subscribe to our alerts to receive schedule updates.

One of the positive outcomes from Covid-19 is the outlay of Federal Infrastructure money for the MEDOT and MSFS. The full amount is still being assessed along with how it might be spent, but it will help fund new vessels and with the updating of shoreside

infrastructure to accommodate electric ferries. Last year I mentioned that we need to begin thinking about the Burgess' replacement. The timeline given for that ferry is as follows:

2027 Design and Engineering 2028 Construction 2029 Delivery

Mark Higgins has promised that North Haven will have input concerning this new vessel. He has said he is willing to consider a 23 car ferry with a different layout than Burgess, with passengers still on first level and therefore not requiring an elevator. Sometime in the coming year or so we will survey the Town to better understand what peoples' thoughts are on the design of the new ferry.

In light of the Federal Infrastructure Funding coming to Maine, the MSFS Advisory Board agreed, and the DOT/MSFS concurred, on the following resolution for guidelines:

Resolution of the Maine State Ferry Service Advisory Board 9/16/21

- 1) That the MSFS make every effort, through cooperation with Maine's congressional delegation and the U.S. Department of Transportation, to obtain federal funds to assist in the funding of and to accelerate the current vessel replacement program;
- That the MSFS consider and employ hybrid and/or electric propulsion systems in new vessels to address cost issues, climate change issues, and vessel speed issues;
- 3) That during the design process particular consideration be given to designs that will maximize revenue and minimize cost, particularly personnel costs;
- 4) That during the design process the MSFS provide the users of the ferry system an open and transparent forum to provide the MSFS with input into the needs of the users of the system to be incorporated in the design of new vessels;
- 5) That the MSFS, to the extent practicable, take vessel speed into account to accommodate longer runs, primarily to North Haven and Vinalhaven with a view toward exploring the possibility of increased trips per day thereto.

Last year a beneficial new policy was put into play where if a person is evacuated for medical reasons, the spouse/partner/guardian will be able to ask for a priority at the NH ticket office to travel on the next ferry with a car to be able to reunite with the patient. This is something that Mark Higgins offered after a similar situation arose last year where the ability to get on the next boat was not clear. This help would be much appreciated in a time of crisis.

Finally, mention must be made in praise of our great boat captains and crews, as well as our ticket office crew. This year has been a hard one and all our crew have carried on admirably. We are lucky to have such willing and helpful people here. A special thanks for the patience shown by Jen, Bethany, Mandy and Adriana in our ticket office.

TAX ASSESSOR'S 2021 REPORT

The Tax Assessors' primary responsibility is to see that all North Haven properties are assessed equitably and fairly in order that the town's tax burden is appropriately distributed between all taxpayers.

The Tax Assessors monitor all real estate sales transactions in an effort to keep assessed values as closely aligned with just value (sales price) as possible and take note of any irregularities or special situations (sales between family members or abutting property owners). Each arms-length transaction sales ratio is taken into account when establishing North Haven's sales ratio for the year. Trends are not set by one disparate sale but when there are a number of similar results, the Assessors consider if and how any assessment procedures or formulas need to be adjusted. During 2021 North Haven certified ratio was 98% which shows, on average, equity between sales prices and assessed values.

Occasionally real estate appraisals are submitted to the Assessors as evidence of incorrect assessed value. If these appraisals are done for a reason other than tax assessment review (i.e. estate settlement, divorce dispute, insurance, property sale) they may not accurately take into account a town's assessment values or procedures and cannot be used for tax assessment purpose.

Thanks go to Merton Howard and Scott Higgins for their work on the Assessor's Board in 2021. Many thanks also to Assessors' Agent Tammy Brown for her continued hard work on behalf of the town of North Haven

TOWN ADMINISTRATOR - 2021 REPORT

Last year, I closed my report with "I believe we need a vision for the Town that will help us coalesce as a community around ideas for the future. My goal is to facilitate a community-wide discussion throughout the spring and summer that leads to a vision statement by October." We were delayed a bit in getting the vision process going, but we made it! We wrapped up work on the Vision in late December and presented it and three Priorities to the community in January 2022. I want to thank everyone who contributed to this process, but especially the Select Board, the North Haven Collective, Gabe McPhail, and Mia Colloredo-Mansfeld.

Our next steps in the Vision & Priorities process are to form working groups and begin addressing the priorities. As I have said to the Select Board and others, I want to see us take concrete steps on concrete timelines to make appropriate changes. The three priorities are: (1) Access to Housing; (2) Workforce Development & Economic Diversification; and (3) Environmental Sustainability & Climate Change Impacts. You can follow our progress and get involved in two ways, by periodically checking the Vision Hub on the Town website and by signing up to receive email updates. The Town's website is www.northhavenmaine.org.

The Select Board and Planning Boards have worked together to advance both a new and updated Land Use Ordinance and a Shoreland Zone Ordinance. The Planning Board deserves your thanks for the years of effort they have put into these documents. In joint workshops and meetings, the two boards discussed the idea of reducing minimum lot sizes in an effort to reduce impediments to creating year-round housing opportunities. We conducted a survey to determine the community's feelings and the results showed support for these changes. You can look forward to a public hearing to discuss the ordinances and a special town meeting to vote on the final products. We first need to obtain the State's approval of the Shoreland Zone Ordinance in final draft form.

On a somber note, the Town's house in which Deputy Josh Lemoi and his family lived caught fire in December. Sadly, the family lost both their dogs. Thanks to the Fire Department, the exterior of the house was saved. We are working with our insurance company on our claim. We will begin rebuilding the interior soon. Jamien Shields, the Town's Property Manager, is overseeing this process. She and Maria Keeler have already removed all the debris and gutted the interior. The community rallied with amazing speed to support the Lemoi family and Karen Grant stepped up to rent a house to the Town for Josh, Kaitlyn, and Michael to occupy through the end of May. (Many of you offered housing; Karen had the longest availability.) If repairs to the Town's house are not completed by then, we will search for another temporary house.

Although we have spent a lot of time on the Vision process, we have not lost track of constructing a new Public Safety Building. Summit Engineering and Gartley & Dorsky

looked at the proposed site at the Town's Crabtree Farm property, which is usually referred to as the State Pit. The property is on South Shore Road about ¼ mile from the current Fire Station. Summit and Gartley & Dorsky found no issues that would interfere with building there. We are currently working on the contracting documents needed to begin the design process. Once we have a tentative design and solid cost estimate, we will return to the voters to ask them whether they will approve the funds.

In the meantime, we are maintaining our current Fire Station. Cooper Construction re-shingled the roof and Andrew Bonarrigo rebuilt the furnace chimney. Our Property Manager and Glen Marquis Plumbing installed a new bathroom. Harold Cooper did the wiring. There is now a door between the Fire Department and EMS meeting rooms so heat will flow through the building more effectively.

People often ask what will become of the old Fire Station if we build a new Public Safety Building. An idea I keep tossing out there is to convert the old station into a three-unit apartment. If we formed a public-private partnership, the Town could retain ownership of the property and mandate that the units be available only for year-round rentals. A private entrepreneur would take charge of the conversion and act as landlord. Time will tell whether this idea goes anywhere.

Last fall, Marcel Payeur, Inc. painted our water tank. They did an excellent job, on-time and on-budget. They stripped the tank and repainted inside and out. They resealed the concrete base, coated it, and recaulked the seam between the tank the base. Glen Marquis, Rex Crockett, and Charlie Arthur worked with Payeur to bypass the water tank and keep the system operational while the tank was stripped, cleaned, and painted. Thanks to them, our Water Treatment Plant suffered no ill effects from running the pumps constantly for weeks. Payeur's crew even agreed to pressure wash the Community Building roof and walls during their downtime.

Thanks to a \$10,000 grant from The Betterment Fund, we had a new standby generator installed at the Clinic. The old generator was built in 1969 and required our providers to go out behind the Clinic – often in the rain or snow – to start the generator manually. The new unit comes on automatically. Please thank Perry Gates for his help in identifying and obtaining this grant.

You have no doubt heard that Sue Ferra has retired. She was a real asset and a great friend to our community. Thankfully, the Medical Services Board, EMS, and the remaining Clinic staff worked together to search for and interview candidates for a second provider to work alternate weeks with Lorraine Reiser. I am pleased to say that we have hired Andy Zuber, a physician's assistant with extensive experience. Andy will start in March 2022.

In my 2020 report, there was a note of uncertainty as we continued to struggle with how to guard against and mitigate the effects of the COVID-19 virus. Thankfully – and this is not surprising – our community pulled together. We took effective steps and learned along the way how to live with the risks. Last summer the island was truly alive with people everywhere, yet we had no serious outbreaks. People got vaccinated – including over 80 percent of the year-round population. Our children returned to school and even resumed playing sports and extracurricular activities. We held our Memorial Day parade and Community Days events. We had music and dances in the ball field. Our restaurants and shops were busy again. And the ferry was so busy that Mark Higgins, the MSFS Manager, made the Island Transporter available to help with truck traffic during August and September. All of you deserve each other's thanks for doing your part to help – from Town employees and volunteers, to long-time islanders and one-day visitors. Thank you all for continuing to make our community's vision possible:

North Haven is a remarkable island community – resourceful, caring, safe and inclusive – committed to sustaining a thriving year-round economy, stewarding our natural resources, and preserving scenic beauty for current and future generations.

During 2021, the North Haven Medical Clinic was staffed by two family nurse practitioners, Sue Ferra, NP-C and Lorraine M. Reiser, PhD, FNP-C, who worked alternate weeks. Kathi Lovell is the office assistant. Carrie Thackeray, MD, is the clinic's consulting physician.

In addition, Emergency Medical Technicians and volunteer First Responders provided call-out and ambulance coverage. You need only to read in the North Haven News the unsolicited letters from people who have been cared for by our EMTs to know that our medical services are an island treasure.

The clinic also offered physical therapy with Patience Trainor, PT, on Tuesdays. Licensed Clinical Social Worker Anne Cogger, LCSW, provided individual, group, and family counseling by appointment.

Patient visits:

PT: 197 total. 177 in office, 20 Telehealth Counseling: 59 total. 50 in office, 9 Telehealth

Anne Cogger, let it be known in August that she would be retiring in November. Currently the clinic offers a list of Mid-Coast area mental health providers and their specialties.

In January 2021, with the availability of the Covid -19 vaccine, the Clinic began holding vaccination clinics in compliance with the CDC directives. A total of nine clinics were held throughout the year. About 87% of North Haven year-round residents have been vaccinated

In August, after ten years of dedicated and compassionate care, Sue Ferra announced that she would be retiring in February 2022. An interview committee was formed, comprised of members from the Medical Services Board, EMT's, Nurse Practitioners, Office Assistant, and Town Administrator. Interviews began in November and continued into 2022.

We are pleased to report that the health and wellness of the North Haven community is in the exceptional hands of our professional and caring FNPs, EMTs, and additional dedicated staff. We thank each of them for their hard work, dedication, and willingness to serve.

NORTH HAVEN FIRE DEPARTMENT - 2021 REPORT

During 2021, the North Haven Fire Department responded to twenty-one calls – six ambulance assists, nine false fire alarms, one equipment accident, a UTV accident, a wood stove malfunction, a grass fire, an ATV fire, and one structure fire.

As my first year as Chief, one of my main concerns is the chance of wildfire. The Select Board approved the purchase of a 2008 F250 brush truck and a Water Ax Mark-3 portable high-pressure pump. Luckily for us, the summer turned out to be fairly wet. Four of our carbon air tanks have met their lifespan, which made the purchase of new tanks necessary.

Unfortunately, the 2021 budget did not allow enough funding for maintenance and many upgrades. The recent structure fires have made it clear that we need to upgrade equipment, especially our air paks. The newest ones were purchased in 2004.

I continue to work with the Town Administrator and Select Board in hopes the muchneeded Public Safety Building is moving forward. Although expensive, I believe this is needed for the future of North Haven.

I would like to thank the NHFD crew for their commitment and dedication. I would also like to thank Shaun Cooper for his years of service and for making it an easy transition. Lastly, I would like to welcome our new members – Josh Lemoi, Chris Hersey, Seth Ames, Ryan Haskell, Sean Haskell, and Tony Green.

EMERGENCY MEDICAL SERVICES – 2021 REPORT

North Haven EMS provides uninterrupted emergency medical care for the island. Our crew is staffed by an all-volunteer crew of drivers, EMTs and advanced EMTs, and we are fortunate to have the North Haven Clinic providers respond with us. North Haven EMS is currently licensed through the state of Maine at the EMT-Basic level, and is permitted to the EMT-Advanced level.

In 2021, North Haven EMS responded to 51 calls for emergencies including anaphylaxis, motor vehicle accidents, stroke, and chest pain. In addition to medical or trauma calls, we are on hand to assist the fire department as needed. The North Haven Fire Department more than reciprocates this support, as they are available for lift assists, scene safety, and LifeFlight landing zones. We're indebted to them, and thank them for all they do.

Creative problem solving around patient transportation is always part of the rural EMT's job. On North Haven, our options include LifeFlight, Penobscot Island Air, Coast Guard, the North Haven ferry, and private boat. Weather, availability, and the nature of the emergency all play into transportation decisions. Transportation time to the mainland is highly variable, as is the total duration of a call, which only concludes when the ambulance is clean, restocked, and back in quarters. We'd be remiss not to note here the wide range of people beyond our crew involved in patient transport, including the LifeFlight nurses and pilots, PIA pilots, our ferry crew, and private boat owners including Fizz Papps, Aaron Cabot, Ryan Haskell and Foy Brown. When we transport via PIA, we hand our patients to the South Thomaston or St. George ambulance crew, whose assistance we are also grateful for.

This is a time of transition for medical services on the island. Sue Ferra, our longtime nurse practitioner and friend, has retired. We will miss her calm, knowledgeable presence on calls, even as we welcome PA Andy Zuber to the clinic. He will also be taking on the EMS director's role following Erin Cooper's resignation as crew chief. We're grateful for Erin's three years of service as our chief during a particularly challenging time of ever-changing pandemic protocols. Rick Lattimer served as interim director during the transition, and we're grateful to him also for stepping in.

Seven aspiring EMTs from North Haven and four from Vinalhaven have recently started the EMT-basic course through Kennebec Valley Community College. The hybrid model requires students to spend four hours each week in class online, and several weekends participating in in-person skills sessions. We also plan to offer the AVOC course this spring with the hope of adding several new ambulance drivers to our roster. We are always grateful and excited to welcome new members to our crew, and even as we find our way through a new leadership model and a continuing pandemic, we remain honored to serve our community through emergency medicine.

Thank you to the town of North Haven for providing continuing financial, organizational, and moral support for our team.

To see if the Town will vote to instruct the Select Board, School Board, and Planning Board to name one member from each board, or the community, to serve on a Search Committee, which will publish seven days in advance of the Annual Town Meeting a list of at least one candidate for each elected position.
