

Dear Friends,

Representing Maine in the United States Senate is an honor.

I continue my work on the Senate Armed Services Committee, each year authorizing the funding required to build our military capabilities and ensuring that our service members are trained and equipped to defend our nation. I was pleased to be part of a bipartisan effort to enact a new law to simplify the appeals review process to reduce the backlog our veterans are facing, as well as a new law that provides critical funding to the VA Choice Program, allowing veterans in rural Maine to access services closer to home.

While my committee work is important, working to combat the opioid epidemic is one of my top priorities. Although Congress has made some important strides, much remains to be done to provide additional funding for prevention, treatment and enforcement. I am working with colleagues on both sides of the aisle to pressure the Drug Enforcement Administration to reduce the amount of opioids produced and to thwart the flow of fentanyl and other deadly drugs into our country.

I am very optimistic about the integrated, multiagency effort I led with Senator Collins to foster innovation and commercialization in Maine's forest economy. Through the Economic Development Assessment Team (EDAT) we are already experiencing increased federal investments that will strengthen our existing forest products industry and help support job creation in rural communities. Initiatives like Cross Laminated Timber, Combined Heat and Power, nanocellulose, 3D printing with biobased materials and other biobased products will mean that Maine's wood-basket will continue to be a major jobs and economic contributor for our future.

Finally, the coming year will continue the work of the Senate Select Committee on Intelligence in the ongoing investigation of Russian interference in the 2016 election. Our Committee has held seven public hearings and numerous classified sessions, reviewed tens of thousands of pages of documents and conducted hundreds of interviews. I remain focused on the security of our elections and committed to developing strategies to prevent interference by foreign governments in our democracy.

May 2018 be a good year for you, your family, your community and our great State.

Dear Residents of North Haven,

I hope 2018 finds you and your family doing well. It is an honor to represent you and this community as your State Senator.

This past year, the Legislature made progress in providing direct property tax relief to Maine homeowners. I fought tirelessly to increase the Homestead Property Exemption from \$15,000 to \$20,000. In addition to direct property tax relief, we also protected state funding for local services such as fire departments and road maintenance, and increased public K-12 education funding by \$162 million over the biennium. These efforts will decrease the pressure on municipalities to increase mil rates. I know this is a top priority for many in our district and I will continue to work towards greater relief.

I would also like to share some information about the state's unclaimed property list. "Unclaimed property" is money owed to Maine people by third parties, such as former employers, banks or utility companies. Organizations are required to give unclaimed property to the State Treasurer after a specified period of time, after which the owner of the unclaimed property can retrieve it from the state. Even if you have done everything right, you could have unclaimed property. It could be from a forgotten account, an overpaid bill or uncollected wages. This money could be unclaimed as a result of a change in name, addresses or bank account. Visit maine.gov/unclaimed or call 1-888-283-2808 to see if you have any unclaimed property.

This past session, we considered over 1,600 pieces of legislation on a variety of issues. As part of my effort to bring matters happening in Augusta back home to our district, I am pleased to email a legislative newsletter to share information about ongoing legislative issues and useful resources. Dear North Haven Residents,

It is an honor to serve once again as your State Representative. As I enter my final year in office due to term limits, I intend to work hard throughout the session to provide responsive constituent services and advance legislation that benefits the people of our island and coastal communities.

This year the Legislature's agenda will be limited mostly to emergency legislation and bills carried over from 2017. We are scheduled to adjourn by the end of April.

The bills we will be taking up cover a wide range of topics, but our chief focus will be on making sure Maine properly implements the MaineCare expansion overwhelmingly passed by voters last November. We will also work to implement the recommendations of a task force that studied Maine's opioid crisis, continue to wrestle with education costs and property taxes, revisit our approach to energy and technology infrastructure in the wake of recent storms, find consensus on the voter-approved citizen initiative legalizing the limited recreational use and sale of marijuana and address any unexpected situations that might arise during the spring.

This year I will once again co-chair the Legislature's Marine Resources Committee. We will continue to work with the Department of Marine Resources on licensing and permitting issues, more effective enforcement, preventing unreasonable fee increases, providing more flexibility for fishermen and harvesters who experience medical issues and continuing to support ways to improve to health of our fisheries. The committee clerk maintains a list of interested parties that get email notification of the committee schedule. Please let me know if you would like to be added to that list.

Whether we are dealing with the above issues or any other topic, I will continue to work with all of my colleagues, regardless of party affiliation, to make sure we're doing the best work we can for the people of our district and all the people of Maine.

NORTH HAVEN PLANNING BOARD

With the aid of a consultant, and with extra labor from Jeff Crawford, the Planning Board has made progress towards finalizing a NH Land Use Ordinance revision. It is our expectation and hope that the revision will be before the voters before the end of 2018. The NH Subdivision Ordinance, and a suggested draft amendment to it, have been on our agenda as well. We also expect and plan for the draft amendment to come before the voters during 2018. Any ordinance revisions require public hearings and subsequently posted town meetings before voting and adoption take place.

Next the Planning Board intends to finalize approval and adoption of a revised Shoreland Zoning Ordinance. Fortunately this project is in its final stages with major work already accomplished.

Both Planning Board and Code Enforcement have spent time with property owners, or their agents, discussing property subdivision of individual properties. Obviously property management issues are changing as are some of the inquiries about them. Land usage can be a fluid conception and so we plan to stay abreast of new ideas and how best to work with them with the understanding we must all work within the language of our local ordinances.

Finally, we continue to be upset by apparent misunderstandings by shoreline property owners and their contractors over what is, and is not, allowed within the mandatory 250 feet and 75 ft. setback of the Shoreland Protection Zone (Shoreland Zoning). We continue to find, after the fact, willful tree and shrub cutting violations. Anyone who walks the shores of NH can easily see constant erosion effects as tree roots are exposed and any surrounding soil amongst them is washed onto the beaches below. Cutting live plants and thereby losing live roots only hastens soil erosion already taking place. Property owners should check with code enforcement before undertaking any tree cutting or other disturbances on properties located within the Shoreland Protection Zone.

FERRY SERVICE ADVISORY BOARD 2017 REPORT

The Ferry Service Advisory Board (FSAB) meets bi-monthly in January, March, May, July, September, and November. Meetings are held at the Conference Room at the Rockland terminal beginning at 10:30 AM. Each island town served by the Maine State Ferry Service (Islesboro, North Haven, Vinalhaven, Swans, Frenchboro, and Matinicus) appoints an advisory board member as well as an alternate. There are also representatives from each of the mainland towns where a terminal is located (Rockland, Lincolnville, and Bass Harbor). The ferry service manager, Mark Higgins who was appointed last fall, attends, as well as other MDOT personnel. The meetings are of course open to the public. Generally the agenda consists of communications from the public, reports from various MDOT departments (including infrastructure and financial), a vessel status update, and island-specific issues. It is an opportunity for our representatives to listen to concerns from other islands, which may or may not match ours. It is also a reminder that Islesboro, Vinalhaven, and North Haven are mostly fortunate in our service. Swans and Frenchboro must share a vessel, and at each meeting there is almost always discussion on the impact on one or the other when a trip is cancelled and a trip to Swans or Frenchboro is lost as a result. Matinicus, of course, is fortunate if the ferry is able to make two trips a month.

Despite our relatively reliable and convenient service, we often are frustrated in our relations with the MDOT. Last year's Town Report from North Haven's representative to the Ferry Service Advisory Board expressed frustration at the response of the MDOT to its own decision to discontinue the time-honored tradition of crew members carrying medical samples. When the initial edict came down, its proposals for dealing with the problem of the samples were impractical and cumbersome. Finally, a more palatable compromise was reached and there is now a lockbox in the cabin where samples can be stored for the arduous, hazardous, terrorizing journey across the bay. Initially, the lockbox was outside the pilot house before common sense kicked in after test samples were degraded by temperatures.

The Frustration-of-the-Year is the posture taken by MDOT that we need a new ticketing structure. The legislature had long since determined that half of ferry service expenses, including crew and repairs to infrastructure and vessels, must be covered by user fees and half by the highway fund. (Some states with island communities provide free service to island residents, but that's another battle). In the coming biennium there is an anticipated revenue shortfall of somewhere between \$1.3 and \$1.4 million, with half of that to come from fares and other user fees. Since there has not been an increase in fares in almost ten years, the increase in fares is not unexpected. Crews have needed and deserved a raise - especially if the system was going to continue to run - and much of the fleet has passed middle age. It is the manner in which the Augusta-based MDOT officials have determined how to meet the shortfall in revenue that rankles.

When the revenue shortfall was first presented, the North Haven Select Board and residents came up with several different scenarios that would meet the anticipated revenue needs in a fair and equitable manner and presented these scenarios to the FSAB, which debated and refined them down to one, which it voted to forward to MDOT Commissioner Bernhardt. It also voted by a lesser margin to forward the competing option

favored by the MDOT participants in the FSAB discussions. Commissioner Bernhardt, perhaps overly influenced in that face-to-face meeting with one of the MDOT's own representatives to the FSAB, Rick Dubois (Director of Multimodal Operations, Bureau of Maintenance and Operations), chose to favor the MDOT's plan. That plan replaces the existing island-origin/mainland-origin ticketing system and institutes a Maine-resident/out-of-state-resident fare structure, which changes the fare equity between year-round and seasonal island residents drastically and is likely to affect service adversely at the Rockland terminal during the busy summer season. Take a moment to envision the chaos of the Fourth of July weekend. There are a myriad of scenes that make this structure indefensible. The Augusta DOT representatives to the FSAB claim that this rate system is simpler.

As of this writing, the Commissioner is still accepting testimony in the form of letters, emails, and phone calls. The first public hearing, on Vinalhaven but with North Haven participating via teleconference, has been held as of this writing. One on Swans had to be postponed due to weather. The MDOT attorney, participating in the teleconferenced hearing, did hear from the Fox Islands loud and clear and unanimously that the proposed structure would be disastrous. At this writing, we can only hope that Commissioner Bernhardt will listen to reason..

Whatever form it takes, the increase in fares is due to start on March 28.

On a positive note, it does appear for the moment that our new manager, Mark Higgins, wants to improve customer service and customer communications. We hope he can follow through.

TAX ASSESSING 2017 REPORT

The Tax Assessors' primary responsibility is to see that assessed property values are equitable and fair in order for the town's tax burden to be appropriately distributed.

During 2017 the assessors re-examined components of North Haven's cost files to check if the adjustments made during the 2016 continued to ring true. After examining and analyzing these elements, it was found that no additional changes were needed to the cost files in 2017.

The Tax Assessors continue to monitor all real estate sales transactions in an effort to keep assessed values as closely aligned with just value (sales price) as possible. The assessors examine all real estate sales transactions and compare sales price to assessed value. Each arms-length transaction sales ratio is taken into account when establishing North Haven's sales ratio for the year. No one sale reflects a trend but when there are a number of similar results, the assessors consider if and how any assessment procedures or formulas need to be adjusted. The increase in the number of North Haven sales gives the assessors more information to work with. During 2017 North Haven certified ratio was 100% which shows, on average, equity between sales prices and assessed values. The initial indications are that we will be close to the same in 2018.

Thanks go to Merton Howard and Scott Higgins for their work on the Assessors Board in 2017. Many thanks also to Assessors' Agent Tammy Brown for her continued hard work on behalf of the town of North Haven.

TOWN ADMINISTRATOR REPORT 2017

It was not until May that the North Haven Clinic was finally able again to send unaccompanied clinical specimens via ferry from the island to the mainland by means of a locked container on the ferry, the solution to a "problem" which itself had originated in the mind of an unknown officious someone almost two years earlier. The kerfuffle over the transportation of clinical specimens was spread over three calendar years, beginning sometime in 2015 and settled mid-2017. At the end we had lost a seat inside the *Burgess* but gained several TWIC cards (Transportation Worker Identification Credentials) to assure any troubled (or troubling) minds that the specimen coolers coming from the Clinic were harmless.

In April, Apex Construction began what was to have been about a six week project to renovate aging parts of the sewer plant. The town's engineering firm, Olver Associates, had identified renovations and upgrades beyond what sewer department personnel had been calling for, including improving the reliability of data the sewer department provides monthly to the Department of Environmental Protection. The town secured debt financing on favorable terms from the State Revolving Fund through the auspices of the D.E.P. and the Maine Bond Bank. The project's timetable slowed to stoppage however in early summer when a key supplier could not deliver critical components to our contractor on time. Work did not conclude until late in the season. Except for some landscaping to be completed in the spring of 2018, the construction is now complete. Arising from the project however is the sewer department's commitment to additional engineering studies in 2018 to anticipate and correct any treatment issues that might jeopardize the town's continued ability to operate a relatively simple primary treatment system. Treatment plants with the so-called 301(h) waiver under the Clean Water Act, which North Haven has, are becoming an endangered species. In impeccable operation lies our shield against the waiver's extinction. The cost to migrate to a secondary treatment plant would be extremely burdensome for department customers.

The town was able to undertake additional property maintenance in 2017. Chief among them was a top to bottom renovation of the Town House and less extensive renovations in the clinic and fitness center. We hope to hire a part time property manager in 2018 to be not only the town's ears and eyes on its property but also a pair of capable hands.

The year's dominating capital project was the reconstruction of Pulpit Harbor Bridge, in which the town had enormous interest but over which it had little responsibility. It was finished on time and with no fanfare. Although its design had excited controversy when unveiled at a public hearing in 2015, enough to delay the start of construction for a year, that same design, when construction was complete, elicited mostly positive comment. Despite the inconvenience of the round-island detour during the first half of 2017, the project caused little disruption to island life. The crews working for CPM Constructors fitted well into the year-round community. The round-island detour to the

Transfer Station for those of us who had to make it every week had a compensation we can never take for granted: the magnificence of the vistas from the North Shore Rd. across the Bay. The bridge work also created an opportunity for a previously unscheduled repaving of part of Pulpit Harbor Rd and of the W. District Rd., a project we were able to finance from accumulated Local Road Assistance funds and from the Repaving Reserve account to which tax payers contribute every year.

The demolition of the 1880's piers supporting Pulpit Harbor Bridge produced an unexpected boon in granite blocks, a large number of which were auctioned off to residents and property owners in the summer of 2017. No one expected the bridge to yield such a bonanza of granite, possibly enough to create a Vinalhaven-esque theme park on North Haven, had we been so minded. As it was, the old bridge will be memorialized throughout the island in walls, steps and garden ornaments.

We became the unplanned owners of a new snow plow in 2017 when the older of our two large plows immolated itself on Smith St. by Calderwood. One of the benefits of the accident (apart from the major one: Aaron Cabot's safe exit from the cab) was the opportunity to lease and then purchase a smaller plow which has turned out to be more nimble and efficient than the behemoth it replaced.

2018 will see the opening of the eldercare facility, Southern Harbor House, the latest in a succession of ambitious non-profit enterprises in North Haven's history. As I write early in 2018, the construction is nearing completion. When the building is complete, North Haven Sustainable Housing which oversaw the construction and most of the fund-raising, will turn the facility over to a new non-profit organization, Southern Harbor Eldercare Services, which will operate the facility. The development expense (not counting the donated property at 12 Pulpit Harbor Rd.) was \$3MM, all of it donated. At a time when in the nation and the world at large, unearned and grandiose self-praise seems on the rise, the modest instigators and frequently anonymous supporters of this project have earned thanks for their generosity and accomplishment..

As you will conclude by reading the reports of various committees and boards elsewhere in this 2017 Annual Report, there is much that the year-round and seasonal residents of North Haven have to be grateful for. I am thinking of the countless hours volunteers have contributed through those boards, committees, services and non-profit organizations to make North Haven safer, cleaner, healthier, culturally richer, more welcoming and more enjoyable.

As I prepare to retire, I want to acknowledge with thanks the support and friendship I have enjoyed over the last 11 years from and with my fellow town office employees, from and with the many members of the changing Select Boards, from and with the year-round and seasonal residents of North Haven who have bound my family and me with such strong ties to North Haven. Thank you! Against the background of a nation and a state torn by divisiveness, I continue to be heartened by how hard most residents of North Haven work for the common good and how hard they strive, remembering their own history, to keep their differences from riving their community. Thank you for that, too.

As it is the secular alpha and omega of our modern island existence, it is only right that the MSFS reappears in the last, as well as the first, paragraph of this annual

report. In 2018, the cost of ferry fares will rise across almost all fare categories to help pay for the served islands' share of the cost of operation. What remains undecided is whether the MSFS will replace the system of discounting island purchased tickets from mainland prices with a system of discounting tickets purchased by Maine residents from fares charged to non-Maine residents. Island representatives to the Ferry Service Advisory Board were able to dissuade the MSFS from moving to a system of seasonal fares which would have had a much more adverse impact on island residents than the MSFS had imagined. Abandoning the seasonal fare approach was a sign that the MSFS was actually listening to islanders' objections. Linking fare prices to state residency became an option under serious discussion only late in 2017. As I write, the other islands seem to have awoken to the negative consequences, both practical and social, of such a residency based system. It remains to be seen whether the MSFS has left enough room in its timetable and flexibility in its mindset to continue negotiating over this approach.

The North Haven Medical Clinic has for another year provided the community with expert medical care. Family nurse practitioners Sue Ferra, NP-C and Lorraine Reiser, PhD, FNP-C, work alternate weeks in the clinic which is staffed by office assistant, Alicia Brown.

Emergency Medical Technicians, volunteer first responders, provide 24 hour call out and ambulance coverage.

In addition, Patience Trainor, PT offers physical therapy on Tuesdays and psychologist Inna Bezborodko, DPsy, CAS, LCPC, is available by appointment for individual, group and family counseling.

During 2017 a lot of projects were successfully completed. The Pulpit Harbor Bridge was finished, the West District and Pulpit Harbor Rd. repaved, the Sewer Plant upgraded and other smaller projects completed.

The Select Board would like to welcome two new members: Jerry M. White and Alex Curtis. We would like to extend a great thank you to the town office staff (Janice, Joette, Tammy, Kathy and our Town Administrator, Joe Stone) for all the time and effort they put forth in making our town run efficiently.

2017 marks the last year that Jon Emerson was part of the Select Board. During our ongoing meetings, Jon, I miss your presence, experience and the thoughtful statements that you continually brought forth. We thank you for your many years of service on this Board. You have made huge contributions to our town government with your knowledge of island living.

During a Select Board meeting, Joe Stone announced to the Board that he would be retiring. Much appreciation goes out to Joe for his time, effort and faithful service as Town Administrator of North Haven. Joe Stone has been serving as the Town Administrator of North Haven since August of 2006. Joe, hope you enjoy your retirement and it has been a pleasure working with you these past two years.

The town purchased a new plow truck from Farley and Sons Landscaping to replace the old Ford that had burned up. Many thanks to the Road Commissioner Elliott Brown and crew for plowing the roads, keeping sides of the roads mowed, brush cut and pot holes filled.

To ALL our first responders and fire fighters, thank you for the work you do. You are certainly appreciated. Crew Chief April Brown graduated more new EMTs this year and Fire Chief Forrest Sprague has declared he will not be running for fire chief this year. Many thanks go out to these people for their continuous response to the call of duty.

"Swallow the Anchor" (also known as Jerry White) built the town an aluminum ramp for the Pulpit Harbor dock. In the spring, the Select Board is hoping to have pilings driven to secure the floats in Pulpit Harbor. Thanks go out to our Harbor Masters, Foy Brown and Adam Campbell.

To Glen Marquis and Rex Crockett, many thanks for keeping our water treatment plant up and running and for your continuous effort to keep the water mains and lines operable for the community.

While waiting for dumpsters to arrive and change out at the Transfer Station, Peter Cooper and crew welcomed aboard a new employee, Jason Burns. For the most part, the Transfer Station keeps on running but is busiest from June through October. I would like to acknowledge clean-up efforts by Laura MacDonald and Argyle with his little red wagon. While out walking, they are picking up bottles and cans along the roadside. We could all learn by this example to put trash and cans where they belong.

The Planning Board has put a huge effort into writing and rewriting our town land use ordinance. The Board brought forth the new ordinance for the Select Board to review. We reviewed it and made some changes and they have gone on for professional input. Pat Curtis and the Planning Board have been working tirelessly for some time on

this project. Jeff Crawford has put in a huge of amount of time writing and rewriting this ordinance. The Select Board wants to show its appreciation for this undertaking.

One of North Haven's bigger projects was an upgrade to the sewer plant. The job was successfully completed this fall by Apex Construction, with assistance from Elliott Brown, general contractor, North Island Landscape and the engineering firm, Olver Associates. Thank you to Harold Cooper, Scott Higgins and Jeff Crawford for keeping the sewer system running smoothly throughout the year.

There is no need now for the long ride to the dump anymore since we have been able to use our new Pulpit Harbor Bridge. CPM Constructors finished the Pulpit Harbor Bridge project on time.

Haggar Construction completed paving the West District and part of Pulpit Harbor Rd. They came in under budget and on time.

The Town House, located by the sewer plant, has had a complete face lift done by Abel LaBelle. It is now ready for a new Town Administrator or if unneeded by the Administrator, for new tenants.

The buzz around town or on Facebook is about ferry tickets. Joe Stone worked tirelessly on the numbers to keep tickets affordable for our community. I sent emails to the MDOT Commissioner with concerns about ticket increases and parking problems in Rockland.

When people and the other town boards interact and work together, it makes for a stronger community. Projects in North Haven for 2017 have been successfully completed from the sewer upgrade to the finishing of the Pulpit Harbor Bridge. A last shout-out to Joe Stone, Jon Emerson and Forrest Sprague for their impeccable service to our community. North Haven is a true gem from its gorgeous sunrises and sunsets to the people that make up this community. The Select Board is here to serve the citizens of the Town of North Haven.

FIRE DEPARTMENT REPORT 2017

The Department responded to 13 emergency calls during 2017. Incidents included: 3 medical assists requiring Life Flight LZ set-up, 2 vehicle accidents and a heavy equipment accident requiring traffic control, 3 powerlines calls, 1 tree across the road requiring clean-up and 3 false alarms.

In January & February Capt. Higgins conducted MBLS annually required refresher training for all volunteers for Hazmat and Bloodborne Pathogen Awareness and Fire Extinguisher operation. In February NHFD SCBA-team members reviewed the written Respiratory Protection Plan and received facemask fit-testing using the OSHA-approved Bitrex Qualitative Test Kit & Protocol.

Fall activities included chimney cleaning services and a trip to the school during Fire Prevention week. Required annual pump testing and SCBA maintenance were completed on island.

The Department welcomes 2 new members. Thank you Alex Curtis and Sam Hallowell.

After serving 46 years on the FD and 26 as Chief, I've decided to take my leave. During my tenure all trucks, equipment and gear have been replaced and updated. I feel confident that I'm leaving the department in good shape and wish my successor well.

EMERGENCY MEDICAL SERVICES – 2017 REPORT

North Haven EMS provides emergency medical care for the island on a twenty-four hour a day, seven day a week, 365 day a year basis. Vehicle Operators, Emergency Medical Responders, Emergency Medical Technicians and Advanced Emergency Medical Technicians staff our crew. The crew is an all-volunteer organization. We typically staff the ambulance with a squad of three responders. In addition to the three responders, our Family Nurse Practitioners, Sue Ferra, Lorraine Reiser, (who staff the clinic in a bi-weekly rotation) also respond to EMS calls. North Haven EMS is currently licensed through the state of Maine at the EMT-Basic level, and is permitted to the Advanced-EMT level.

During 2017, North Haven EMS responded to fifty-four incidents. Many of the calls we responded to in 2017 were related to cardiac illness, cerebrovascular accidents, medical based incidents, and trauma related incidents. We also respond each time the fire department is toned out for "fire department assist". We often request North Haven Fire Department for an "EMS assist". They have often assisted us with lifting patients and also setting up a landing zone for LifeFlight. Both crews work in conjunction with one another seamlessly. We could not run as smoothly without their support. Thank you, North Haven Fire Department.

Living in a remote environment can make transporting a patient(s) logistically challenging. It is not unusual for transports to take an hour or more. That being said, each call typically involves responses from a series of agencies. The flow of each call is in essence the same: we respond to the scene, assess the patient(s), treat the patient(s), make a transport decision, and transport if necessary. We transport using Penobscot Island Air, the ferry, private boat, the Coast Guard and with critical patients, we call LifeFlight. In each transport, the patient is accompanied by at least one EMT. Based on a collaborative conversation with responders, the leading crewmember makes a transport decision. We consider the patient's condition and environmental factors when evaluating our evacuation options.

The weather plays a crucial role in our decision regarding how we transport. If the weather is favorable, for stable patients we typically transport via Penobscot Island Air to Knox County Regional Airport in Owl's Head. Prior to transport from North Haven, we communicate with either South Thomaston or Rockland EMS and have them standing by at the airport to receive the patient from us. Patients are transferred from our care to the responding agency, and transported to Pen Bay Medical Center for further evaluation and treatment. For critical cases, or patients who require expedited evacuation, we call LifeFlight. LifeFlight is based out of Bangor and Lewiston. LifeFlight crews can deliver advanced medical care while en route to a regional trauma or burn center (Lewiston, Portland, or Bangor). If the weather does not permit us to travel by air, (rain, snow, fog and wind), we transport in our ambulance via the ferry to Pen Bay Medical Center via the *Captain Neal Burgess*. When traveling by ferry, the duration of the call from start to finish takes approximately three hours.

It takes a coordinated response from a number of individuals to successfully evacuate individuals in need of definitive care from North Haven. Some of these people

include, but are not limited to: Knox County Regional Dispatch, the North Haven Fire Department, the staff at Penobscot Island Air, ferry Captains as well as the entire crew of the *Captain Neal Burgess*, the staff at LifeLight of Maine and the personnel that receive us at Pen Bay. Each person and service plays a crucial role in the success of each transport.

We are so pleased to welcome six newly licensed and ambitious EMT's. Erin Cooper, Roman Cooper, Nikole Seeger, Mike Seeger, Jessie Hallowell and Jamien Shields have joined the us as licensed crew members. They have already demonstrated their determination, knowledge and enthusiasm through participation in meetings, trainings and on scene. They are compassionate providers who have ensured that we will remain a strong and robust service. Thanks go to all of them for taking the class which exceeds 120 hours with clinical time, and for volunteering with our service. It does not matter what the hour is, what the weather is, what we're doing, when pagers go off, we respond.

We continue to train as often as we can with our neighboring island, Vinalhaven. We recognize the importance of fostering this relationship with Vinalhaven EMS and fire, as they are our closest support if an event necessitates a mutual aid response. Similarly, we are theirs, and would without hesitation support them should they need our resources.

New crewmembers are always welcome in whatever capacity one can serve, whether it is as drivers, as Emergency Medical Responders, or as EMT's. Contact me, or any of the crew on our roster if you are interested in joining our team.

Thank you to the community of North Haven for supporting our team in all of the ways that you do.
