4. Audit Reports Fiscal Year 2022-2023 presented by Louis Breedlove from BrooksWatson & Co.
5. Panorama Golf Club January report presented by Doug McEntire.
6. Planning & Zoning presented by Gary Hollingsworth. There were 3 plumbing, 2 deck, 1 electrical, 2 roof, 3 generator, 2 foundation, 1 HVAC, and 1 fence permit for a total of 15 permits in January.
7. Police Department January report presented by Tray Hudgins. There were 96 calls for service, 0 arrests, 7 extra patrols, and 2337 patrol miles driven. New patrol officer Laci Seaton introduced.
 - a. Criminal Justice Grant Application Resolutions – Motion to approve Resolution 2025-571 for Grant Number 5423801 made by Ted Nichols, seconded by Royce Engler. Motion voted and carried unanimously. Motion to approve Resolution 2025-572 for Grant Number 5423101 made by Ted Nichols, seconded by Royce Engler. Motion voted and carried unanimously.
 - b. Racial Profiling Report 2024 presented to Council. Motion to accept made by Royce Engler, seconded by Joe Watson. Motion voted and carried unanimously.
8. Public Works reports presented by Ted Nichols. Catahoula Well # 4 pumped 7,487,000 gallons and there was 6.30 inches of rainfall in January.
9. Code Enforcement report presented by Ted Nichols. There were 1 stop work order, 1 Planning & Zoning, 3 recreation vehicle, 6 parking, 4 rubbish, and 2 trash violations for a total of 17 violations in January. 1 violation has been sent to Municipal Court.
10. Parks & Recreation October update presented by Doug McEntire. Mayor Scott has appoint Joan Jackson to the Parks & Recreation Advisory Board.
11. Engineering Report presented by Travis Walker from Bleyl Engineering.
 - a. MS4 Permit Renewal – The permit was submitted by the February 11th deadline. Additional reporting will be required throughout the year. Bleyl will coordinate with the City as needed to maintain permitting compliance.
 - b. Big Bear Retail Center – Coordination on the recently submitted plan review is ongoing with the Big Bear Team. The developer's agreement to be discussed later in the meeting.
 - c. Woodlands Hills drainage – LJA provided and updated submittal in September. It has been reviewed. Two previous comments have not been addressed. One regarding calculations and another regarding the maintenance agreement. LJA stated that the Attorney for Howard Hughes was reaching out to Mr. Schneider. Mr. Schneider reached out to the Developer in November. Bleyl received revised plans on January 16th for review and is coordinating with LJA, the Developer's Engineer.
 - d. Drainage Swale for Hanover Lane – Discussions have occurred with the Attorney and City regarding various options. An upstream portion of the drainage ditch was improved previously and as potentially paid for by the City. Documentation of the City's participation in the work has not been found to date.
