The school, Peaine Township, Health Center would be an option. Tammy and Will have been in communication. Tammy will reach out to the Health Department. Lisa Peacock. Next week to the island. ## 5. Reports

- a. Fire Department: McDonough. The new 800 radios have been installed. They have been tested today with first responders. They will be up and running next month. A vast difference in ability to communicate. Much improved. Use of cell towers and public radio towers.
- b. EMS: Director's Report: Cody Randall. County has paid for all the equipment with mileage money. Everything has been replaced in the trucks. State Police requires training of all individual. Going live in January 2021. Average runs 4 people went to Munson, 1 to McLearn and 1 to the health center. 5 refusals. Billables Total is \$95, 000 which is down by \$20,000. Medical leaves due to COVID. The gaps have been covered. Brian ankle

issue and may be available in January. Zero part time medics. Leave request on the website for interested parties. There is discussions about a County wide EMS authority. Some push back from some entities. Looking at feasibility study. 5 systems now running in the county. They have been tasked to consider the options to alleviate duplication of service. Low ball private company to manage. Charlevoix, East Jordan, Boyne City/Falls retiring EMS directors are all in favor of doing this. 18 jurisdictions.
