You have just received a traffic citation and may be wondering about your options. The information enclosed within this Bond Envelope will explain your options. **Please read all sections in this document thoroughly.**

Be sure to read all parts of your traffic citation. It is very important that you know that you must respond to the court on or before the "Notice To Appear" date shown on the front of your citation. *Failure to do so may result in a warrant being issued for your arrest and/or suspension of your driver's license and/or other penalties.*

The following options are available to you (detailed information is included within this bond card):

**OPTION 1**

If you are eligible, you may attend a Defensive Driving School. No court appearance is required. You will be required to provide a copy of your traffic citation, driver's license, and full payment before you begin the class. Further instructions for registering for a Defensive Driving class are located on page 4.

**RED LIGHT ADVISORY PURSUANT TO  
 A.R.S. § 28-645 & 28-647:**

If you are eligible you may attend Defensive Driving School or, if not eligible or if you choose NOT to attend Defensive Driving School and you are found responsible or plead responsible to this violation, you must attend and successfully complete Traffic Survival School training and education sessions. If you are required to attend Traffic Survival School you will receive a notice from the Arizona Motor Vehicle Division (MVD).

**OPTION 2**

You may request a trial/hearing by mail. You will be notified by mail of your assigned trial/hearing date. You must appear on that date and be ready to present evidence and examine witnesses. If you need reasonable accommodations pursuant to the Americans with Disabilities Act (ADA) please call the GVC Municipal Court at the number listed above.

**OPTION 3**

If your citation is Civil traffic, you may pay the fine and be done. No court appearance is required. You can pay with debit/credit card by going to [azcourtpay.com](http://azcourtpay.com)  
 Exception: All Criminal Violations must appear in Court, including Criminal Traffic Violations.

**To pay your fine:**

- To pay by mail, make Cashier's Check or Money Order payable to: **GVC MUNICIPAL COURT (NO PERSONAL CHECKS ACCEPTED) –OR–** To pay with credit/debit, call 1-855-436-6820 or go to [townofthatcherpayments.com](http://townofthatcherpayments.com) or [azcourtpay.com](http://azcourtpay.com)
- Include the citation number located on upper left corner of citation.
- No partial payment accepted on fines without permission.

**\*\*If you are under the age of 18, you must appear before the Judge with a parent or guardian.**

**DRIVING ON A SUSPENDEND LICENSE:**

If you are charged with 28-3482A due to unpaid fines, you may want to consider getting your license reinstated. Reinstatement of your driver's license can significantly affect the outcome of your case. The fine may be reduced or the charge dismissed with proof of reinstated license.

**BOND SCHEDULE (CONTINUED)**

**DRIVING WITHOUT INSURANCE:**

A.R.S. § 28-4135A, 28-4135B, or 28-4135C:

For a first offense .....	\$965.00
For a second offense.....	\$1,425.00
For a third offense.....	\$1,885.00
(If you provide proof of current insurance with a six-month policy AND a copy of your 36-month driving record, the fine may be reduced to \$142.00 and the mandatory suspension of your license could be waived.)	

**THESE AMOUNTS INCLUDE ALL SURCHARGES.**

**IMPORTANT:**

If you fail to appear or fail to pay a Civil Traffic Sanction on or before the court date, a time payment fee of \$20.00 will be assessed and a default judgment will be entered against you.

**FINES PAID AFTER YOUR COURT DATE MUST INCLUDE A \$20.00 TIME PAYMENT FEE (per A.R.S. § 12-116.)**

**Failure to appear will result in forfeiture of your bond, additional monetary penalties, suspension of your driving privileges and/or issuance of a warrant for your arrest.**

**Your Driver's license may remain suspended until the civil sanction is paid to the Court and you have your license reinstated by MVD. You may be arrested and incarcerated for a suspended license.**

**FOR ALL OTHER VIOLATIONS NOT LISTED HERE, DEFENDANT MUST CONTACT COURT. NO WEAPONS PERMITTED IN THE COURTHOUSE.**

**If you are required to pay fines, penalties, fees or other financial obligations as a result of a judgement of this court and you are unable to pay, bring this information to the attention of court staff or the judge because payments over time or other alternatives may be available. Do not ignore your responsibility to pay, as this may result in additional penalties and costs to you. **OPTION 1**

**DEFENSIVE DRIVING PROGRAMS**

Defensive Driving classes are available for persons who receive a citation for certain minor traffic violations.

**ADVANTAGES:**

1. You will not need to go to court.
2. Your violation will be dismissed.
3. There will be no fine.
4. You will receive no points on your driving record.

**AM I ELIGIBLE?**

You may be eligible for the program if:

1. You have not attended Defensive Driving class within the last 12 months (violation date to violation date).
2. You have a valid driver's license or valid I.D. If you have a CDL and were driving a non-commercial vehicle, you may be eligible to take a Defensive Driving course.
3. You must contact a Defensive Driving School to verify that your violation is eligible.
4. Your citation did not result from an accident involving death or a serious injury.
5. Yours was not a major traffic citation.
6. Your citation has not already been set for a hearing or trial.

**IF YOU ARE ELIGIBLE AND WISH TO ATTEND, DO THE FOLLOWING:**

1. You must notify the Court prior to the appearance date on the citation of your intention to attend the school.
2. Contact a Defensive Driving school within the first week of receiving the citation:

3. Register for a Defensive Driving School course.
4. Attend and satisfactorily complete the class at least **SEVEN DAYS** before the Court appearance date that is listed on your citation OR 7 days prior to your extension date if you received a new date from the Court.
5. You must submit a copy of your citation to the Defensive Driving School. If you have lost your citation, you may request a copy from the Court.

**OUT OF STATE RESIDENTS**

Out-of-State Residents must contact National Traffic Safety Institute at the phone number listed above to coordinate the Out-of-State attendance.

**OPTION 2  
REQUEST A TRIAL HEARING BY MAIL**

**1. READ AND SIGN THE FOLLOWING STATEMENT:**

"I request a trial/hearing to contest the charge(s) indicated below. I enter my plea of not guilty/responsible. I understand I am giving up my option of attending a Defensive Driving Program. I understand I may voluntarily enclose a bond (cashier's check or money order) equal to the fine/sanction, which will be forfeited should I fail to appear for my hearing/trial. I further understand that the bond/forfeiture will relieve me of the possibility of the court assessing additional monetary sanctions, issuing a suspension of my Driver's license, or a warrant for my arrest should I fail to appear for trial/hearing."

6. **MAIL** the envelope at least 5 working days before your court date. You will be notified by mail of a trial hearing date.

7. **CHECK ONE:**  I will be represented by a lawyer.

**IMPORTANT:**

If you don't receive a court date within 10 days after mailing in a request for a trial/hearing, call the Court.

You must appear on the date assigned and be prepared to present evidence and/or examine witnesses before the Judge.
