TRASH SPECIAL ASSESSMENT: Motion by Renee Herhold, second by Susan Neuenfeldt, to assess \$165.00 per residential household for weekly trash collection service and bi-weekly recycling in 2022 on the 2021 winter tax roll. Roll call vote Herhold, yes; Neuenfeldt, yes; Earley, yes; Frederick, yes. (4) Yeas, (0) Nays, (1) Absent. Motion carried.

SALARY COMPENSATION COMMITTEE RESIGNATION: Motion by Susan Neuenfeldt, second by David Earley, to accept the resignation of Patrick Dorr from the Salary Compensation Committee, effective October 12th, 2021, thanking Pat for his years of service on the Committee. Unanimous voice vote. Motion carried.

SALARY COMPENSATION COMMITTEE APPOINTMENT: Motion by Susan Neuenfeldt, second by David Earley, to appoint Martin Neuenfeldt to fill the vacancy on the Salary Compensation Committee, term expiring in January 2025. PARK BOARD RESIGNATION: Motion by Susan Neuenfeldt, second by David Earley, to accept the resignation of Matthew Lockwood from the Park Board, thanking Matt for his years of service on the Board. Roll call vote Earley, yes; Frederick, yes; Herhold, yes; Neuenfeldt, yes. (4) Yeas, (0) Nays, (1) Absent. Motion carried.

PARK BOARD APPOINTMENT: Motion by Renee Herhold, second by Susan Neuenfeldt, to allow Manager Reno to advertise the vacancy on the Richland Township Park Board due to the resignation of Matthew Lockwood. Roll call vote Frederick, yes; Herhold, yes; Neuenfeldt, yes; Earley, yes. (4) Yeas, (0) Nays, (1) Absent. Motion carried.

PARK MILLAGE/IMPROVEMENT MILLAGE: Motion by Susan Neuenfeldt, second by Renee Herhold, to place the park millage renewal on the August Primary Election ballot seeking 1 mill for a period of ten years, December 2022 through December 2032, for the purpose of maintenance and operating costs for the Richland Township Park. Discussion held.

Motion by Susan Neuenfeldt, second by Renee Herhold, to amend the motion on the floor. Roll call vote Herhold, yes; Neuenfeldt, yes; Earley, yes; Frederick, yes. (4) Yeas, (0) Nays, (1) Absent. Motion carried.

Motion by Susan Neuenfeldt, second by Renee Herhold, as requested by the Park Board, to place a park millage renewal proposal on the August Primary Election ballot seeking 1 mill for a period of ten years, December 2022 through December 2032, for the purpose of maintenance and operating costs for the Richland Township Park; also, placing a park improvement millage proposal on the August Primary Election ballot seeking 0.25 mill for a period of ten years, December 2022 through December 2032, for the purpose of maintaining, purchasing equipment and property, improving parks and recreational programs, sites, and facilities within the Township. Roll call vote Neuenfeldt, yes; Earley, yes; Frederick, yes; Herhold, yes. (4) Yeas, (0) Nays, (1) Absent. Motion carried.

COMMUNICATIONS: Motion by Susan Neuenfeldt, second by David Earley, to receive and file communications. Unanimous vote. Motion carried.

The Board of Trustees consents to the proposed location in the park, between ball diamonds one and two, for construction of a 50' x 100' building, to be funded by the Hemlock Youth Little League.

PUBLIC COMMENT: Comments/questions were received and answered regarding the solar farm and wind farm ordinances, unlicensed vehicle ordinance.
