**ORDINANCE O-A-221, REZONING A-1, AGRICULTURAL TO M-1, INDUSTRIAL:** Motion by Brian Beckrow, second by David Earley, to adopt Ordinance O-A-221 rezoning five parcels of land (parcel numbers 22-12-24-1001-000, 22-12-2-24-1002-000, 22-12-2-1004-001, 22-12-2-1004-002, 22-12-2-1004-003) totaling 80.01 acres from A-1, Agricultural - Farmland Preservation to M-1, Industrial, commonly known as 1885 North Orr Road and to amend the zoning map, Chapter 3, Section 302 of the Zoning Ordinance, effective immediately upon publication. Roll call vote Earley, yes; Beckrow, yes; Herhold, yes; Frederick, yes. (4) Yeas, (0) Nays, (1) Absent. Motion carried.

**RESOLUTION R-2023-11, ESTABLISH EARLY VOTE CENTER:** Motion by Renee Herhold, second by Brian Beckrow, to adopt Resolution R-2023-11, pursuant to Michigan Constitution, Section 4 and Public Act 81, establishing the Saginaw County Vote Center as an early voting site for all elections held within Richland Township, authorizing Clerk Herhold to sign on behalf of Richland Township.
