
**Motion** by Mr. Summers to enter Executive Session on personnel. Second by Ms. Pfeifer at 7:45. Carried 4-0.


**Motion** by Mr. Lahue to reenter regular session. Second by Mr. Summers at 8:05. Motion carried 4-0.

**Motion** by Mr. Summers to adjourn the meeting at 8:06pm. Second by Ms. Pfeifer. Motion carried 4-0.


