Motion by Mr. Summers to approve Civil Service testing. Second by Mr. LaHue. Motion carried 5-0.

Mr. Tuccinard would like to get quotes on the grass cutting and the tree that needs cut down.

Motion by Mr. Summers to approve payment of bills in the amount of \$32,624.93 from the Liquid Fuels Account and \$ 21,480.27 from the General Fund as reviewed by Township Board of Commissioners. Second by LaHue. Motion carried 5-0.

Remarks of Officials:

Mr. LaHue knows that there was resistance when he presented the Early Intervention Program to keep us out of Act 47, but we have been awarded a \$99,000.00 grant. Mr. LaHue would like to send a letter to the PA Legislators and Governor to let them know what a blessing this program is and ask that they not cut funding for this. Mr. Tuccinard would like to wait until we receive the funds.
