**RESOLUTION AUTHORIZING CHANGE ORDER #1 TO
ARAWAK PAVING CO., INC. RELATED TO THE
2023 ROAD AND DRAINAGE IMPROVEMENT PROJECT**

WHEREAS, by Resolution 2023R-87, the Shamong Township Committee awarded a Contract to Arawak Paving Co., Inc. for the 2023 Road and Drainage Improvement Project in the amount of \$1,167,600.00; and

WHEREAS, the contract required adjustment to reflect actual, completed, construction quantities and inclusion of supplemental construction items; and

WHEREAS, the change order results in an addition of \$97,069.05 and increases the contract amount to \$1,264,669.05 from \$1,167,600.00, an overall 8.31% increase, and is permitted under the Local Public Contracts Law, and the Regulations promulgated pursuant thereto, and the Township Committee deems it appropriate to authorize this Change Order, subject to and contingent upon compliance with the conditions set forth below,

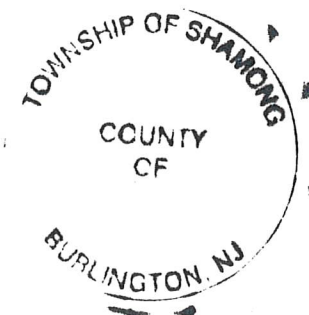
NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Shamong, County of Burlington, State of New Jersey that Change Order #1, submitted by Arawak Paving Co., Inc. and reviewed and recommended by the Township Engineer, is approved in the amount of \$97,069.05 to be added to the contract, resulting in an adjusted contract amount of \$1,264,669.05; and

BE IT FURTHER RESOLVED that nothing herein contained shall be deemed a waiver by the Township of any claims it currently possesses, or may possess in the future, regarding this Contract, the existing insurance policy, Performance and Payment Bond, and any other rights, privileges or remedies otherwise available to it.
