Issue: Proposal to change the name of Squaw Island

Dear Supervisor McNamara:

As you may know, the U.S. Board on Geographic Names (BGN) is responsible by law for standardizing geographic names for use by the departments and agencies of the Federal Government. The BGN has received a proposal from the current owners of <u>Squaw Island</u> in St. James Township to change the name of the island to <u>Eagle Island</u>.

Because local opinion is important to the BGN, we would like the opinion of the St. James Township Board of Trustees concerning this issue. We ask that you please share this request with any offices or others who might have an interest in this proposal.

The current landowners report that they were asked by local tribes to change the name of Squaw Island because the word "squaw" is considered offensive. The landowners agreed to proposed the name Eagle Island as a replacement. The landowners plan to operate the Squaw Island Lighthouse as a tourist attraction and do not want to change its historic name. The BGN does not have purview over the names of structures, and no proposed change to the name of the lighthouse is being considered. The Little Traverse Bay Bands of Odawa Indians reports that it has no objection to the name <u>Eagle Island</u>.

This proposal is listed on the BGN's Review List #431, posted at http://geonames.usgs.gov/domestic/quarterly_list.htm. The case summary is attached for your review and convenience. Also attached are the original proposal, a map of the island, and a Geographic Name Proposal Recommendation form to facilitate a response from your office. Also attached is a copy of the response to the proponent from the Little Traverse Bay Bands of Odawa Indians. Once we receive your response, we will ask the Michigan State Names Authority (copied on this email) for their recommendation.


