Chambers Minutes of January 24, 2019

CALL TO ORDER: Mayor Alvarez-Roa called the Special Council meeting of Thursday, January 24, 2019 to order at 9:00 am.

MEETING AGENDA APPROVAL:

EXECUTIVE SESSION:

- a. Discussion with legal counsel regarding pending litigation pursuant to RCW 42.30.110(1)(i) with potential action to follow.

NEW BUSINESS:

- a. Councilperson Irasema Gonzalez- Cantu moved to authorize the City's legal counsel to submit an offer of judgement in the matter of Aguirre vs. City of Wapato in the amount of \$20,000. Councilperson Barbara Perez seconded the motion. Motion carried unanimously.

ADMIN. REPORTS:

- a. Public Works Jeff Schumacker reported that he has ordered flower pots for downtown, the pool is nearly completed.
- b. Public Safety Sgt. Deccio stated that we have hired new police officers and out two new police cars are being fitted with lights and cages.
- c. City Administrator Juan Orozco stated that when outsiders sue our City the entire community ends up suffering. When 5 or 6 people take from the City Tax payers things like lowering utility taxes or purchasing a slide for the pool may not be an option because the settlement payout has to come from somewhere.

- b. Doug Milne – Expressed his dissatisfaction of not getting his property inspected. Mayor recommended that he go to City Hall to resolve his issue and he responded by saying he wasn’t going to.
