Some other projects are ongoing as well. You may notice some activity happening around the Blake Hill Bridge. Engineering work is being completed so we can put out an RFP to make the necessary improvements to the bridge. We are hoping to move this project along quickly so it can be included in the next budget.

The budget and ordinance review committees are meeting often to prepare for the town report and town warrant. We thank these groups for their efforts and community service! We are also thankful for each of you in town who help serve the community by sitting on committees, dropping off food to a neighbor who needs a hand, organizing fun public gatherings, and much more. It is all of these efforts together that add up and help make Mount Vernon a great place to live.

#### Broadband Committee—APRIL 2022

Your Mt Vernon Broadband committee has received proposals from four internet service providers (ISPs) and is organizing public meetings to review them with you. We need your feedback to guide the efforts we take in the weeks ahead. A summary of the town's core concerns is available on <u>the broadband website</u> linked to <u>the town website</u>.

<u>The first meeting</u> will be held on Zoom at 7 pm Monday April 4. A link to join this meeting will be posted on the broadband website and distributed via email to those homes that have given us permission to contact them. They will also be posted around town. <u>A second meeting</u> will be held in person at the Mt Vernon Community Center at 11:00 am Saturday morning April 9 shortly after the first Saturday Breakfast of the 2022 season. We also expect to provide Zoom and Channel 7 taped coverage of the meeting for those who cannot attend.

The fourth option is to defer action if none of the four proposals is acceptable to the town. At the meetings, we will discuss the benefits and costs of the proposals, ownership options, and subscription fees. We will discuss ways to meet the town matching fund obligations for grant applications by using bond financing, subscriber fees or property taxes or a combination. No decision on an option will be made except after authorization of the voters of Mt Vernon.

In a nutshell, here is what the town will be considering:

**Option 1:** Fiber to the Premises. We have proposals from three Internet Service Providers to hook up fiber optic wire to your premises. Proposals from Axiom and Matrix would involve building a new fiber network for the entire town and one from Spectrum would extend a fiber network to those locations that currently do not have access to Spectrum cable.

**Option 2:** Fixed Wireless. A local company out of Rockland Maine (RedZone) has provided a proposal to affix transmitters to cell towers and repeaters to send a wireless signal that would reach Mt Vernon residents.

**Options 3:** A third option, proposed by Spectrum, would cover the entire town with a combination of cable-fiber hybrid (existing cabled locations) and fiber (currently uncabled locations) by changing the subscription relationship so that the town leases the entire network from Spectrum at a fixed charge per month.

**Option 4:** Defer Action: Town voters may choose not to endorse any of these proposals.

We plan 90-minute meetings with one half the time allowed for questions. Email or online surveys will be sent out to get an updated sense of the community' preferences. Questions can be sent to the committee using the website or email <a href="mailto:mtvbrdbnd@gmail.com">mtvbrdbnd@gmail.com</a>

• SB Meeting was Called to Order by SB Crockett at 7:00pm

#### Meeting Minutes of 02-14-2022

Motion by SB Grenier to accept the meeting minutes from 02-14-22, 2nd by SB Crockett. Motion Carried. Vote was 3-0.

#### **Broadband Committee Review of Proposals:**

- **National Digital Equity Center** Susan Corbitt's proposal provides digital inclusion, equity, affordability (don't leave anyone behind) and training. You want to make sure as many people as possible are included.
  - There is a one-time fee of \$2500 to start. It is common to find grant funding sources for this type of application. Included Digital equity act. Sue was unsure of what this means for Maine. Also private philanthropy, John T Gorman may be able to fund. Sue will provide funding sources. Also works with department of education to get broadband in the hands of households that need devices or hot spots. Make sure that everyone has access to the internet. Have recently worked with the Town of Searsport. Gave them a blueprint on how it could work. Affordability Program if they meet the qualification. This town is a great example. \$30 discount for families that qualify for reduced funding. ACB program, provided a \$50 subsidy.
  - If they were qualified under the EBB program, they qualified for the ACB program. This may not be enough, this has to be looked at.
  - Bill Rosenberg asked for a vote on digital equity. Paul wants to hold off until the end of the meeting. We need to focus on 1) technical and financial. 2) helping get grant funding. Need to evaluate proposals and grants funding.
- Mission Broadband Inc John Dougherty said that Broadband intent is to help solve broadband across the United States
  with a Return on investment and Match up Private and Public Funding. We need to Start with a survey to understand where
  the community is at with regards to Availability, Affordable, Training, Design, Pricing, Technology today and moving forward.
  - RFP needs to bring the community and the Select Board with you. It will come to some kind of vote. Community effort, doable, public or private. Where do you want to be moving forward, thru the years. He proposes to Represent the town as an Adjunct Staff.
  - SB Crockett: Some towns invest or own the fiber. Some Towns not. What do you see with other towns. Can't imagine a lot of town want to have a municipally owned network.
  - John Daugherty: One of the challenges is when you get into Bonds, you have to have an asset, which would be one of the poles. You can give that money to a service provider if you don't want to own.
  - SB Crockett: Could we own the fiber on the pole and get a different company to provide service? Can you have multiple providers?

## Mount Vernon Select Board Meeting Minutes of 02-28-22 (Cont.)

- John Daugherty: You really don't want a lot of different people with their hands in it. Currently working on broadband in China.
- SB Crockett: what is your expertise with grant funding.
- John Daugherty: Connect Maine doesn't have enough money. 100 million plus coming from treasury and 100 million plus coming from infrastructure.
- Sue Corbitt: Connect Maine Authority has spent last few years updating, working hand in hand with Maine Connectivity and authorized \$15 million.
- SB Crockett: Mount Vernon has 30% (unserved) whereas Vienna has 100% unserved. Concern that the 0% will get all the grant money.
- John Daugherty: ARP less concerned with money already spent. Concerned with the underserved.
- Bill Rosenberg: DSL is not necessarily qualified as being served by broadband.
- SB Crockett: the sooner we put in the better the chance?
- John Daugherty: Not necessarily. This round is 15 mil and they will probably get 50 mil in requests. Speed test is very important and should be pushed.
- Bill Rosenberg: KP5 Key performance indicators. The whole town is involved in buying internet.
- KPI's:
  - Customer Service How quickly is the call answered, resolution, trouble, installation, maintenance, repair.
  - SLA Service Level: Uptime of equipment, what happens when power is out, how many upstreams are coming out of the office.
- SB Crockett: Not going to immediately vote on these.
- Bill Rosenberg: according to his spreadsheet, the Select Board has approved funding with \$3500 leftover. We could pay the Digital engagement.
- SB Grenier: how much for mission?
- Bill Rosenberg: 14-15K for Mission to get us started.
- John Daugherty: will approve every effort.
- SB Grenier: ARPA funds are not specific, they are guidelines. Previously they were to be used for purposed for which they were funded. We can used them for whatever our need is. The legislative body must tell us how to spend these funds. The Towns people should have a say in this. BB, Bridge, Owl? The auditor will want to know how this money is spent. Bob has consulted with Garrett Corbin at MMA.
- Bill Rosenberg: The warrant that was approved at the last town meeting was not enough to cover this expenditure?

The current Covid Omicron variant surge does seem to be in our rearview mirror now. Maine has just gone under 100 hospitalized patients daily for the last 3 days; but before you throw your masks to the wind and forget about distancing, let me offer some advice. Here are two cautions you might consider.

**First**, we need to watch out that the current disease incidence and resulting hospitalizations improvements in Maine are going to stay down. They probably will, at least from the current variant. But European countries are documenting a new variant, Omicron A2, this past month, which is increasingly prevalent there. It has been documented in the US, but none so far found in Maine, according to CDC director, Dr. Shaw. However, it is likely that it is present, or will be soon. European reports suggest that it is more infectious than the original, the delta, as well as the first Omicron variants. On the good side, our 3 available vaccine types, especially the Moderna and Pfizer 2-shot, RNA types, as well as natural infections caused by earlier variants appear quite effective in preventing symptomatic disease, including that which requires hospitalization and ICU care. That's all good, especially since Maine has one of the highest immunization rates, 77% if you include children under 5 who can't yet be immunized, and nearly 80% if you don't. That is potentially a lot of community immunity, but it clearly isn't enough, since we still have continued community spreading. Dr. Anthony Fauci agrees that this surge is subsiding but predicts the US will see smaller "up-ticks" in the next 6 months, "not big enough to call surges". Hopeful thinking, I'd guess.

Should this variant or others suddenly "uptick" cases, we should be ready to go back to masking, distancing, avoiding indoor crowds, and other precautions, at least for those over 65 and/or those with so-called "co-morbidities". The latter means that such people are on medicines or have diseases that further increase the likelihood of catching covid infection and more likely to have serious disease, require hospitalization, need ICU care, or suffer death, especially if they are not vaccinated. Even if they are fully vaccinated, those risks are still there, although reduced from 20-25% to 6%. Not good if you are on the bad side of those numbers.

When should you "go back" to more precautions? I'd suggest doing so if current hospitalizations double; currently we are at fewer than 100 Covid patients daily in Maine hospitals for several days running. That's what Neighbors Driving Neighbors has decided to do as that volunteer ride service gradually goes back to business as usual in early April, rather than just medical or delivery rides. You can follow hospitalizations by reading the newspapers daily, or here's a URL where you can see graphs like the one below to monitor those numbers yourself on-line: https://www.maine.gov/dhhs/mecdc/infectious-disease/epi/airborne/coronavirus/data.shtml and choose the "hospitalizations" tab on that first page.



## COVID19's Next Tricks? (Cont.)

**Secondly**, be aware that managing Covid is now mostly a do-it-yourself project; if you are exposed and/or have caught it, or are caring for someone who has, you need to know how to manage things yourself, because your case, like many, may be detected by home tests and never reported to the state. There are too many cases to follow AND the new variants have such short incubation periods (2-3 days), there often isn't time for state workers or even your medical clinicians to help you with isolation advice, contact tracing, and triggers of when to seek treatment with antibiotics. Be sure to have a good supply of home tests on hand, masks (KN95s, or N95s) for you and your contacts, a good thermometer, and a home oxygen saturation monitor (less than \$35 in most drug stores) to detect saturations in the low 90%s, or worse, high 80%s. Low saturations like that tell you that it is time to bail to the hospital ER, ASAP. Here is where you sign up to get a helpful weekly flier from the Federal CDC; it can help you navigate the decisions you'll need to make. Sign up for it now. Hopefully you won't need it.

That all said, I'd urge high risk individuals over age 65-70 and/or with impaired immune systems, vaccinated or unvaccinated, to still mask and distance as best they can, especially indoors, to increase their protection.
