### From the Select Board

There are a couple of bills before the legislature that will affect our citizens. One will change the property tax stability that is in effect now. Currently anyone who is 65 or older and has 10 years of homestead exemption can apply to have their taxes bill frozen at the current rate. The homestead exemption is about \$23,000 in savings on your evaluation. The new bill would remove the freeze on taxes and raise the homestead exemption to \$40,000 to 50,000, depending on your income. Let's wait and see what happens.

Metal gates in front of the metal and bulky waste bins at the transfer station have been installed and seem to be working to keep the area safer. The chains were not enough protection from falling into the bins, and were an accident waiting to happen.

At the last town meeting we tried to raise money to look at the condition of all our roads and develop a plan and schedule to fix them. This did not pass. Recent storms have caused a great deal of damage to our already fragile roads. The Christmas storm is a good example, which cost about \$20,000 to repair them. Fortunately, we did not get another snowstorm while we were fixing the many washed out and almost impassable roads. I don't know how we would have handled that.

We had a request from a citizen that we refrain from mowing town lots and cemeteries during the month of May, so that the beneficial insects can feed on the flowers. We decided against this, and suggested that maybe the citizens of the town may wish to do a "no mow May" project. We encourage volunteers to plant flower gardens at the Town Office and memorial lot.

The transfer station does not accept LP gas tanks. Tim's RV in Chelsea will take them for free if you drop them off. Check with Megan for Tim's RV phone number and address.

We are looking at raising some fees at the transfer station on items which cost the town more to get rid of than normal trash. These include items such as demolition debris, bulky waste, and electronics. Roads have been posted, a sure sign that spring is on the way. Let's hope our roads make it through this season without too much damage.

The Maine Department of Agriculture, Conservation & Forestry maintains a website where you can book State park campground reservations and NOW is the time to do so.

### MARCH, 2023 UPDATE FROM THE MT VERNON BROADBAND COMMITTEE

The Broadband Committee continues its work on two main two objectives. It is monitoring infrastructure development in Maine and searching for ways to promote local digital inclusion and equity.

### State of Maine Connectivity Authority (MCA) announces grant awards January 2023.

This new State Authority, in its first grant application process, received 29 grant requests and awarded 15 projects, including projects for Fayette, Vienna, and Wilton awards of \$2.6 million, \$2.4 million, and \$3.7 million respectively. The total monies awarded were over \$50 million. All approved projects involved applications that partnered towns with an Internet Service Provider (ISP) such as Consolidated Communications, Matrix, or Axiom. The awards generally covered 50%-80% of the project cost with the towns and ISPs contributing the balance of the . The committee is carefully reviewing MCA's actions to understand the matching contribution and other requirements that will affect prospective town project applications.

Consolidated Communication, Inc. (CCI) agrees to do an internet engineering study for Mt. Vernon. The Broadband Committee and the Selectboard accepted CCI's offer to conduct an engineering study this March to assess the cost of their providing a fiber optic network throughout Mt. Vernon. There would be no cost to the town for this study. Preliminary conversations with CCI are promising. They will need a grant award and a contribution from the town, but because they own or already lease the utility poles, the cost could be lower than previous proposals we have reviewed. Stay tuned for more details.

This chart from Purdue University shows how Mt. Vernon, Kennebec County and Maine lag other states in developing FCC-standard (100/20) broadband. Five years from now we will be looking at charts like this where other states and communities will be experiencing speeds of 5 to 10 gigabytes, more than 100 times faster than those shown below. The committee sees the need to continue to look for a satisfactory broadband solution for our town to consider.

### Promoting Digital Inclusion and Equity

Providing modern broadband infrastructure is necessary, but not sufficient. Our Digital Equity & Digital Inclusion (DEDI) initiative is aimed at assisting our residents in overcoming barriers to acquiring the practical benefits of using broadband. You can see the DEDI plan on the Town's website.

The DEDI working group is developing a strategy to move the digital inclusion agenda forward. This means finding a) volunteers, b) partner groups and c) funding opportunities that support reaching out and learning from Mt. Vernon members about their online interests and goals. Grant opportunities have been identified and so far in 2023, a new proposal has been written.

At the same time, the group is searching for additional grant opportunities earmarked to achieving local DEDI objectives (see the Plan). The Working Group has been studying state and federal sources <u>organizing regional and tribal digital inclusion interest groups</u>. In the meantime, Mount Vernon's DEDI working group has been working with (3) volunteers, the Shaw Memorial Library and <u>the National Digital Equity Center</u> in Wiscasset to design models of individual outreach that are both encouraging and rewarding for individual members of the town.

Universal access to affordable, reliable internet will be a key ingredient for identification of and response to emergencies.





### MINUTES FROM 01/16/2023

Motion by Selectman Grenier to approve the minutes of 01/16/2023.

Second by Selectman Rogers. Motion Passes: 2-0 (Selectman Libby abstains due to not being at the last meeting).

### **KVCOG**

- ♦ LD 2003 which is the Affordable Housing Mandate. This mandate does not come with any funds for the Town.
- ♦ To have KVCOG review the Land Use Ordinance, the Town must become a member of which the unbudgeted cost is \$1635.
- ♦ What is the time frame to have this reviewed and approved to be voted on at Town Meeting?
- Selectman Grenier will look into what the timeline will need to be.

### TRANSFER STATION UPDATE

- ♦ After a safety review from Maine Municipal Association, the transfer station has installed "cattle gates" across the metal pile to help prevent residents from falling into the bin.
- The gates do open for larger, heavier items.

### AUTO GRAVEYARDS

♦ The select board has sent out letters to all automobile graveyards regarding the property line waiver.

### TOWN GENERATORS (TOWN OFFICE AND COMMUNITY CENTER)

- Three (3) bids came back for the backup generators for the town office and the community center.
- ♦ Attendees would like the bid info from all three (3) bidders.
- There would be an extra charge to upgrade the town office electric in the amount \$2800.

Motion by Selectman Grenier to approve the bid from Mid Maine Generator in the amount of \$15,471 for the town office and \$13,015 for the community center.

Second by Selectman Libby. Motion passes: 3-0.

### ANIMAL CONTROL OFFICER

- Selectman Grenier received a phone call from the Town Manager in Readfield regarding the phone that the Animal Control Officer uses for both Readfield and Mount Vernon.
- ♦ The yearly cost to the Town of Mount Vernon would be \$184.91, as the Town of Readfield is currently paying the entire cell phone bill.
- The Animal Control Officer would like to have printed a two-part form in order to give violation tickets to the residents, when necessary. This cost is \$32.

Motion by Selectman Libby to approve the cost of the cell phone in the amount of \$184.91 and for forms in the amount of \$32. Second by Selectman Grenier. Motion passes: 3-0.

### MAINE MUNICIPAL SAFTEY

The town will look into pouring a concrete slab in the basement of the community center, therefore, the select board is waiting for that to toccur before scheduling the safety inspection of the stairs.

### **OTHER BUSINESS**

- ♦ Blake Hill Bridge has been put on the Maine Department of Transportation (MDOT) schedule for the 2024-2025 season.
- ♦ The cost has been estimated to be approximately \$2.5 million dollars to replace the Blake Hill Bridge. The Town does not know what their portion will be at this time.

### **Neighbors Driving Neighbors Expanding to Readfield**

MT. VERNON, ME (January 19, 2023) – Neighbors Driving Neighbors will soon provide free transportation to residents of Readfield who don't drive. In announcing this expansion of NDN's service area, Harald Bredesen, NDN's President, said, "Readfield and we have had each other in our sights for over a year and are thrilled that this collaboration is now being realized." Readfield Town Manager Eric Dyer echoed Bredesen, noting, "We've been admiring the value NDN delivers to its service-area communities and look forward to a successful launch over the next several months. This is an important piece of the puzzle for communities like ours with close proximity to service centers but limited transportation options."

A working group made up of representatives of NDN and Readfield is now recruiting an initial group of drivers and riders with a plan to initiate service provision in the Spring. "We'll be scheduling training sessions for prospective drivers and conducting intake interviews of residents who are looking for rides," said Joe Austin, NDN's Executive Director.

Bredesen added that NDN volunteer drivers have now driven more than 100,000 miles to help over 180 different riders get to where they need to go. "The heart of NDN is the volunteer driver. It is that community spirit that makes NDN possible and that makes Readfield a natural next step. What better way to mark the 100,000<sup>th</sup> mile than to invite the neighbors."

**About Neighbors Driving Neighbors:** NDN is a non-profit organization founded in 2015 to enrich participating communities by matching volunteer drivers with those who do not drive. NDN's current service area comprises Belgrade, Fayette, Mt. Vernon, Readfield, Rome, and Vienna, and 40 volunteer drivers provide rides to 58 registered riders. ### FREE INCOME TAX SERVICES

The AARP Tax-Aide program provides free Federal and State tax return services. Tax-Aide volunteers are trained, tested and certified by the IRS to prepare returns for low- and moderateincome taxpayers, with particular focus on those over 50, but all are welcome!

Low-income taxpayers should note that the only way they can receive the Maine Property Tax Fairness Credit and the Sales Tax Fairness Credit is to file a Maine Income Tax return. Even if you pay no income tax you may be eligible for these credits. These may be worth several hundred dollars, depending on your circumstances.

At this point, Covid-19 masking is optional. Tax counselors will mask, if requested by the tax-payer.

The free tax services are provided <u>by appointment only by calling January 3rd or later</u> and are available at the following sites:

The Town of Mount Vernon Aging in Place Committee, coordinating with Vienna and Fayette, intends to contract with a consultant on a part time basis to act as Outreach/Project coordinator for our Caring Ears and Tri-town Health program.

Besides liaising with our Social Worker, the health officers of the three towns and the Aging in Place Committee the duties will include:

- Help to develop a supportive network with various departments and volunteer organizations in the 3 towns in an effort to support a regional health outreach program focused on the medical, behavioral and social health needs of the older residents in our towns
- Develop partnerships and resources to identify older residents and their care partners in need of assistance and support
- Recruit volunteers who can be trained to assist in meeting the needs of older residents and their care partners
- Establish data collection needs and procedures
- Identify spaces in each community that can be used for telehealth visits and establish protocols for use of those spaces
- Meet with older residents in the 3-town community to determine what types of assistance they need to age in place, be it social opportunities, better access to health care, information/resources to maintain better health etc.
- Provide support to volunteers in meeting those identified needs
- Determine how best these efforts can continue once the grant period is complete
