When applying for the annual tag you must provide a vaccination record for each animal. Animals under seven months will need to be licensed as soon as they reach seven months.

City ordinance allows three dogs & three cats in residential zones. Puppies will be considered dogs at eight weeks and at that time they will fall under the three dogs and three cats limitation.

Pets shall be under the control and restrained by a competent person. Pets must be on a leash at all times when off an owner's premises. Any animal found off the premises of its owner at large may be collected for impoundment.

Impounding fees and boarding costs will be charged for any animal picked up for at-large and released to an owner. Owners have three days in which to recover any at-large animal.

Disturbances caused by a pet such as howling, yelping, and barking, are all prohibited and may bring cause for summons if these types of problems are brought to the attention of officials.

It is unlawful to keep a vicious animal. The Tiffin City Council has approved Ordinance 2008-295 to deal with animals that are deemed vicious.

City Ordinances make it unlawful for the owner of an animal to allow or let such animal to pass onto the premises of another thereby causing damage or interference. This simply means do not allow your animal to excrete on other's property.

The City may feel it necessary to require additional rules and penalties if citizens of the community cannot find ways to consider more kindly the property of adjacent neighbors and the good order of the community.
