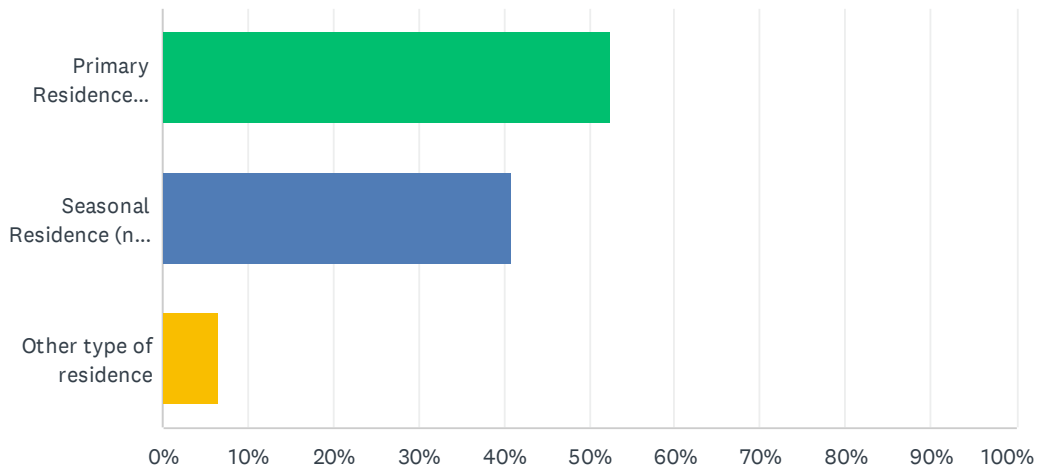

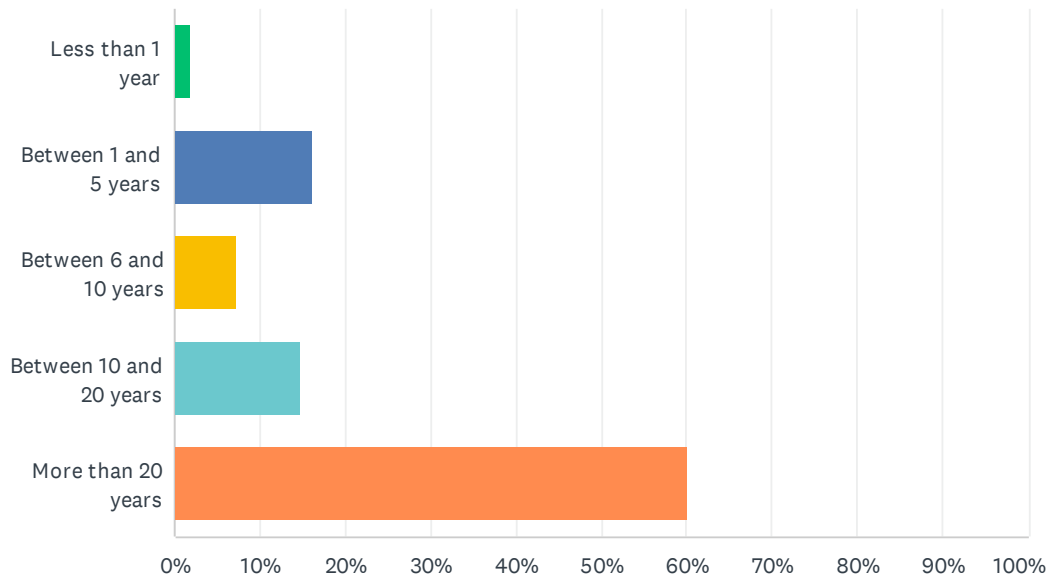

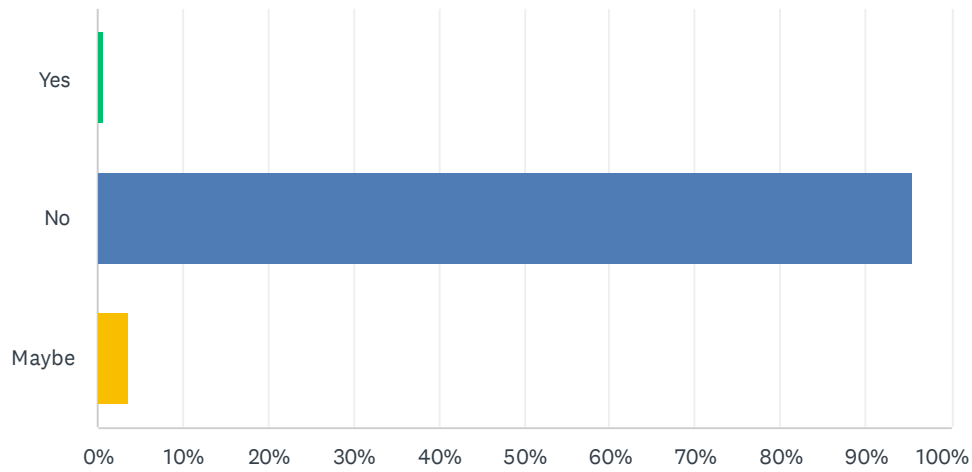

Q3 During the next 5 years do you expect to move away from Brooklin?

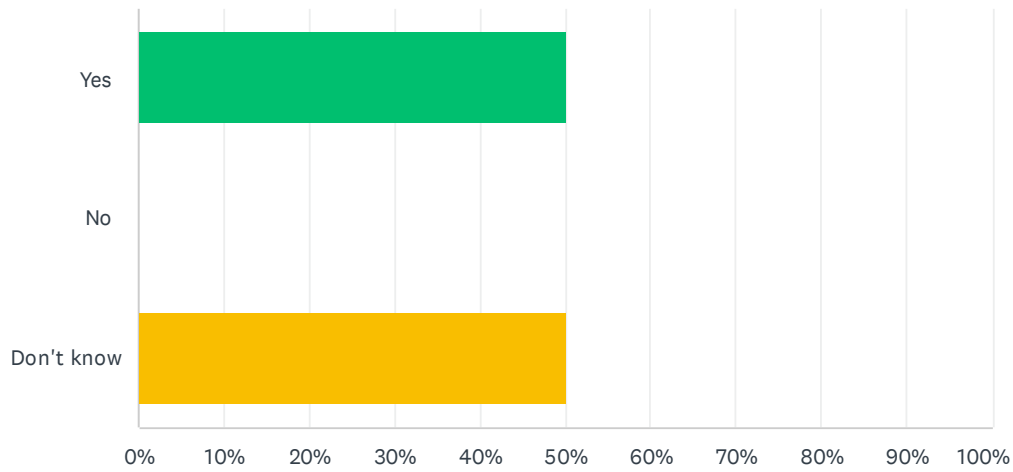

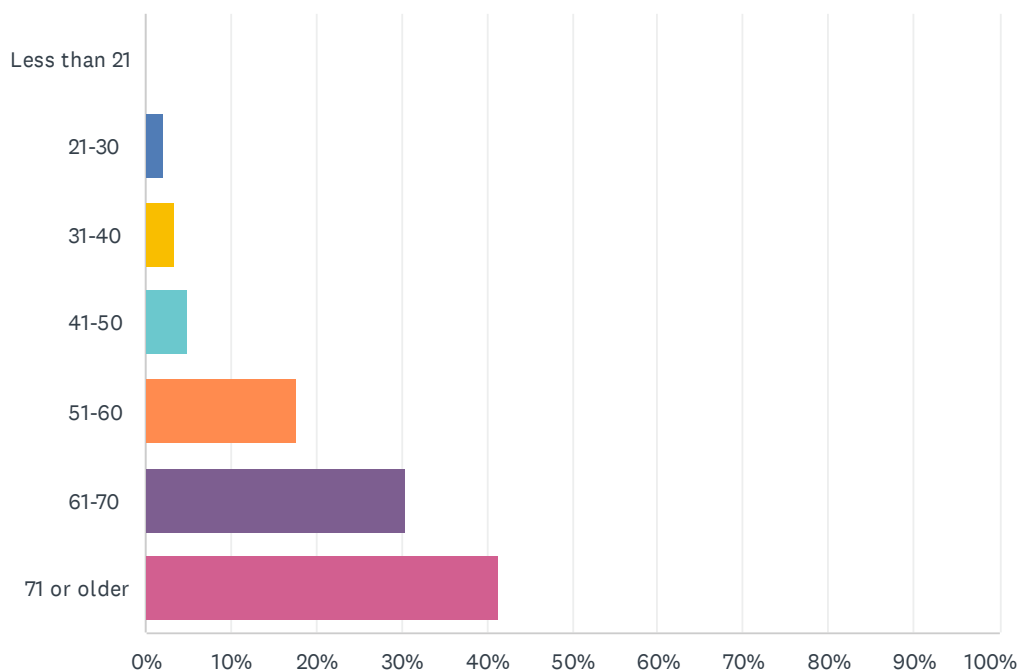

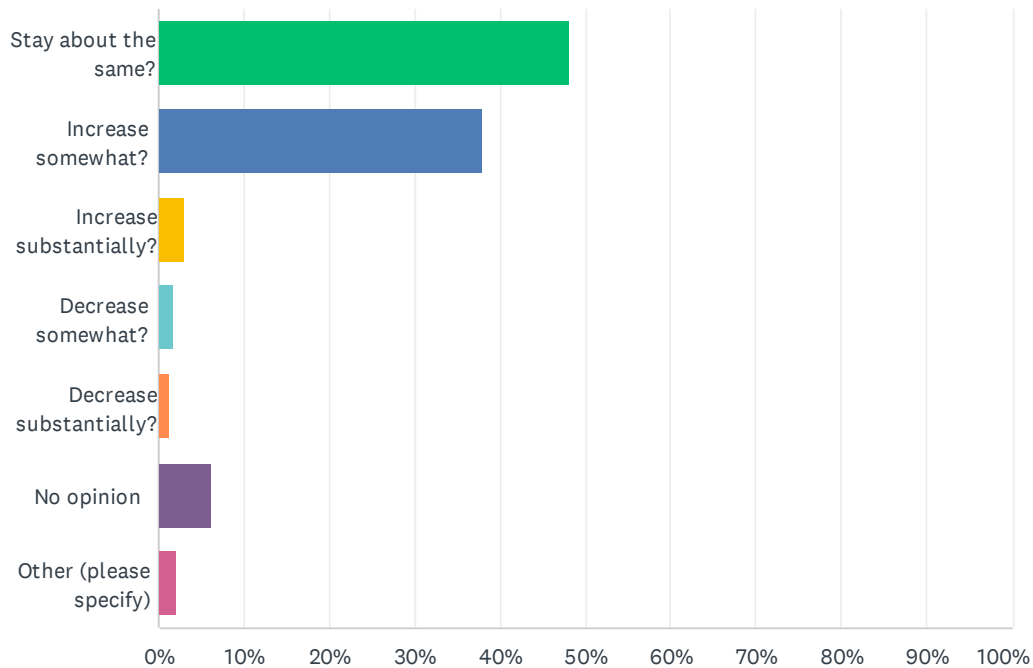

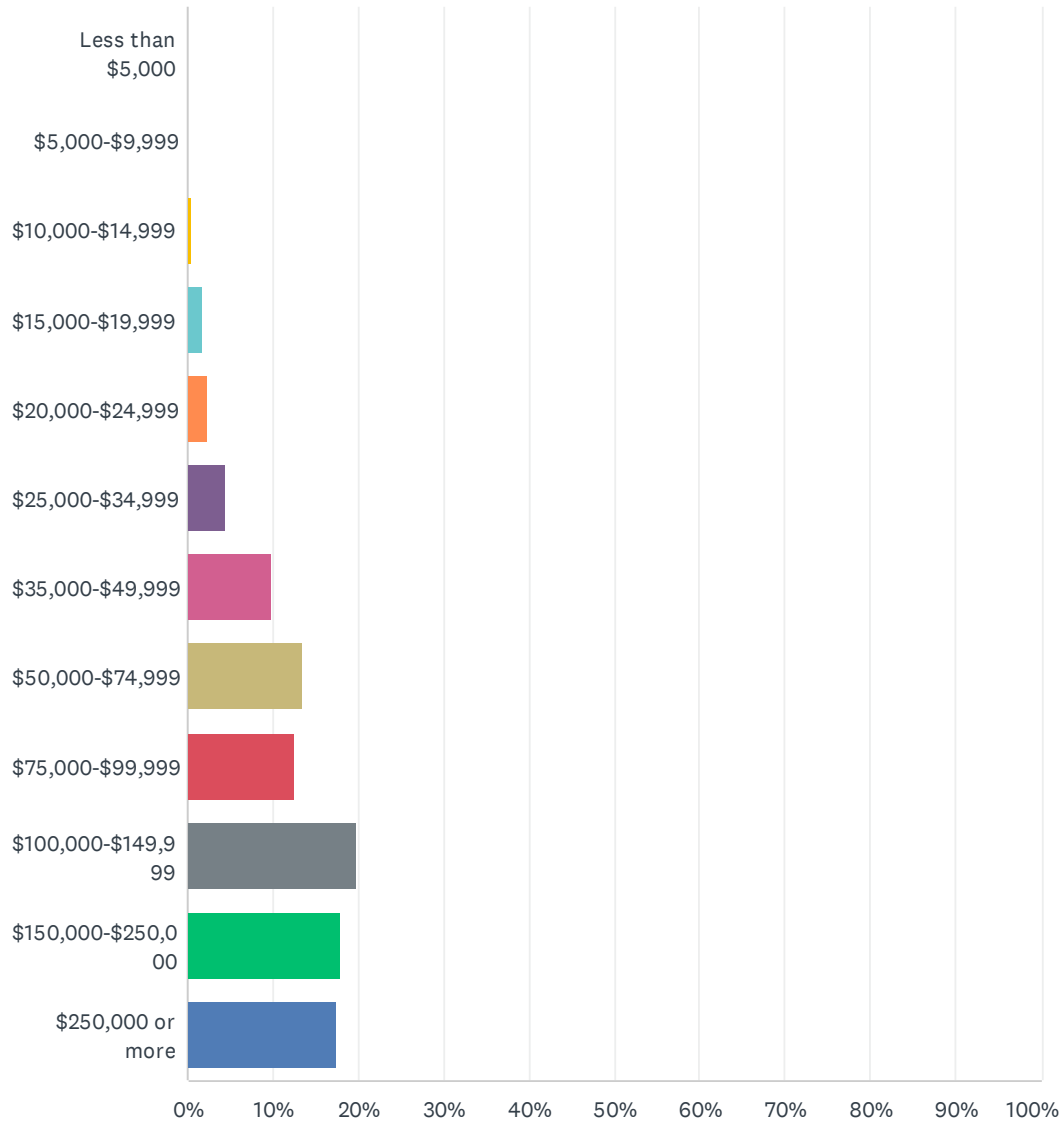

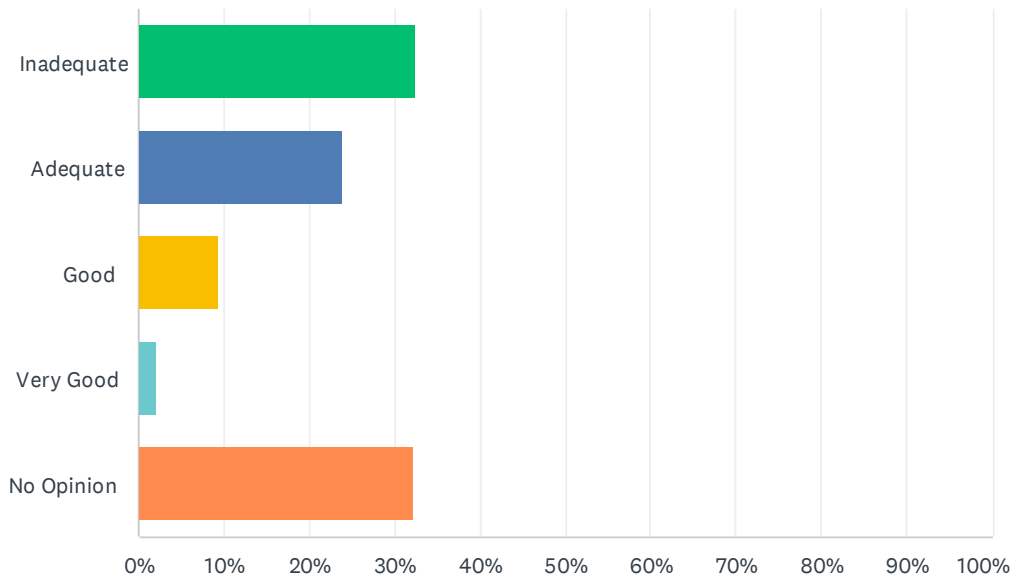

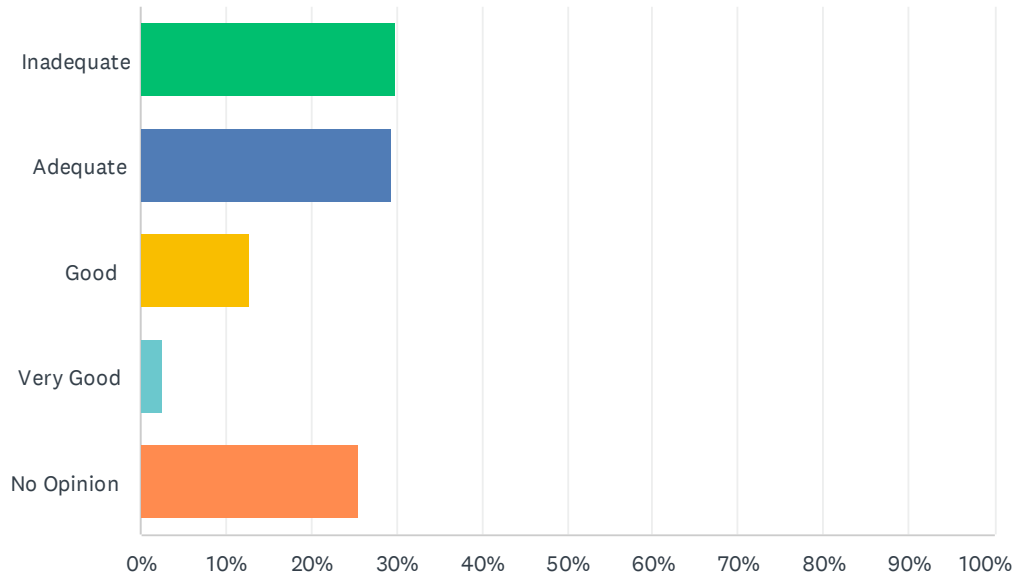

Q10 What, if any, is your opinion on job opportunities conveniently located near Brooklin?

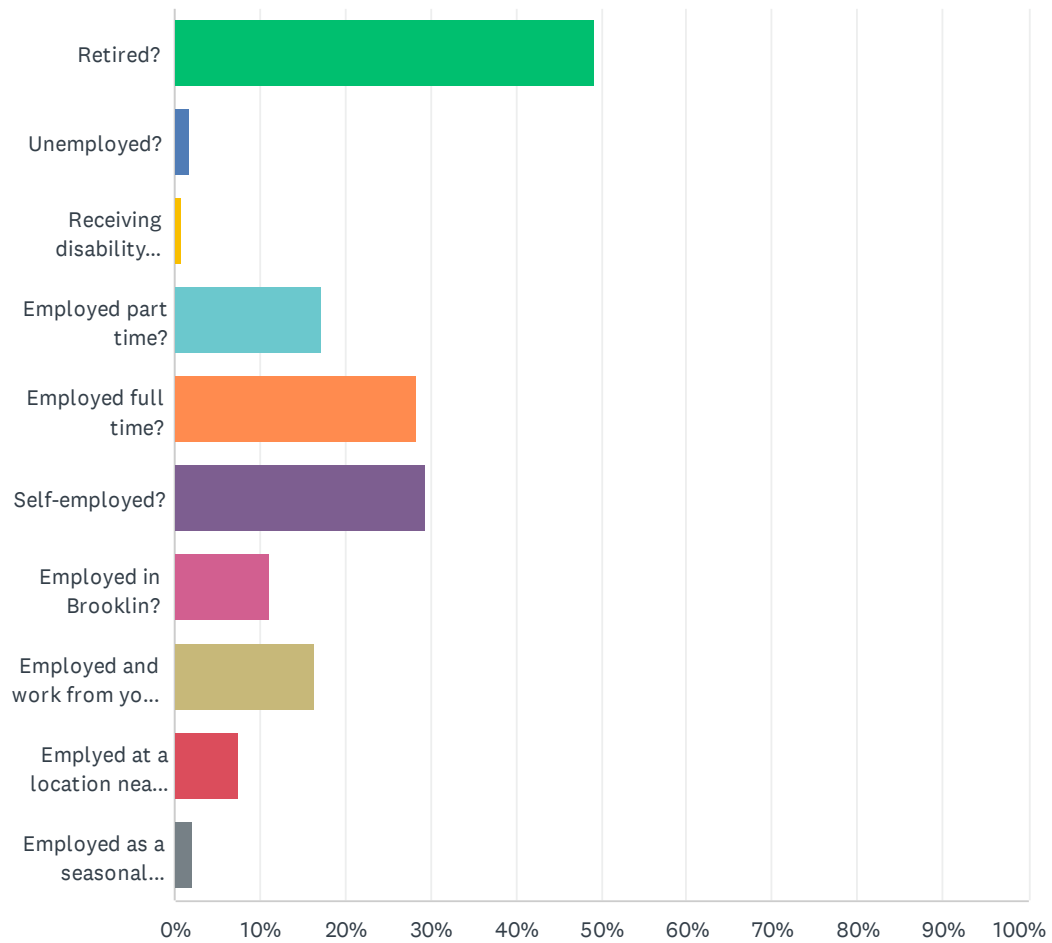

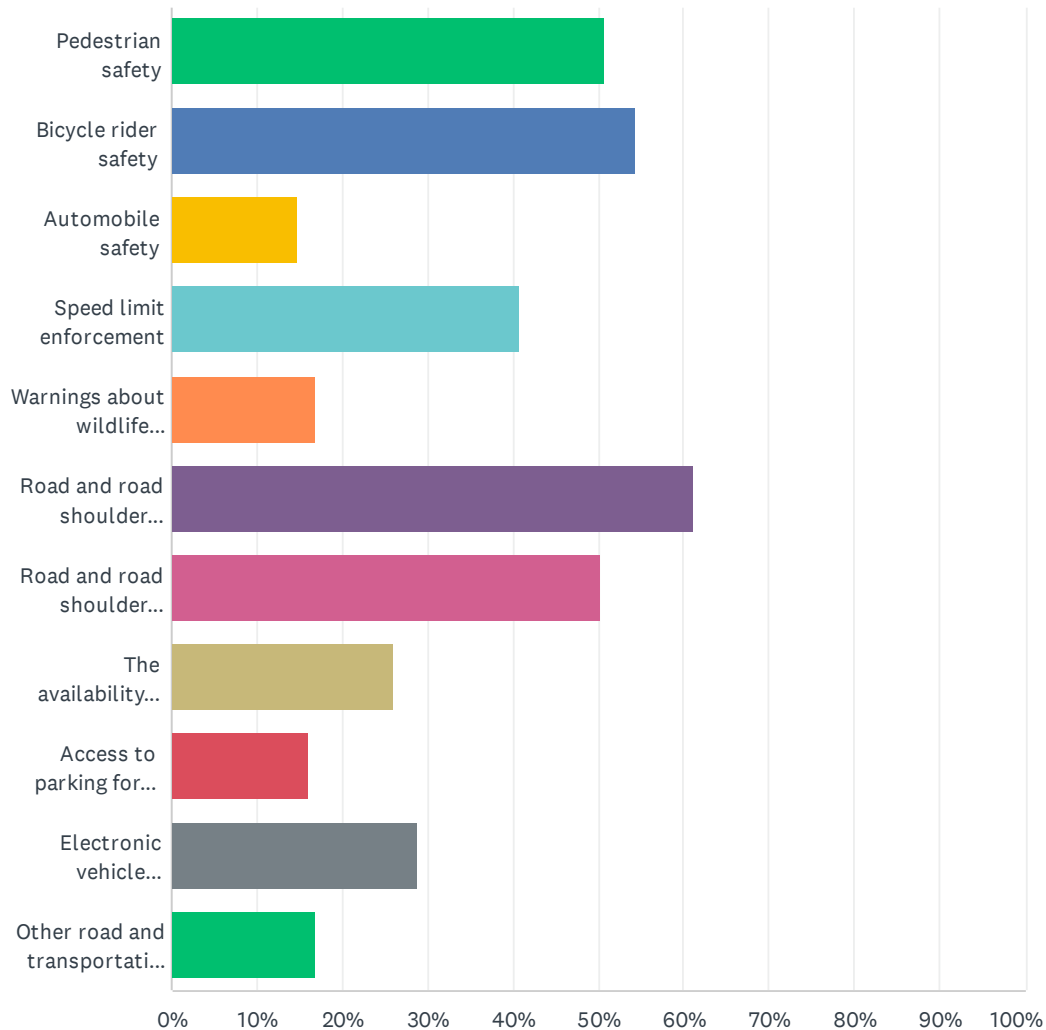

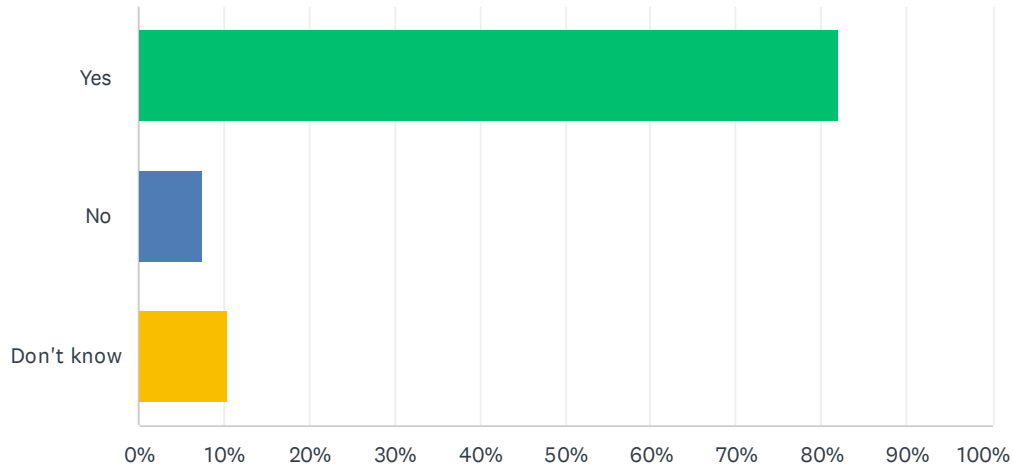

Q45 Should it be the function of the Town to encourage the protecton of archeologically important records, items and sites?

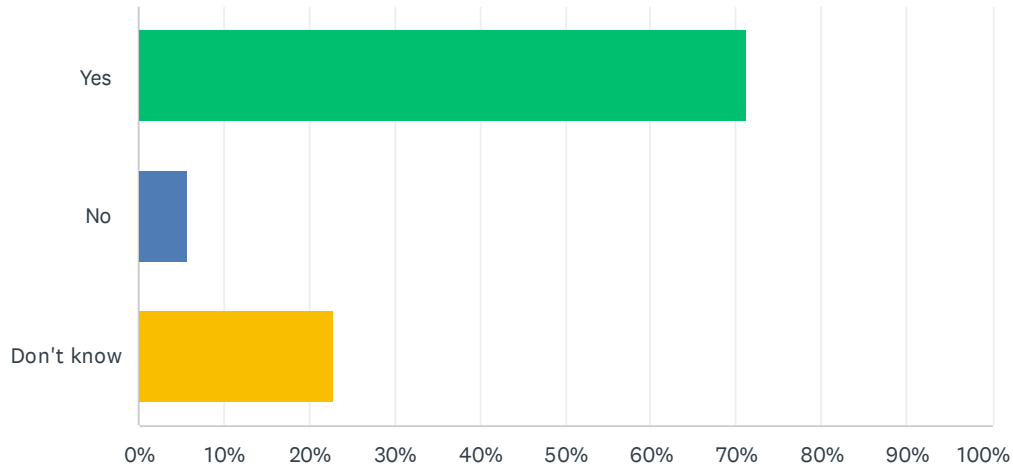

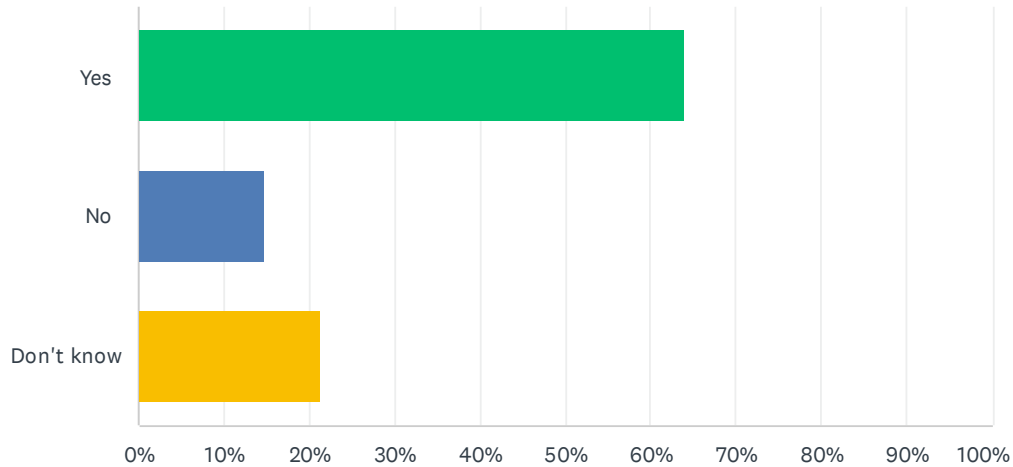

Q47 Should it be a function of the town to encourage agricultural resources and activities?

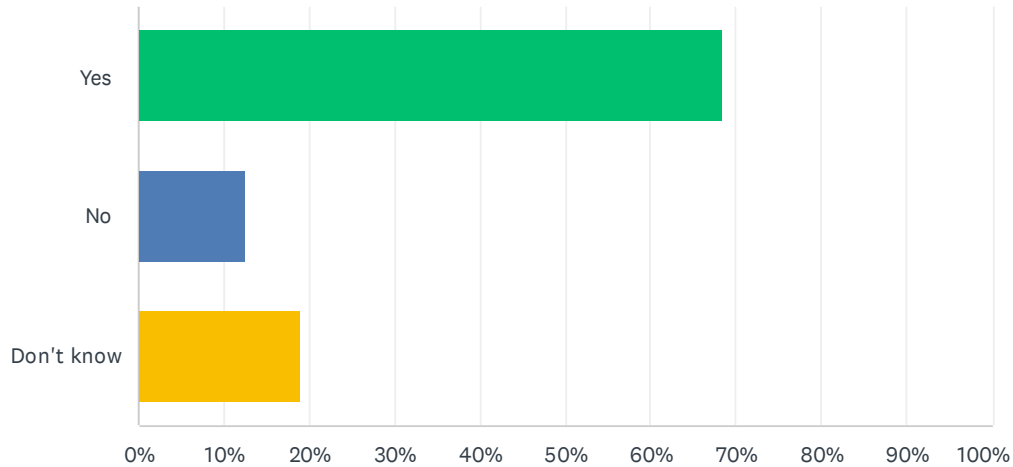

Q48 Should it be a function of the Town to to encourage forest care and managment?

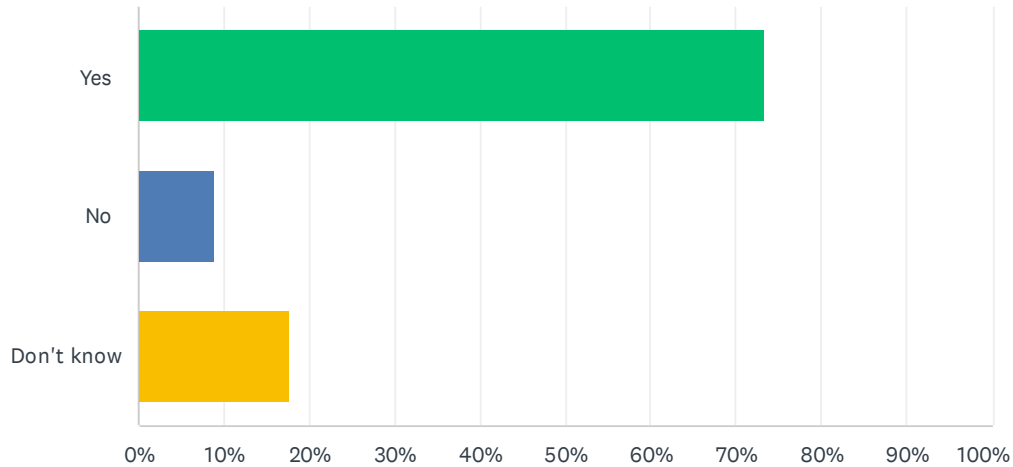

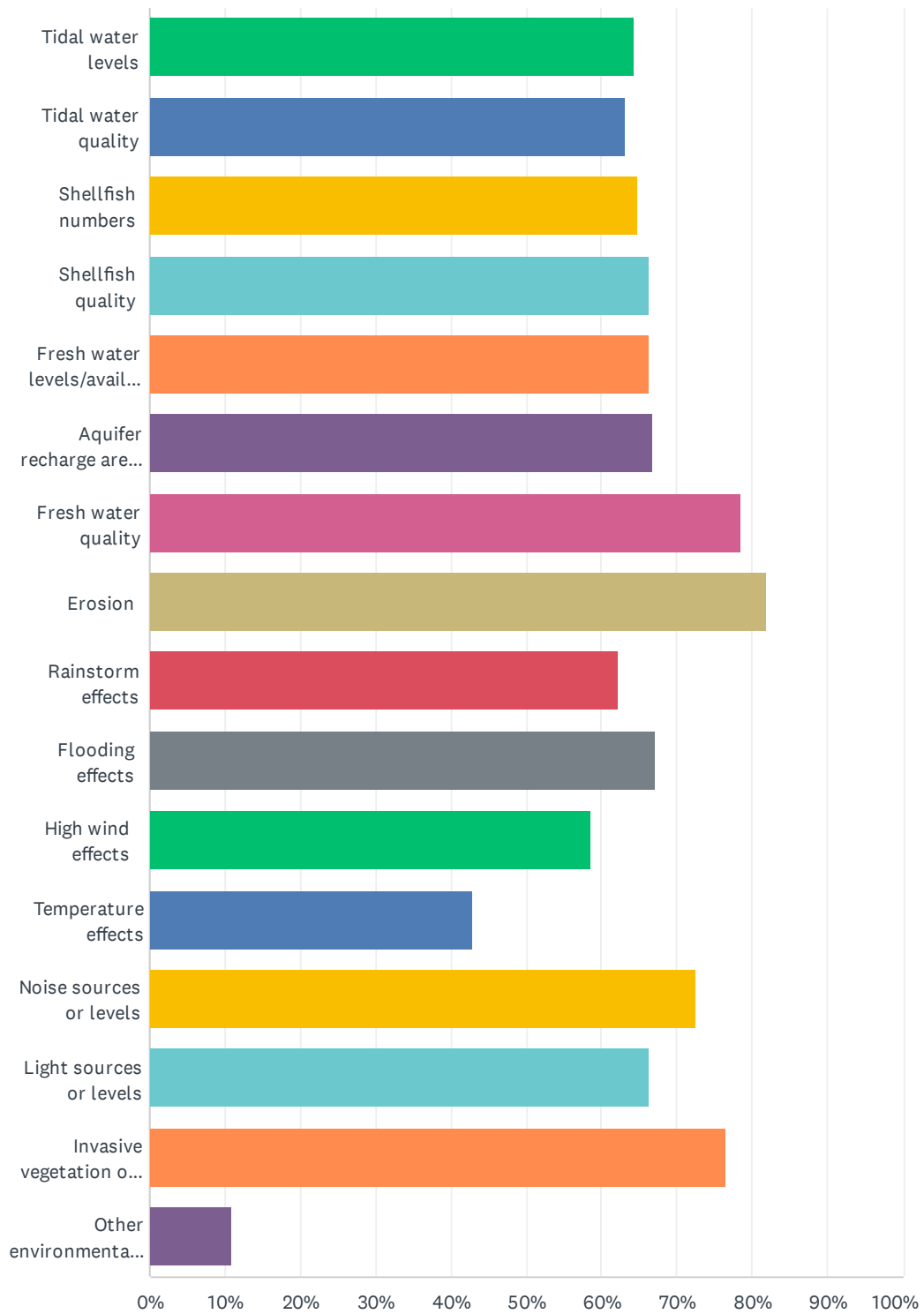
