The remaining 50% shall be retained by the Town as a funds deposit toward Town costs of application review and processing, pursuant to a Cost Agreement executed by the applicant and the Town. At the conclusion of the processing of the application, including review for conformance with any conditions of approval, any and all funds remaining on deposit with the Town shall be refunded to the applicant. No interest shall accrue on the funds deposited with the Town.
