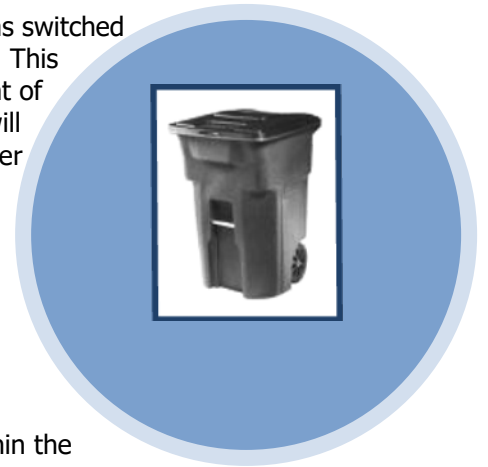

Village of Vernon Starts Automated Trash

Garbage & Recycling collection in the Village of Vernon has switched to fully automated collection for both trash and recycling. This means that a garbage truck will pull up to the curb in front of your residence and by use of a mechanical arm system, will pick up, dump and return your cart(s) to the curb. In order to facilitate this change, a 95-gallon wheeled trash cart, like the one in the photo to the right, was delivered to your residence along with a 95-gallon wheeled cart for collection of all single stream recyclable items.



Remember, single-stream recycling allows you to place all recyclable commodities, such as paper, cardboard, steel, plastic, tin, aluminum and glass, into one collection cart. Single-stream recycled items require loose placement within the

collection cart.

The carts are very easy to maneuver over multiple types of terrain.

In order to assist persons with disabilities who do not have anyone to help them with their chores, the Village of Vernon has contracted with Waste Management to provide Walk Up Service to persons who qualify.

Qualified residents must:

1. Be unable to wheel their cart to the curb for collection.
2. Have no one else who can assist them, such as a spouse or other live-in family member or a personal assistant.
3. Be certified by a physician as needing assistance.
4. Fill out and return the required request for exemption form. (Page 1)
